AN ACT to amend the public health law, in relation to making ephedrine
and ma huang controlled substances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The opening paragraph of subdivision (e) of schedule IV of
2 section 3306 of the public health law, as amended by chapter 589 of the
3 laws of 1996, is amended and two new paragraphs 13 and 14 are added to
4 read as follows:
5 Unless specifically excepted or unless listed in another schedule, any
6 material, compound, mixture, or preparation which contains any quantity
7 of the following substances having a stimulant effect on the central
8 nervous system, including its salts, isomers, (OTHER THAN PSEUDOEPHED-
9 RINE) and salts of such isomers (OTHER THAN PSEUDOEPHEDRINE):
10 (13) EPHEDRINE.
11 (14) BOTANICAL PRODUCTS OF GENUS EPHEDRA WHICH CONTAIN EPHEDRINE.
12 S 2. Section 3307 of the public health law is amended by adding a new
13 subdivision 5 to read as follows:
14 5. DRUG PRODUCTS CONTAINING EPHEDRINE, A SALT OF EPHEDRINE, AN OPTICAL
15 ISOMER OF EPHEDRINE, OR A SALT OF AN OPTICAL ISOMER OF EPHEDRINE ARE
16 EXEMPTED FROM SUBDIVISION (E) OF SCHEDULE IV OF SECTION THIRTY-THREE
17 HUNDRED SIX OF THIS TITLE IF THE DRUG PRODUCT MAY LAWFULLY BE SOLD OVER
18 THE COUNTER WITHOUT A PRESCRIPTION UNDER FEDERAL LAW, IS LABELED AND
19 MARKETING IN A MANNER CONSISTENT WITH THE PERTINENT OVER THE COUNTER
20 (OTC) TENTATIVE FINAL OR FINAL MONOGRAPH, IS MANUFACTURED AND DISTRIB-
21 UTED FOR LEGITIMATE MEDICAL USE IN A MANNER THAT REDUCES OR ELIMINATES
22 THE LIKELIHOOD FOR ABUSE, AND IS NOT MARKETING, ADVERTISED, OR LABELED
23 FOR AN INDICATION OF STIMULATION, MENTAL ALERTNESS, ENERGY, WEIGHT LOSS,
24 APPETITE CONTROL, OR MUSCLE ENHANCEMENT.

1 S 3. Paragraph c of subdivision 1 of section 3383 of the public health
2 law, as added by chapter 494 of the laws of 1982, is amended to read as
3 follows:

4 c. "Imitation controlled substance" means a substance, other than a
5 drug for which a prescription is required pursuant to article one
6 hundred thirty-seven of the education law OR A DRUG WHICH HAS BEEN
7 APPROVED BY THE FOOD AND DRUG ADMINISTRATION FOR TREATMENT OF MEDICALLY
8 RECOGNIZED CONDITIONS, that is not a controlled substance, which by
9 dosage unit appearance, including color, shape, and size [and] OR by a
10 representation is represented to be a controlled substance, as defined
11 in the penal law. Evidence of representations that the substance is a
12 controlled substance may include but is not limited to oral or written
13 representations by the manufacturer or seller, as the case may be, about
14 the substance with regard to:

- 15 (i) its price, nature, use, or effect as a controlled substance; or
- 16 (ii) its packaging in a manner normally used for illicit controlled
17 substances; or
- 18 (iii) markings on the substance.

19 S 4. This act shall take effect on the one hundred eightieth day after
20 it shall have become a law; provided, however, that section two of this
21 act shall take effect immediately and provided further that the commis-
22 sioner of health is authorized to take steps necessary to implement the
23 provisions of section two of this act in a timely manner.
