AN ACT to amend the public health law, in relation to anatomical gifts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 4307 of the public health law, as amended by chap-
2 ter 346 of the laws of 2006, is amended to read as follows:
3 S 4307. Prohibition of sales and purchases of human organs. 1. It
4 shall be unlawful for any person to knowingly acquire, receive, or
5 otherwise transfer for valuable consideration any human organ for use in
6 human transplantation. The term human organ means the human kidney,
7 liver, heart, lung, bone marrow, and any other human organ or tissue as
8 may be designated by the commissioner but shall exclude blood. The term
9 "valuable consideration" does not include the reasonable payments asso-
10 ciated with the removal, transportation, implantation, processing, pres-
11 ervation, quality control, and storage of a human organ or the expenses
12 of travel, housing, and lost wages incurred by the donor of a human
13 organ in connection with the donation of the organ. Any person who
14 violates this section shall be guilty of a class E felony.
15 2. FOR THE PURPOSES OF THIS SECTION, THE DONATION OF A KIDNEY OR OTHER
16 ORGAN FROM A LIVE DONOR FOR TRANSPLANTATION INTO AN INDIVIDUAL CONDI-
17 TIONED UPON THE DONATION AND TRANSPLANTATION OF A SIMILAR ORGAN INTO AN
18 INDIVIDUAL SPECIFIED BY THE DONOR SHALL NOT, IN AND OF ITSELF, BE
19 CONSIDERED TO BE "VALUABLE CONSIDERATION" PROVIDED THAT SUCH DONATION
20 AND TRANSPLANT ARE PERFORMED IN ACCORDANCE WITH OTHER APPLICABLE LAWS,
21 RULES AND REGULATIONS, INCLUDING ANY SPECIFIC RULES AND REGULATIONS THE
22 COMMISSIONER MAY ADOPT, WITH THE ADVICE AND CONSENT OF THE TRANSPLANT
23 COUNCIL, WITH RESPECT TO SUCH CONDITIONAL DONATIONS. NO INDIVIDUAL MAY
24 MAKE A DONATION CONDITIONED UPON THE RACE, COLOR, CREED, NATIONAL ORIGIN
25 OR RELIGIOUS AFFILIATION OF THE RECIPIENT, AND NO HOSPITAL, ORGAN
26 PROCUREMENT ORGANIZATION, TISSUE BANK, PHYSICIAN OR OTHER PROFESSIONAL
