AN ACT to amend the civil rights law, in relation to sealing certain court papers upon applications for a change of name

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 64-a of the civil rights law, as added by chapter
2 447 of the laws of 1994, is amended to read as follows:
3 S 64-a. Exemption from publication requirements. 1. If the court shall
4 find that the publication of an applicant's change of name would jeop-
5 ardize such applicant's personal safety, the provisions of sections
6 sixty-three and sixty-four of this article requiring publication shall
7 be waived and shall be inapplicable. The court shall order the records
8 of such change of name proceeding to be sealed, to be opened only by
9 order of the court for good cause shown or at the request of the appli-
10 cant.
11 2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, PENDING SUCH A FINDING
12 IN SUBDIVISION ONE WHERE AN APPLICANT SEEKS RELIEF UNDER THIS SECTION,
13 THE COURT SHALL IMMEDIATELY ORDER THE APPLICANT'S CURRENT NAME, PROPOSED
14 NEW NAME, RESIDENTIAL AND BUSINESS ADDRESSES, TELEPHONE NUMBERS, AND ANY
15 OTHER INFORMATION CONTAINED IN ANY PLEADINGS OR PAPERS SUBMITTED TO THE
16 COURT TO BE SAFEGUARDED AND SEALED IN ORDER TO PREVENT THEIR INADVERTENT
17 OR UNAUTHORIZED USE OR DISCLOSURE WHILE THE MATTER IS PENDING.
18 S 2. This act shall take effect immediately.
