- AN ACT to amend the vehicle and traffic law, in relation to enacting the "Ambrose-Searles move over act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 the "Ambrose-Searles move over act".

3 S 2. Subdivision 3 of section 502 of the vehicle and traffic law, as 4 amended by chapter 692 of the laws of 1985, is amended to read as 5 follows:

3. Application for learner's permit. An application for a learner's 6 7 permit shall be included in the application for a license. A learner's 8 permit shall be issued in such form as the commissioner shall determine 9 but shall not be issued unless the applicant has successfully passed the vision test required by this section and the test set forth in paragraph 10 (a) of subdivision four of this section with respect to laws relating to 11 12 traffic and ability to read and comprehend traffic signs and symbols and has satisfactorily completed any course required pursuant to paragraph 13 (a) of subdivision four of this section. Upon acceptance of an applica-14 15 tion for a learner's permit the commissioner shall provide the applicant with a driver's manual which includes but is not limited to the 16 laws relating to traffic, the laws relating to and physiological effects of 17 18 driving while ability impaired and driving while intoxicated, THELAW 19 FOR EXERCISING DUE CARE TO AVOID COLLIDING WITH A PARKED, STOPPED OR 20 STANDING AUTHORIZED EMERGENCY VEHICLE PURSUANT TO SECTION ELEVEN HUNDRED

3 S 3. Subparagraph (i) of paragraph (a) of subdivision 4 of section 502 4 of the vehicle and traffic law, as amended by chapter 585 of the laws of 5 2002, is amended to read as follows:

6 an application for a driver's license, the (i) Upon submission of 7 applicant shall be required to take and pass a test, or submit evidence 8 of passage of a test, with respect to the laws relating to traffic, the laws relating to driving while ability is impaired and while intoxicat-9 10 ed, under the overpowering influence of "Road Rage", or "Work Zone Safe-11 awareness as defined by the commissioner, THE LAW RELATING TO EXERty" CISING DUE CARE TO AVOID COLLIDING WITH A PARKED, STOPPED OR 12 STANDING 13 VEHICLE PURSUANT TO SECTION ELEVEN HUNDRED AUTHORIZED EMERGENCY 14 FORTY-FOUR-A OF THIS CHAPTER, the ability to read and comprehend traffic 15 signs and symbols and such other matters as the commissioner may prescribe, and to satisfactorily complete a course prescribed by the 16 17 commissioner of not less than four hours and not more than five hours, 18 consisting of classroom driver training and highway safety instruction 19 or the equivalent thereof. Such test shall include at least seven written questions concerning the effects of consumption of alcohol or drugs 20 21 on the ability of a person to operate a motor vehicle and the legal and 22 financial consequences resulting from violations of section eleven hundred ninety-two of this chapter, prohibiting the operation of a motor 23 24 vehicle while under the influence of alcohol or drugs. Such test shall 25 include one or more written questions concerning the devastating effects 26 of "Road Rage" on the ability of a person to operate a motor vehicle and legal and financial consequences resulting from assaulting, threat-27 the ening or interfering with the lawful conduct of another person legally 28 29 using the roadway. 39 S 4. The vehicle and traffic law is amended by adding a new section 40 1144-a to read as follows:

1144-A. OPERATION OF VEHICLES WHEN APPROACHING A PARKED, STOPPED OR 41 S STANDING AUTHORIZED EMERGENCY VEHICLE. EVERY OPERATOR OF A MOTOR VEHICLE 42 43 SHALL EXERCISE DUE CARE TO AVOID COLLIDING WITH AN AUTHORIZED EMERGENCY 44 VEHICLE WHICH IS PARKED, STOPPED OR STANDING ON THE SHOULDER OR ANY 45 SUCH HIGHWAY AND SUCH AUTHORIZED EMERGENCY VEHICLE PORTION OF IS 46 DISPLAYING ONE OR MORE RED OR COMBINATION RED AND WHITE LIGHTS PURSUANT 47 TO THE PROVISIONS OF PARAGRAPH TWO OF SUBDIVISION FORTY-ONE SECTION OF FOR OPERATORS OF MOTOR 48 THREE HUNDRED SEVENTY-FIVE OF THIS CHAPTER. VEHICLES ON PARKWAYS OR CONTROLLED ACCESS HIGHWAYS, SUCH DUE CARE 49 SHALL 50 BUT NOT BE LIMITED TO, MOVING FROM A LANE WHICH CONTAINS OR IS INCLUDE, 51 IMMEDIATELY ADJACENT TO THE SHOULDER WHERE SUCH AUTHORIZED EMERGENCY 52 VEHICLE DISPLAYING ONE OR MORE RED OR COMBINATION RED AND WHITE LIGHTS 53 PURSUANT TO THE PROVISIONS OF PARAGRAPH TWO OF SUBDIVISION FORTY-ONE OF 54 SECTION THREE HUNDRED SEVENTY-FIVE OF THIS CHAPTER IS PARKED, STOPPED OR 55 STANDING TO ANOTHER LANE, PROVIDED THAT SUCH MOVEMENT OTHERWISE COMPLIES WITH THE REQUIREMENTS OF THIS CHAPTER INCLUDING, BUT NOT LIMITED TO, THE 56

3 S 5. This act shall take effect immediately, provided that:

4 (a) sections two and three of this act shall take effect September 1, 5 2010, except that the promulgation of any rules and regulations, and the 6 taking of any other actions necessary to implement the provisions of 7 such sections of this act are authorized and directed to be made on or 8 before the effective date of such sections of this act; and

9 (b) section four of this act shall take effect January 1, 2011.
