AN ACT to amend the general municipal law, in relation to land use compliance for public construction projects

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. The general municipal law is amended by adding a new  
2     section 99-v to read as follows:  
3     S 99-V. LAND USE PLANNING; COMPLIANCE. 1. NOTWITHSTANDING ANY OTHER  
4     PROVISION OF LAW, ANY UNIT OF GOVERNMENT, AS DEFINED IN SUBDIVISION TWO  
5     OF THIS SECTION, OR SUBSIDIARY THEREOF, SHALL, WITH RESPECT TO THE  
6     CONSTRUCTION, DEVELOPMENT, PLANNING, SITING, LEASING, OPERATING OR  
7     OWNERSHIP OF ANY FACILITY, BUILDING OR ANY OTHER CONSTRUCTION WHICH IS  
8     LOCATED OR PROPOSED TO BE LOCATED WITHIN THE STATE, COMPLY WITH ALL  
9     LOCAL, STATE AND FEDERAL LAWS, RULES, REGULATIONS AND ORDINANCES WITH  
10    RESPECT TO LAND USE PLANNING AND REVIEW OR ZONING APPLICABLE TO SUCH  
11    LOCATION OR PROPOSED LOCATION.  
12    2. FOR PURPOSES OF THIS SECTION, THE TERM "UNIT OF GOVERNMENT" SHALL  
13    MEAN THE STATE OF NEW YORK, A COUNTY, CITY, TOWN, VILLAGE OR ANY OTHER  
14    POLITICAL SUBDIVISION OR CIVIL DIVISION OF THE STATE, A SCHOOL DISTRICT  
15    OR ANY GOVERNMENTAL ENTITY OPERATING A PUBLIC SCHOOL, COLLEGE OR UNIVER-  
16    SITY, A PUBLIC IMPROVEMENT OR SPECIAL DISTRICT, A PUBLIC AUTHORITY,  
17    COMMISSION, COMMITTEE OR PUBLIC BENEFIT CORPORATION, OR ANY OTHER PUBLIC  
18    CORPORATION, AGENCY OR INSTRUMENTALITY OR UNIT OF GOVERNMENT WHICH EXER-  
19    CISES GOVERNMENTAL POWERS UNDER THE LAWS OF THE STATE.  
20    S 2. This act shall take effect immediately.
