AN ACT to amend the general municipal law, in relation to the use of zoning overlay districts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The general municipal law is amended by adding a new arti-
2 cle 5-L to read as follows:

3 ARTICLE 5-L

4 USE OF ZONING OVERLAY DISTRICTS

5 SECTION 119-EE. USE OF ZONING OVERLAY DISTRICTS.

6 S 119-EE. USE OF ZONING OVERLAY DISTRICTS. 1. ZONING OVERLAY DISTRICTS
7 MAY ONLY BE UTILIZED WHEN

8 A. PRIOR TO THE CREATION OF THE OVERLAY DISTRICT, THERE EXISTS A WRIT-
9 TEN, LEGALLY ADOPTED, INTERMUNICIPAL AGREEMENT BETWEEN OR AMONG ALL
10 MUNICIPALITIES THAT WILL BE COVERED BY THE OVERLAY DISTRICT; OR

11 B. AFTER A MUNICIPALITY HAS EXHAUSTED ALL OTHER METHODS.

12 2. A MUNICIPALITY MAY NOT CREATE A ZONING OVERLAY DISTRICT OR ENTER
13 INTO AN INTERMUNICIPAL AGREEMENT FOR THE CREATION OF A ZONING OVERLAY
14 DISTRICT UNLESS THE MUNICIPALITY HAS FIRST COMPLETED AND ADOPTED A
15 COMPREHENSIVE PLAN.

16 3. WHEN CREATING A ZONING OVERLAY DISTRICT, THE MUNICIPALITIES
17 INVOLVED MUST CLEARLY DEFINE WHAT COMMUNITY RESOURCE IS TO BE PROTECTED,
18 ENHANCED, OR DEVELOPED. THE MUNICIPALITIES MUST ALSO SHOW THAT THEY HAVE
19 A COMPELLING GOAL IN THE PUBLIC INTEREST THAT CANNOT BE ACHIEVED USING
20 METHODS OTHER THAN AN OVERLAY DISTRICT.

21 4. IF A ZONING OVERLAY DISTRICT IS USED, THE OVERLAY DISTRICT MUST
22 PRESERVE THE INTEGRITY OF THE UNDERLYING OR PRIMARY ZONING, IT MUST BE
23 CONSISTENT WITH THE UNDERLYING OR PRIMARY ZONING, AND MAY NOT, IN ANY
24 WAY, INCREASE THE PERMITTED USES OF THE UNDERLYING OR PRIMARY ZONING
25 (ALSO KNOWN AS UP-ZONE).

26 5. THE PROVISIONS OF THIS SECTION SHALL APPLY TO ALL MUNICIPALITIES.

27 S 2. This act shall take effect immediately.
