AN ACT to amend the highway law, in relation to the Shawangunk mountains scenic byway

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (j-9) of subdivision 1 of section 349-dd of the 2 highway law, as added by chapter 666 of the laws of 2006, is amended to 3 read as follows:

Shawangunk mountains scenic byway which shall consist of all 4 (i-9) 5 that portion of the highway system beginning at the intersection of б state route two hundred ninety-nine and exit eighteen of the New York state thruway in the town of New Paltz, Ulster county, continuing 7 8 westerly along state route two hundred ninety-nine to its junction with 9 the overlap of United States route forty-four and state route fiftyfive, in the town of Gardiner, Ulster county, continuing westerly along 10 the United States route forty-four and state route fifty-five overlap to 11 12 the intersection of United States route two hundred nine and then south-13 erly along the overlap United States route two hundred nine and state 14 route fifty-five to the intersection with state route fifty-two in the 15 village of Ellenville, Ulster county, and then generally southeasterly along state route fifty-two to the intersection with state route three 16 17 hundred two in Pine Bush and continuing southerly along state route 18 three hundred two to the junction of state route seventeen-K, and 19 continuing easterly along state route fifty-two from the intersection of 20 state route three hundred two and route fifty-two in Pine Bush to the intersection of the overlap Orange county route fourteen and Ulster county route nine, then northerly along Orange county route fourteen and 21 22 23 Ulster county route nine to the intersection with Ulster county route 24 eighteen, then generally easterly on county route eighteen into the 25 hamlet of Wallkill, where it meets with state route two hundred eight

and continuing in a generally northerly direction along state route two 1 2 hundred eight to the intersection of state route two hundred eight and 3 state route two hundred ninety-nine in the village of New Paltz, and 4 continuing from the junction of state route two hundred ninety-nine and 5 Ulster county route seven continuing northerly along Ulster county route 6 seven to its junction with state route two hundred thirteen then gener-7 ally westerly along state route two hundred thirteen to the intersection 8 of Ulster county route one then generally southwesterly along Ulster 9 county route one to the junction with United States route two hundred 10 nine and along United States route two hundred nine to the intersection of two hundred nine and United States route forty-four and 11 state route 12 fifty-five in Kerhonkson. THE ALTERNATE ROUTE OF THE SHAWANGUNK MOUN-13 TAINS SCENIC BYWAY SHALL CONSIST OF ALL THAT PORTION OF THE HIGHWAY 14 SYSTEM BEGINNING AT THE INTERSECTION OF STATE ROUTE TWO HUNDRED NINETY-15 NINE AND OVERLAPPING UNITED STATES ROUTE FORTY-FOUR AND STATE ROUTE FIFTY-FIVE, CONTINUING SOUTH AND EAST ALONG OVERLAPPING UNITED STATES 16 17 ROUTE FORTY-FOUR AND STATE ROUTE FIFTY-FIVE TO THE INTERSECTION WITH ROUTE TWO HUNDRED EIGHT IN IRELAND CORNERS, ALL IN THE TOWN OF 18 STATE 19 GARDINER, ULSTER COUNTY.

20 S 2. This act shall take effect immediately.
