AN ACT to repeal part GG of chapter 59 of the laws of 2009 relating to transferring the functions, powers, duties, obligations and assets of the State Northeastern Queens Nature and Historical Preserve Commission to the office of parks, recreation and historic preservation; and in relation to making an appropriation to the State Northeastern Queens Nature and Historical Preserve Commission

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Part GG of chapter 59 of the laws of 2009 relating to
2 transferring the functions, powers, duties, obligations and assets of
3 the State Northeastern Queens Nature and Historical Preserve Commission
4 to the office of parks, recreation and historic preservation is
5 REPEALED.
6 S 2. The sum of one hundred twenty thousand dollars (\$120,000), or so
7 much thereof as may be necessary, is hereby appropriated to the State
8 Northeastern Queens Nature and Historical Preserve Commission, out of
9 any moneys in the state treasury in the general fund to the credit of
10 the state purposes account, not otherwise appropriated, and made imme-
11 diately available, for the services, expenses and administration of the
12 State Northeastern Queens Nature and Historical Preserve Commission. Of
13 such sum: (a) up to seventy-eight thousand dollars (\$78,000) shall be
14 made available for personal service; and (b) up to forty-two thousand
15 dollars (\$42,000) shall be made available for nonpersonal service. Of
16 such sum made available for nonpersonal service: (i) up to thirty-two
17 thousand dollars (\$32,000) shall be made available for supplies and
18 materials; (ii) up to four hundred dollars (\$400) shall be made avail-
19 able for travel; and (iii) up to nine thousand six hundred dollars
20 (\$9,600) shall be made available for equipment. Such moneys shall be
21 payable on the audit and warrant of the comptroller on vouchers certi-

1 fied or approved by the State Northeastern Queens Nature and Historical
2 Preserve Commission in the manner prescribed by law.

3 S 3. Notwithstanding the provisions of article 5 of the general
4 construction law, the provisions of chapter 919 of the laws of 1973,
5 relating to establishing the State Northeastern Queens Nature and
6 Historical Preserve are hereby revived and shall continue in full force
7 and effect as they existed on March 31, 2009.

8 S 4. This act shall take effect immediately.
