AN ACT to amend the labor law and the state finance law, in relation to the New York state worker protection board

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph b of subdivision 4 of section 27-a of the labor
2 law, as amended by chapter 433 of the laws of 2007, is amended to read
3 as follows:
4 b. Notwithstanding the provisions of paragraph a of this subdivision,
5 the commissioner, in consultation with the state [occupational safety
6 and health hazard abatement] WORKER PROTECTION board, shall promulgate
7 rules and regulations recommended to him OR HER by such board which
8 establish standards whenever such board finds (i) that no federal stand-
9 ard exists for the particular condition being addressed and that such a
10 standard is necessary for the protection of the public employees at
11 risk, or (ii) a federal standard exists, but conditions in public work-
12 places in this state require a different standard, and such state stand-
13 ard will be at least as effective in providing safe and healthful places
14 of employment as the federal standard.
15 S 2. The subdivision heading and paragraphs a, b and e of subdivision
16 15 of section 27-a of the labor law, the subdivision heading and para-
17 graphs a and e as added by chapter 729 of the laws of 1980, paragraph b
18 as amended by chapter 55 of the laws of 1992 and such subdivision as
19 renumbered by chapter 706 of the laws of 1990, are amended to read as
20 follows:
21 New York state [occupational safety and health hazard abatement] WORK-
22 ER PROTECTION board; creation and procedure. a. The New York state
23 [occupational safety and health hazard abatement] WORKER PROTECTION
24 board is hereby created to have and exercise the powers, duties and
25 prerogatives provided by the provisions of this subdivision.

1 b. The membership of the board shall consist of [five] NINE persons.
2 THREE MEMBERS SHALL BE appointed by the governor of whom one shall be
3 upon the recommendation of THE NEW YORK STATE FEDERATION OF LABOR-CON-
4 GRESS OF INDUSTRIAL ORGANIZATIONS, TWO MEMBERS SHALL BE APPOINTED BY the
5 temporary president of the senate, one upon the recommendation of THE
6 NEW YORK STATE FEDERATION OF LABOR-CONGRESS OF INDUSTRIAL ORGANIZATIONS,
7 TWO MEMBERS SHALL BE APPOINTED BY the speaker of the assembly, [and] one
8 upon the recommendation of THE NEW YORK STATE FEDERATION OF LABOR-CON-
9 GRESS OF INDUSTRIAL ORGANIZATIONS, ONE MEMBER SHALL BE APPOINTED BY the
10 state comptroller AND ONE MEMBER SHALL BE THE COMMISSIONER. Members
11 shall serve at the pleasure of the governor, and the governor may
12 replace any member in accordance with the provisions contained herein
13 for the appointment of members.

14 The governor shall designate one of the members to serve as [chairman]
15 CHAIRPERSON. The board shall act by a majority vote of its members, and
16 a quorum to conduct business shall consist of [three] FIVE members. Any
17 determination of the board shall be evidenced by a certification thereof
18 executed by all the members present and voting. Each member of the board
19 shall be entitled to designate a representative to attend meetings of
20 the board in his OR HER place, and to vote or otherwise act on his OR
21 HER behalf in his OR HER absence. Such representative shall not be
22 authorized to delegate any of his OR HER duties or functions to any
23 other person. Notice of such designation shall be furnished in writing
24 to the board by the designating member. A representative shall serve at
25 the pleasure of the designating member during the member's term of
26 office.

27 e. The board shall meet at least four times a year with at least one
28 meeting in each calendar quarter. The [chairman] CHAIRPERSON shall
29 designate the days of meeting, and shall provide each member with at
30 least three weeks written notice of the date of such meeting.

31 S 3. The subdivision heading of subdivision 16 of section 27-a of the
32 labor law, as amended by chapter 886 of the laws of 1985 and such subdi-
33 vision as renumbered by chapter 706 of the laws of 1990, is amended to
34 read as follows:

35 New York state [occupational safety and health hazard abatement] WORK-
36 ER PROTECTION board; powers and duties.

37 S 4. Subdivision 1 of section 885 of the labor law, as added by chap-
38 ter 886 of the laws of 1985, is amended to read as follows:

39 1. "Board" shall mean the New York state [occupational safety and
40 health hazard abatement] WORKER PROTECTION board created pursuant to the
41 provisions of section twenty-seven-a of this chapter.

42 S 5. Subdivision 3 of section 97-c of the state finance law, as
43 amended by chapter 309 of the laws of 1996, is amended to read as
44 follows:

45 3. Moneys of the fund shall be available to the New York state [occu-
46 pational safety and health hazard abatement] WORKER PROTECTION board for
47 purposes of carrying out the provisions of article twenty-nine of the
48 labor law and to the department of labor for worker protection activ-
49 ities under its jurisdiction.

50 S 6. This act shall take effect on the ninetieth day after it shall
51 have become a law; provided, however, that effective immediately, the
52 addition, amendment and/or repeal of any rule or regulation necessary
53 for the implementation of this act on its effective date are authorized
54 and directed to be made and completed on or before such effective date.
