AN ACT to amend the education law, in relation to recovery of excess payments to county vocational education and extension boards

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 1104 of the education law, as
2 added by chapter 53 of the laws of 1990, is amended to read as follows:
3 2. [Notwithstanding the provisions of subdivision one of this section
4 or chapters fifty-three and three hundred ninety-one of the laws of
5 nineteen hundred eighty-nine or any other provision of law to the
6 contrary, aid payable to county vocational education and extension
7 boards in the spring of nineteen hundred ninety shall be reduced by an
8 amount equal to the amount that would have been paid pursuant to section
9 five hundred twenty-one of this chapter to the New York state teachers'
10 retirement system on behalf of such board] UPON NOTIFICATION OF EXCESS
11 PAYMENTS OF AID FOR WHICH A RECOVERY MUST BE MADE BY THE STATE THROUGH
12 DEDUCTION OF FUTURE AID PAYMENTS, A COUNTY VOCATIONAL EDUCATION AND
13 EXTENSION BOARD MAY REQUEST THAT SUCH EXCESS PAYMENTS BE RECOVERED BY
14 DEDUCTING SUCH EXCESS PAYMENTS FROM THE PAYMENTS DUE TO SUCH COUNTY
15 VOCATIONAL EDUCATION AND EXTENSION BOARD IN (I) THE SCHOOL YEAR IN WHICH
16 SUCH NOTIFICATION WAS RECEIVED AND (II) THE TWO SUCCEEDING SCHOOL YEARS,
17 PROVIDED FURTHER THAT THERE SHALL BE NO INTEREST PENALTY ASSESSED
18 AGAINST SUCH COUNTY VOCATIONAL EDUCATION AND EXTENSION BOARD OR
19 COLLECTED BY THE STATE. SUCH REQUEST SHALL BE MADE TO THE COMMISSIONER
20 IN SUCH FORM AS THE COMMISSIONER SHALL PRESCRIBE, AND SHALL BE BASED ON
21 DOCUMENTATION THAT THE TOTAL AMOUNT TO BE RECOVERED IS IN EXCESS OF
22 TWENTY-FIVE PERCENT OF THE COUNTY VOCATIONAL EDUCATION AND EXTENSION
23 BOARD'S TOTAL STATE AID ALLOCATION PURSUANT TO THIS SECTION FOR THE
24 PRECEDING SCHOOL YEAR. THE AMOUNT TO BE DEDUCTED IN EACH YEAR SHALL BE
25 ONE-THIRD OF SUCH EXCESS PAYMENTS.
26 S 2. This act shall take effect immediately.
