AN ACT to amend the election law, in relation to providing that campaign accounts be transferred to the state treasury upon death of a candidate

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. The election law is amended by adding a new section 14-131  
2     to read as follows:  
3     S 14-131. REQUIRED DISPOSAL OF CAMPAIGN FUNDS. 1. UPON THE DEATH OF A  
4     CANDIDATE, FORMER CANDIDATE OR HOLDER OF ELECTIVE OFFICE, WHO RECEIVED  
5     CAMPAIGN CONTRIBUTIONS, ANY MONEYS REMAINING IN THE ACCOUNT OF A POLI-  
6     TICAL COMMITTEE FORMED FOR THE PURPOSE OF PROMOTING OR ELECTING SUCH  
7     CANDIDATE NOT OTHERWISE DUE AND OWED TO ANY PARTY SHALL BE PAID OVER TO  
8     THE COMPTROLLER OF THE STATE OF NEW YORK FOR DEPOSIT IN THE GENERAL  
9     TREASURY OF THE STATE.  
10    2. THE TREASURER OF A POLITICAL COMMITTEE SHALL NOTIFY THE STATE BOARD  
11    OF ELECTIONS UPON THE DEATH OF A CANDIDATE, FORMER CANDIDATE OR HOLDER  
12    OF ELECTIVE OFFICE. SUCH NOTICE SHALL BE FILED IN THE OFFICE IN WHICH  
13    THE COMMITTEE IS REQUIRED TO FILE STATEMENTS UNDER SECTION 14-110 OF  
14    THIS ARTICLE, WITHIN THIRTY DAYS OF THE DEATH OF SUCH PERSON.  
15    3. NOTWITHSTANDING SUBDIVISION ONE OF THIS SECTION, A CANDIDATE,  
16    FORMER CANDIDATE OR HOLDER OF ELECTIVE OFFICE MAY, AT ANY TIME, DESIG-  
17    NATE A CHARITABLE ORGANIZATION TO RECEIVE THE BALANCE OF ANY MONEYS  
18    REMAINING IN THE ACCOUNT OF A POLITICAL COMMITTEE FORMED FOR THE PURPOSE  
19    OF PROMOTING OR ELECTING SUCH CANDIDATE UPON THE DEATH OF SUCH PERSON BY  
20    FILING A NOTICE TO THAT EFFECT WITH THE STATE BOARD OF ELECTIONS. THE  
21    STATE BOARD OF ELECTIONS SHALL DEVELOP A FORM FOR SUCH PURPOSE. IF A  
22    CHARITABLE ORGANIZATION DESIGNATED BY A CANDIDATE UNDER THIS SECTION IS  
23    NO LONGER IN EXISTENCE UPON THE DEATH OF SUCH PERSON THEN SUCH REMAINING

1 MONEYS SHALL BE PAID INTO THE GENERAL TREASURY OF THE STATE IN ACCORD-  
2 ANCE WITH THIS SECTION.

3 S 2. This act shall take effect on the sixtieth day after it shall  
4 have become a law; provided, however, that this act shall apply to  
5 contributions received after such effective date; and provided, further,  
6 that the state board of elections shall notify all registered campaign  
7 committees of the applicable provisions of this act within thirty days  
8 after this act shall have become a law.
