AN ACT to amend the public authorities law, in relation to providing for the financing and construction of capital facilities for Broad Channel Volunteer Fire Department and Ambulance Corps, a not-for-profit corporation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Paragraph (b) of subdivision 2 of section 1676 of the  
2 public authorities law is amended by adding a new undesignated paragraph  
3 to read as follows:  
4 BROAD CHANNEL VOLUNTEER FIRE DEPARTMENT AND AMBULANCE CORPS, INC. FOR  
5 THE PURPOSE OF PROVIDING CONSTRUCTION RELATED SERVICES IN CONNECTION  
6 WITH THE CONSTRUCTION, RECONSTRUCTION, IMPROVEMENT, RENOVATION, DEVELOP-  
7 MENT OR EXPANSION OF FACILITIES OWNED BY BROAD CHANNEL VOLUNTEER FIRE  
8 DEPARTMENT AND AMBULANCE CORPS, INC. LOCATED AT 23 WEST 11TH ROAD, BROAD  
9 CHANNEL, NEW YORK.  
10 S 2. Subdivision 1 of section 1680 of the public authorities law is  
11 amended by adding a new undesignated paragraph to read as follows:  
12 BROAD CHANNEL VOLUNTEER FIRE DEPARTMENT AND AMBULANCE CORPS, INC. FOR  
13 THE PURPOSE OF PROVIDING CONSTRUCTION RELATED SERVICES IN CONNECTION  
14 WITH THE CONSTRUCTION, RECONSTRUCTION, IMPROVEMENT, RENOVATION, DEVELOP-  
15 MENT OR EXPANSION OF FACILITIES OWNED BY BROAD CHANNEL VOLUNTEER FIRE  
16 DEPARTMENT AND AMBULANCE CORPS, INC. LOCATED AT 23 WEST 11TH ROAD, BROAD  
17 CHANNEL, NEW YORK.  
18 S 3. This act shall take effect immediately.
