AN ACT to amend the penal law, in relation to redefining the term "disguised gun" to include any rifle, pistol, shotgun or machine-gun resembling a toy gun and prohibiting the possession, manufacture or design thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 20 of section 265.00 of the penal law, as added 1 2 by chapter 378 of the laws of 1998, is amended to read as follows:

- 3 20. "Disquised gun" means any weapon or device capable of being concealed on the person from which a shot can be discharged through the energy of an explosive and is designed and intended to appear to be something other than a gun; OR (B) A TOY GUN THAT SHALL EITHER; (A) 7 INCLUDE, BUT NOT BE LIMITED TO, ANY RIFLE, PISTOL, MACHINE-GUN DISPLAYING A COLOR FINISH OTHER THAN THE ORIGINAL MANUFAC-TURE COLOR, A DECORATIVE PATTERN OR PLASTIC 9 LIKE SURFACE; 10 THAT ANY RIFLE OR SHOTGUN DISPLAYING A CAMOUFLAGE COLOR FINISH 11 OR PATTERN THAT IS INTENDED FOR HUNTING, AS DEFINED BY ARTICLE ELEVEN OF 12 THE ENVIRONMENTAL CONSERVATION LAW, SHALL NOT BE CONSIDERED A "DISGUISED 13 GUN" FOR PURPOSES OF THIS SECTION.
- S 2. Section 265.10 of the penal law is amended by adding a new subdi-14 vision 8 to read as follows: 15
- 16 8. ANY PERSON, DEALER, FIRM, PARTNERSHIP OR CORPORATION WHO 17 DESIGNS OR TRANSFORMS A RIFLE, PISTOL, SHOTGUN OR MACHINE-GUN TIONALLY 18 TO RESEMBLE A TOY GUN BY EITHER ALTERING OR CONCEALING THE
