AN ACT to amend the education law, in relation to the Syracuse city school district

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 12 of section 3602 of the education law, as  
2     added by section 19 of part B of chapter 57 of the laws of 2008, the  
3     closing paragraph as added by section 18 of part A of chapter 57 of the  
4     laws of 2009, is amended to read as follows:  
5     12. Academic enhancement aid. A school district that as of April first  
6     of the base year has been continuously identified as a district in need  
7     of improvement for at least five years shall, for the two thousand  
8     eight--two thousand nine school year, be entitled to an additional  
9     apportionment equal to the positive remainder, if any, of (a) the lesser  
10    of fifteen million dollars or the product of the total foundation aid  
11    base, as defined by paragraph j of subdivision one of this section,  
12    multiplied by ten percent (0.10), less (b) the positive remainder of (i)  
13    the sum of the total foundation aid apportioned pursuant to subdivision  
14    four of this section and the supplemental educational improvement grants  
15    apportioned pursuant to subdivision eight of section thirty-six hundred  
16    forty-one of this [act] ARTICLE, less (ii) the total foundation aid  
17    base.  
18    For the two thousand nine--two thousand ten [and] THROUGH two thousand  
19    [ten] ELEVEN--two thousand [eleven] TWELVE school years, each school  
20    district shall be entitled to an apportionment equal to the amount set  
21    forth for such school district as "EDUCATION GRANTS, ACADEMIC EN" under  
22    the heading "2008-09 BASE YEAR AIDS" in the school aid computer listing  
23    produced by the commissioner in support of the budget for the two thou-  
24    sand nine--two thousand ten school year and entitled "SA0910", and such  
25    apportionment shall be deemed to satisfy the state obligation to provide  
26    an apportionment pursuant to subdivision eight of section thirty-six  
27    hundred forty-one of this article. THE SYRACUSE CITY SCHOOL DISTRICT  
28    SHALL ALSO BE ENTITLED TO AN AMOUNT EQUIVALENT TO THE PERCENTAGE

1 INCREASE, CARRIED TO FOUR DECIMALS, IN THE SYRACUSE CITY SCHOOL DISTRICT  
2 PUBLIC ENROLLMENT PURSUANT TO FOUNDATION AID UNDER SUBDIVISION FOUR OF  
3 THIS SECTION FROM THE TWO THOUSAND EIGHT--TWO THOUSAND NINE SCHOOL YEAR  
4 TO THE TWO THOUSAND NINE--TWO THOUSAND TEN SCHOOL YEAR MULTIPLIED BY THE  
5 DISTRICT'S FOUNDATION AID AMOUNT. SUCH INCREASE SHALL NOT BE SUBJECT TO  
6 SECTION TWO HUNDRED ELEVEN-D OF THIS CHAPTER.

7 S 2. This act shall take effect July 1, 2010.
