AN ACT to amend the administrative code of the city of New York, in relation to the establishment of specific criteria for the evaluation and placement of traffic control signals

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Short title. This act shall be known and may be cited as 2 "Stefan's law".
  - S 2. The administrative code of the city of New York is amended by adding a new section 19-180.1 to read as follows:
- 5 19-180.1 TRAFFIC CONTROL SIGNALS. THE DEPARTMENT SHALL ESTABLISH A 6 PROCESS BY WHICH IT EVALUATES THE NEED FOR TRAFFIC CONTROL SIGNALS TO BE 7 PLACED AT INTERSECTIONS WITHIN THE CITY. CRITERIA TO BE INCLUDED IN SUCH PROCESS SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO, 8 MOTOR VEHICLE 9 TRAFFIC VOLUMES, VISIBILITY FOR BOTH MOTOR VEHICLE OPERATORS PEDESTRIAN 10 AND PEDESTRIANS, ANY UNIOUE CHARACTERISTICS RELEVANT TO THE LOCATION QUESTION, PROXIMITY OF EXISTING TRAFFIC CONTROL SIGNALS TO THE LOCATION 11 IN QUESTION, AVERAGE VEHICULAR SPEEDS, THE FREQUENCY AND TYPES OF ACCI-12 13 INVOLVING MOTOR VEHICLES AND PEDESTRIANS, INCLUDING DAMAGE TO PROPERTY, AT SPECIFIC INTERSECTIONS BASED UPON INFORMATION 14 15 TICS PROVIDED BY THEPOLICE DEPARTMENT AND INSURANCE COMPANIES, THE LIKELY PRESENCE OF SCHOOL CHILDREN AND BICYCLISTS 16 AND THE ABILITY APPROPRIATELY CONTROL TRAFFIC FLOW BY IMPLEMENTING OTHER TRAFFIC CONTROL 17 18 TECHNIQUES, SUCH AS SPEED BUMPS OR SPEED LIMIT SIGNS. WHENEVER THE 19 DEPARTMENT UNDERTAKES SUCH EVALUATION FOLLOWING THE REQUEST OF AN 20 VIDUAL, GROUP OR ORGANIZATION FOR THE INSTALLATION OF A TRAFFIC CONTROL 21 SIGNAL AT A PARTICULAR INTERSECTION AND SUCH REQUEST IS DENIED AFTER THE COMPLETION OF SUCH EVALUATION, THE DEPARTMENT SHALL PROVIDE A WRITTEN 22 FINDING TO SUCH INDIVIDUAL, GROUP OR ORGANIZATION UPON REQUEST DETAILING 23 24 RESULTS OF THE EVALUATION UPON WHICH ITS DETERMINATION WAS BASED.
- 25 SUCH WRITTEN FINDING SHALL BE PROVIDED WITHIN TEN BUSINESS DAYS OF SUCH 26 REQUEST, WITH COPIES SENT TO THE MEMBER OF THE STATE ASSEMBLY AND STATE

27 SENATOR IN WHOSE DISTRICTS SUCH EVALUATED INTERSECTION IS LOCATED.

S 3. This act shall take effect on the ninetieth day after it shall have become a law, provided that any administrative actions, including the promulgation of rules, necessary to implement the provisions of this act on its effective date are authorized and directed to be taken and completed on or before such effective date.
