AN ACT to amend the environmental conservation law, in relation to repair of damaged pesticide containers; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph b of subdivision 1 of section 33-1301 of the
2 environmental conservation law, as amended by chapter 318 of the laws of
3 1992, is amended to read as follows:
4 b. Except as specified in regulation authorizing alternative pesticide
5 containers, any pesticide unless it:
6 (1) is in the registrant's or the manufacturer's unbroken immediate
7 container, and there is affixed to such container, and to the outside
8 container or wrapper of the retail package, if there be one, through
9 which the required information on the immediate container cannot be
10 clearly read, a label bearing[:
11 (1) The] (I) THE name and address of the manufacturer, registrant, or
12 person for whom manufactured;
13 [(2) The] (II) THE name, brand, or trade-mark under which said article
14 is sold; and
15 [(3) The] (III) THE net weight or measure of the content; subject,
16 however, to such reasonable variations as the commissioner may permit;OR
17 (2) MEETS THE REQUIREMENTS OF SUBPARAGRAPH ONE OF THIS PARAGRAPH
18 EXCEPT THAT THE CONTAINER HAS BEEN ACCIDENTLY DAMAGED DURING HANDLING
19 PRIOR TO SALE AND THE DAMAGE HAS BEEN REPAIRED BY SUCH PERSON IN ACCORD-
20 ANCE WITH HIS OR HER OWN SPECIFIC "MINOR REPAIR PROGRAM" APPROVED BY THE
21 UNITED STATES ENVIRONMENTAL PROTECTION AGENCY PURSUANT TO ITS OCTOBER
22 NINTH, TWO THOUSAND NINE PESTICIDE CONTAINER REPAIR INTERIM POLICY. A
23 COPY OF THE APPROVED PROGRAM SHALL BE FORWARDED TO THE DEPARTMENT WITHIN
24 THIRTY DAYS OF APPROVAL AND SHALL BE KEPT AT THE PERSON'S PLACE OF BUSI-
25 NESS AND BE AVAILABLE FOR DEPARTMENT REVIEW UPON REQUEST.
