AN ACT to amend the executive law, in relation to requiring unanimous agreement by the parole board to release an inmate on parole

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph (i) of paragraph (a) of subdivision 2 of 2 section 259-i of the executive law, as separately amended by section 11 3 of part E and section 9 of part F of chapter 62 of the laws of 2003, is 4 amended to read as follows:

5 (i) Except as provided in subparagraph (ii) of this paragraph, at 6 least one month prior to the date on which an inmate may be paroled 7 pursuant to subdivision one of section 70.40 of the penal law, a member 8 or members as determined by the rules of the board shall personally 9 interview such inmate and determine whether he OR SHE should be paroled 10 in accordance with the guidelines adopted pursuant to subdivision four 11 of section two hundred fifty-nine-c of this article. SUCH DETERMINATION PAROLE SUCH INMATE SHALL BE BY UNANIMOUS AGREEMENT OF THE BOARD. If 12 TO parole is not granted upon such review, the inmate shall be informed in 13 14 writing within two weeks of such appearance of the factors and reasons for such denial of parole. Such reasons shall be given in detail and not 15 16 in conclusory terms. The board shall specify a date not more than twenty-four months from such determination for reconsideration, and the 17 procedures to be followed upon reconsideration shall be the same. If the 18 19 inmate is released, he OR SHE shall be given a copy of the conditions of 20 parole. Such conditions shall where appropriate, include a requirement 21 that the parolee comply with any restitution order, mandatory surcharge, 22 sex offender registration fee and DNA databank fee previously imposed by a court of competent jurisdiction that applies to the parolee. The board 23 of parole shall indicate which restitution collection agency established 24 25 under subdivision eight of section 420.10 of the criminal procedure law, 26 shall be responsible for collection of restitution, mandatory surcharge, 27 sex offender registration fees and DNA databank fees as provided for in

3 S 2. Paragraph (a) of subdivision 2 of section 259-i of the executive 4 law, as amended by chapter 396 of the laws of 1987, is amended to read 5 as follows:

6 (a) At least one month prior to the expiration of the minimum period 7 or periods of imprisonment fixed by the court or board, a member or 8 members as determined by the rules of the board shall personally inter-9 view an inmate serving an indeterminate sentence and determine whether 10 OR SHE should be paroled at the expiration of the minimum period or he periods in accordance with the guidelines adopted pursuant 11 to subdivi-12 sion four of section two hundred fifty-nine-c. SUCH DETERMINATION TO PAROLE SUCH INMATE SHALL BE BY UNANIMOUS AGREEMENT OF 13 THEBOARD. Ιf 14 parole is not granted upon such review, the inmate shall be informed in 15 writing within two weeks of such appearance of the factors and reasons 16 for such denial of parole. Such reasons shall be given in detail and not 17 conclusory terms. This act shall take effect immediately, provided that the amend-S 31 ments to paragraph (a) of subdivision 2 of section 259-i of the execu-32 tive law made by section one of this act shall be subject to the expira-33 tion and reversion of such paragraph pursuant to section 74 of chapter 3 34 of the laws of 1995, as amended, when upon such date the provisions of section two of this act shall take effect. 35
