- AN ACT to amend the environmental conservation law, in relation to the requirement for an environmental impact statement

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraphs (b) and (f) of subdivision 2 of section 8-0109 1 the environmental conservation law, as amended by chapter 219 of the 2 of 3 laws of 1990, are amended and a new paragraph (e-1) is added to read as 4 follows: 5 (b) the environmental impact of the proposed action including short-6 term [and], long-term AND CUMULATIVE effects; (E-1) AN ANALYSIS OF THE CUMULATIVE ENVIRONMENTAL 7 IMPACTS OF THE 8 PROPOSED PROJECT; 9 (f) mitigation measures proposed to minimize the environmental impact, 10 INCLUDING CUMULATIVE EFFECTS; 2. Section 8-0105 of the environmental conservation law is amended 11 S by adding a new subdivision 9 to read as follows: 12 13 9. "CUMULATIVE ENVIRONMENTAL IMPACTS" MEANS ENVIRONMENTAL IMPACTS THAT 14 MAY OCCUR WHEN A PROPOSED ACTION OR ACTIONS: 15 (I) MAY RESULT IN CHANGES IN TWO OR MORE ELEMENTS OF THE ENVIRONMENT; 16 (II) WHEN CONSIDERED TOGETHER WITH ONE OR MORE PENDING OR PROPOSED 17 IN CHANGES IN ONE OR MORE COMMON ELEMENTS OF THE ACTIONS, MAY RESULT 18 ENVIRONMENT; 19 (III) WILL RESULT IN ONE OR MORE OTHER ACTIONS LIKELY TO BE UNDERTAKEN AS A RESULT THEREOF; 20 21 (IV) IS A PART OF A PROPOSAL OR PLAN THAT INCLUDES OR CONTEMPLATES ONE 22 OR MORE OTHER SIMULTANEOUS OR SUBSEQUENT ACTIONS; 23 (V) IS DEPENDENT UPON APPROVAL OR COMPLETION OF ONE OR MORE OTHER 24 ACTIONS;

IS A PROGRAM OR PLAN HAVING WIDE APPLICATION OR IS A PART THERE-1 (VI) 2 OF; 3 (VII) IS A PLAN, PROGRAM, OR SERIES OF ACTIONS THAT WILL RESTRICT THE 4 RANGE OF FUTURE ALTERNATIVES, POLICIES, OR ACTIONS; 5 (VIII) WHEN CONSIDERED TOGETHER WITH EXISTING OR BACKGROUND LEVELS OF 6 CONTAMINATION OR POLLUTION OR ACTIONS WHICH HAVE HAD AN ADVERSE EFFECT 7 ON THE ENVIRONMENT, MAY RESULT IN COMBINED OR SYNERGISTIC IMPACTS ON THE 8 ENVIRONMENT; OR 9 (IX) A COMBINATION OF ONE OR MORE OF THE ABOVE. 10 CUMULATIVE ENVIRONMENTAL IMPACTS SHALL BE CONSIDERED WITHOUT REGARD TO WHETHER THE ACTION OR ACTIONS ARE PROPOSED BY 11 THE SAME INDIVIDUAL, OR AGENCY, OR WHETHER THE ACTION IS PENDING FOR APPROVAL BY ONE 12 PERSON, OR MORE AGENCIES. 13 14 S 3. This act shall take effect on the one hundred eightieth day 15 after it shall have become a law; provided, however that effective immediately, the addition, amendment and/or repeal of any rule or regulation 16 necessary for the implementation of this act on its effective date are 17 authorized and directed to be made and completed on or before such 18 19 effective date.
