AN ACT to amend the insurance law, in relation to requiring health insurance policies to cover comprehensive ultrasound screening and magnetic resonance imaging for breast cancer in certain cases and requiring the provision of certain information relating to breast density to patients

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph 11 of subsection (i) of section 3216 of the
2 insurance law is amended by adding a new subparagraph (D) to read as
3 follows:
4 (D) (I) SUCH POLICY SHALL PROVIDE ADDITIONAL COVERAGE FOR COMPREHEN-
5 SIVE ULTRASOUND SCREENING AND/OR MAGNETIC RESONANCE IMAGING (MRI) OF AN
6 ENTIRE BREAST OR THE ENTIRETY OF BOTH BREASTS IF:
7 (I) A MAMMOGRAM DEMONSTRATES HETEROGENEOUS OR DENSE BREAST TISSUE
8 BASED ON THE BREAST IMAGING REPORTING AND DATA SYSTEM ESTABLISHED BY THE
9 AMERICAN COLLEGE OF RADIOLOGY; OR
10 (II) A WOMAN IS BELIEVED TO BE AT INCREASED RISK FOR BREAST CANCER DUE
11 TO FAMILY HISTORY OR PRIOR PERSONAL HISTORY OF BREAST CANCER, POSITIVE
12 GENETIC TESTING OR OTHER INDICATIONS AS DETERMINED BY SUCH WOMAN'S
13 PHYSICIAN OR NURSE PRACTITIONER.
14 (II) SUCH ADDITIONAL COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND
15 COINSURANCE AS MAY BE DEEMED APPROPRIATE BY THE SUPERINTENDENT AND AS
16 ARE CONSISTENT WITH THOSE ESTABLISHED FOR OTHER BENEFITS WITHIN A GIVEN

18 (III) EACH MAMMOGRAPHY REPORT PROVIDED TO A PATIENT SHALL INCLUDE
19 INFORMATION ABOUT BREAST DENSITY, BASED ON THE BREAST IMAGING REPORTING
20 AND DATA SYSTEM ESTABLISHED BY THE AMERICAN COLLEGE OF RADIOLOGY. WHERE
21 APPLICABLE, SUCH REPORT SHALL INCLUDE THE FOLLOWING NOTICE: "IF YOUR

17 (II) SUCH ADDITIONAL COVERAGE MAY BE SUBJECT TO ANNUAL DEDUCTIBLES AND

36 SIVE ULTRASOUND SCREENING AND/OR MAGNETIC RESONANCE IMAGING (MRI) OF AN
37 ENTIRE BREAST OR THE ENTIRETY OF BOTH BREASTS IF:

5 S 4. Paragraph 7 of subsection (d) of section 4326 of the insurance
6 law, as added by chapter 1 of the laws of 1999, is amended to read as
7 follows:

8 (7) adult preventive health services consisting of mammography screen-
9 ing, AS PROVIDED IN SUBSECTION (P) OF SECTION FOUR THOUSAND THREE
10 HUNDRED THREE OF THIS ARTICLE; cervical cytology screening; periodic
11 physical examinations no more than once every three years; and adult
12 immunizations;

13 S 5. This act shall take effect on the sixtieth day after it shall
14 have become a law.
