AN ACT to amend the alcoholic beverage control law, in relation to increasing the length of suspension of a driver's license for a person who illegally purchases or attempts to illegally purchase an alcoholic beverage

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision 6 of section 65-b of the alcoholic beverage
2 control law, as amended by chapter 519 of the laws of 1999, the opening
3 paragraph as amended by chapter 503 of the laws of 2000, is amended to
4 read as follows:
5 6. In addition to the penalties otherwise provided in subdivision
6 three of this section, if a determination is made sustaining a charge of
7 illegally purchasing or attempting to illegally purchase an alcoholic
8 beverage, the court may suspend such person's license to drive a motor
9 vehicle and the privilege of an unlicensed person of obtaining such
10 license, in accordance with the following and for the following periods,
11 if it is found that a driver's license was used for the purpose of such
12 illegal purchase or attempt to illegally purchase; provided, however,
13 that where a person is sentenced pursuant to paragraph (b) or (c) of
14 subdivision three of this section, the court shall impose such license
15 suspension if it is found that a driver's license was used for the
16 purpose of such illegal purchase or attempt to illegally purchase:
17 (a) For a first violation of paragraph (a) of subdivision two of this
18 section, a [three] SIX month suspension.
19 (b) For a second [violation of paragraph (a) of subdivision two of
20 this section, a six month suspension.

1 (c) For a third] or subsequent violation of paragraph (a) of subdivi-
2 sion two of this section, a suspension for one year or until the holder
3 reaches the age of twenty-one, whichever is the greater period of time.

4 Such person may thereafter apply for and be issued a restricted use
5 license in accordance with the provisions of section five hundred thirty
6 of the vehicle and traffic law.

7 S 2. Subdivision 5 of section 65-b of the alcoholic beverage control
8 law, as amended by chapter 383 of the laws of 1998, the opening para-
9 graph as amended by chapter 503 of the laws of 2000, is amended to read
10 as follows:

11 5. In addition to the penalties otherwise provided in subdivision two
12 of this section, if a determination is made sustaining a charge of ille-
13 gally purchasing or attempting to illegally purchase an alcoholic bever-
14 age, the court may suspend such person's license to drive a motor vehi-
15 cle and the privilege of an unlicensed person of obtaining such license,
16 in accordance with the following and for the following periods, if it is
17 found that a driver's license was used for the purpose of such illegal
18 purchase or attempt to illegally purchase; provided, however, that where
19 a person is sentenced pursuant to paragraph (b) or (c) of subdivision
20 two of this section, the court shall impose such license suspension if
21 it is found that a driver's license was used for the purpose of such
22 illegal purchase or attempt to illegally purchase:

23 (a) For a first violation of paragraph (a) of subdivision one of this
24 section, a [three] SIX month suspension.

25 (b) For a second [violation of paragraph (a) of subdivision one of
26 this section, a six month suspension.

27 (c) For a third] or subsequent violation of paragraph (a) of subdivi-
28 sion one of this section, a suspension for one year or until the holder
29 reaches the age of twenty-one, whichever is the greater period of time.

30 Such person may thereafter apply for and be issued a restricted use
31 license in accordance with the provisions of section five hundred thirty
32 of the vehicle and traffic law.

33 S 3. This act shall take effect on the ninetieth day after it shall
34 have become a law, provided that the amendments to subdivision 6 of
35 section 65-b of the alcoholic beverage control law made by section one
36 of this act shall be subject to the expiration and reversion of such
37 subdivision pursuant to section 4 of chapter 519 of the laws of 1999, as
38 amended, when upon such date the provisions of section two of this act
39 shall take effect.
