AN ACT to amend the vehicle and traffic law, in relation to the issuance
of distinctive plates for veterans of the armed forces of the United
States

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 404-x to read as follows:
3 S 404-X. DISTINCTIVE PLATES FOR VETERANS OF THE ARMED FORCES OF THE
4 UNITED STATES. 1. ANY VETERAN OF THE ARMY, NAVY, AIR FORCE, MARINE
5 CORPS, COAST GUARD OR MERCHANT MARINE OF THE UNITED STATES OR THE SPOUSE
6 OF ANY SUCH VETERAN SHALL, UPON REQUEST, BE ISSUED A LICENSE PLATE BEAR-
7 ING THE WORDS "UNITED STATES ARMY VETERAN", "UNITED STATES NAVY VETER-
8 AN", "UNITED STATES AIR FORCE VETERAN", "UNITED STATES MARINE CORPS
9 VETERAN", "UNITED STATES COAST GUARD VETERAN" OR "UNITED STATES MERCHANT
10 MARINE VETERAN", RESPECTIVELY. IF A DISTINCTIVE PLATE IS ISSUED TO A
11 VETERAN PURSUANT TO THIS SECTION, SUCH A DISTINCTIVE PLATE SHALL NOT BE
12 ISSUED TO THE SPOUSE OF SUCH VETERAN. APPLICATION FOR SUCH LICENSE PLATE
13 SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE
14 COMMISSIONER SHALL PRESCRIBE.
15 2. THE DISTINCTIVE PLATE AUTHORIZED IN SUBDIVISION ONE OF THIS SECTION
16 SHALL BE ISSUED UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE
17 APPLICANT IS A VETERAN OF THE ARMY, NAVY, AIR FORCE, MARINE CORPS, COAST
18 GUARD OR MERCHANT MARINE OF THE UNITED STATES, OR THE SPOUSE OF SUCH
19 VETERAN.
20 3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED
21 IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THE REGULAR
22 REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE
23 PROVIDED, HOWEVER, THAT AN ADDITIONAL ONE TIME SERVICE CHARGE OF TEN
24 DOLLARS SHALL BE CHARGED FOR SUCH PLATE.
25 4. NOTHING CONTAINED IN THIS SECTION SHALL REQUIRE THE ISSUANCE OF A
26 SPECIAL NUMBER PLATE UNDER THIS SECTION UNLESS THE COMMISSIONER IS
27 SATISFIED THAT THE AGGREGATE AMOUNT OF ANNUAL SERVICE CHARGES COLLECTED
