AN ACT to amend the labor law, in relation to prevailing wages

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 220 of the labor law is amended by adding a new
2 subdivision 3-f to read as follows:

3 3-F. FOR THE PURPOSES OF DETERMINING PREVAILING WAGES UNDER THIS
4 SECTION, PERSONS CONTRACTED TO PROVIDE A FIRE ALARM SYSTEM, INCLUDING
5 SYSTEM TESTING AND MAINTENANCE, WHO DO NOT INSTALL SUCH ALARM SYSTEM
6 SHALL NOT BE DETERMINED TO BE ELECTRICIANS OR SUBCONTRACTORS OF AN ELEC-
7 TRICIAN.

8 S 2. This act shall take effect immediately.
