AN ACT to require a workgroup to investigate and report about licensing and the difficulties encountered by military spouses (Part A); to amend the education law, in relation to the authority of the state to certify persons to teach who are not graduates of teacher education programs (Part B); to amend the education law, in relation to adopting the interstate nursing licensure compact (Part C); to amend the education law, the general business law, the insurance law and the real property law, in relation to licensing of military spouses with out-of-state licenses in equivalent occupations (Part D)

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act enacts into law components of legislation relating
2 to the "Military Spouse Act of 2010". Each component is wholly contained
3 within a Part identified as Parts A through D. The effective date for
4 each particular provision contained within such Part is set forth in the
5 last section of such Part. Any provision in any section contained within
6 a Part, including the effective date of the Part, which makes reference
7 to a section "of this act", when used in connection with that particular
8 component, shall be deemed to mean and refer to the corresponding
9 section of the Part in which it is found. Section three of this act
10 sets forth the general effective date of this act.

11 PART A

12 Section 1. State agencies are hereby directed to help spouses of
13 members of the armed forces of the United States, national guard or
14 reserves transfer teaching certificates or professional certifications
15 to their new home state.

16 S 2. The department of labor and the division of veterans' affairs
17 shall establish a workgroup to identify licensing requirements for work-
18 force shortage areas and to study, in conjunction with the relevant

1 licensing entities, whether comparable military training could substi-
2 tute for current licensing requirements, and manners in which state
3 agencies, regulatory bodies and licensing entities can adopt procedures
4 sensitive to the difficulties encountered by military spouses. The work-
5 group shall submit any findings, including any recommendations for
6 legislative action to the governor, the temporary president of the
7 senate and the speaker of the assembly by January 1, 2012.

8 S 3. This act shall take effect immediately.

PART B

10 Section 1. Subdivision 1 of section 3006 of the education law is
11 amended by adding a new paragraph f to read as follows:

12 F. AN ALTERNATIVE PLACEMENT CERTIFICATE TO ANY PERSON:

13 (1) WHO MEETS THE ELIGIBILITY REQUIREMENTS OF THE TROOPS FOR TEACHERS
14 PROGRAM OPERATED BY THE UNITED STATES DEPARTMENT OF DEFENSE AND MANAGED
15 BY THE DEFENSE ACTIVITY FOR NON-TRADITIONAL EDUCATION SUPPORT ORGANIZA-
16 TION; AND

17 (2) WHO MEETS THE REQUIREMENTS SET FORTH IN SECTION THREE THOUSAND
18 EIGHT-A OF THIS ARTICLE.

19 S 2. The education law is amended by adding a new section 3008-a to
20 read as follows:

21 S 3008-A. ALTERNATIVE TEACHING CERTIFICATION. 1. THE COMMISSIONER
22 SHALL ISSUE A ONE-YEAR, NONRENEWABLE MIDDLE OR SECONDARY LEVEL ALTERNA-
23 TIVE TEACHING CERTIFICATION TO TEACH TO ANY PERSON WHO HAS ATTAINED
24 CERTIFICATION BY AN ALTERNATIVE TEACHER CERTIFICATION ORGANIZATION AS
25 SET FORTH IN SUBDIVISION THREE OF THIS SECTION AND HAS MET THE REQUIRE-
26 MENTS OF SECTION THREE THOUSAND FOUR-B OF THIS ARTICLE.

27 2. NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, TEACHERS
28 ISSUED AN ALTERNATIVE TEACHING CERTIFICATION PURSUANT TO THIS SECTION
29 SHALL PARTICIPATE IN THE MENTORING PROGRAM PROVIDED BY THE ALTERNATIVE
30 TEACHER CERTIFICATION ORGANIZATION AS SET FORTH IN SUBDIVISION THREE OF
31 THIS SECTION. UPON SUCCESSFUL COMPLETION OF SUCH MENTORING PROGRAM,
32 COMPLETION OF THE APPLICATION AND PAYMENT OF THE CERTIFICATION FEE AS
33 SET FORTH IN SECTION THREE THOUSAND SIX OF THIS ARTICLE OR AS PRESCRIBED
34 BY THE COMMISSIONER, THE COMMISSIONER SHALL ISSUE THE TEACHER A CERTIF-
35 ICATE TO TEACH.

36 3. FOR PURPOSES OF THIS SECTION, THE COMMISSIONER SHALL IDENTIFY AN
37 ALTERNATIVE TEACHER CERTIFICATION ORGANIZATION THAT WAS FOUNDED WITH
38 GRANT FUNDING FROM THE UNITED STATES DEPARTMENT OF EDUCATION AND THAT
39 DEVELOPED PURSUANT TO THE PASSPORT TO TEACHING PROGRAM ADMINISTERED BY
40 THE AMERICAN BOARD FOR CERTIFICATION OF TEACHER EXCELLENCE. THE ORGAN-
41 IZATION SHALL REQUIRE CANDIDATES TO HOLD A BACHELOR'S DEGREE, PASS A
42 PROFESSIONAL TEACHING KNOWLEDGE EXAM, PASS A SUBJECT AREA EXAM AND PASS
43 A BACKGROUND CHECK. THE ORGANIZATION SHALL PROVIDE CANDIDATES WITH
44 ACCESS TO WORKSHOPS, AN EXPERIENCED TEACHER-ADVISOR AND OPTIONAL ACCESS
45 TO COMPREHENSIVE SUBJECT MATTER REFRESHER COURSES. THE ORGANIZATION
46 SHALL ALSO PROVIDE AN INTENSIVE MENTORING AND INDUCTION PROGRAM.

47 S 3. This act shall take effect on the ninetieth day after it shall
48 have become a law; provided, however, that effective immediately, the
49 addition, amendment and/or repeal of any rule or regulation necessary
50 for the implementation of this act on its effective date are authorized
51 and directed to be made and completed on or before such effective date.

PART C

1 Section 1. The education law is amended by adding a new section 6911
2 to read as follows:

3 S 6911. INTERSTATE NURSE LICENSURE COMPACT. 1. THE INTERSTATE NURSE
4 LICENSURE COMPACT IS HEREBY ENACTED INTO LAW AND ENTERED INTO WITH ALL
5 JURISDICTIONS LEGALLY JOINING THEREIN IN THE FORM SUBSTANTIALLY AS
6 FOLLOWS:

7 INTERSTATE NURSE LICENSURE COMPACT
8 ARTICLE I.
9 FINDINGS AND DECLARATION OF PURPOSE

10 (A) THE PARTY STATES FIND THAT:

11 (1) THE HEALTH AND SAFETY OF THE PUBLIC ARE AFFECTED BY THE DEGREE OF
12 COMPLIANCE WITH AND THE EFFECTIVENESS OF ENFORCEMENT ACTIVITIES RELATED
13 TO STATE NURSE LICENSURE LAWS;

14 (2) VIOLATIONS OF NURSE LICENSURE AND OTHER LAWS REGULATING THE PRAC-
15 TICE OF NURSING MAY RESULT IN INJURY OR HARM TO THE PUBLIC;

16 (3) THE EXPANDED MOBILITY OF NURSES AND THE USE OF ADVANCED COMMUNI-
17 CATION TECHNOLOGIES AS PART OF OUR NATION'S HEALTHCARE DELIVERY SYSTEM
18 REQUIRE GREATER COORDINATION AND COOPERATION AMONG STATES IN THE AREAS
19 OF NURSE LICENSURE AND REGULATION;

20 (4) NEW PRACTICE MODALITIES AND TECHNOLOGY MAKE COMPLIANCE WITH INDI-
21 VIDUAL STATE NURSE LICENSURE LAWS DIFFICULT AND COMPLEX; AND

22 (5) THE CURRENT SYSTEM OF DUPLICATIVE LICENSURE FOR NURSES PRACTICING
23 IN MULTIPLE STATES IS CUMBERSOME AND REDUNDANT TO BOTH NURSES AND
24 STATES.

25 (B) THE GENERAL PURPOSES OF THIS COMPACT ARE TO:

26 (1) FACILITATE THE STATES' RESPONSIBILITY TO PROTECT THE PUBLIC'S
27 HEALTH AND SAFETY;

28 (2) ENSURE AND ENCOURAGE THE COOPERATION OF PARTY STATES IN THE AREAS
29 OF NURSE LICENSURE AND REGULATION;

30 (3) FACILITATE THE EXCHANGE OF INFORMATION BETWEEN PARTY STATES IN THE
31 AREAS OF NURSE REGULATION, INVESTIGATION, AND ADVERSE ACTIONS;

32 (4) PROMOTE COMPLIANCE WITH THE LAWS GOVERNING THE PRACTICE OF NURSING
33 IN EACH JURISDICTION; AND

34 (5) INVEST ALL PARTY STATES WITH THE AUTHORITY TO HOLD A NURSE
35 ACCOUNTABLE FOR MEETING ALL STATE PRACTICE LAWS IN THE STATE IN WHICH
36 THE PATIENT IS LOCATED AT THE TIME CARE IS RENDERED THROUGH THE MUTUAL
37 RECOGNITION OF PARTY STATE LICENSES.

38 ARTICLE II.
39 DEFINITIONS

40 AS USED IN THIS COMPACT:

41 (A) "ADVERSE ACTION" MEANS A HOME OR REMOTE STATE ACTION.

42 (B) "ALTERNATIVE PROGRAM" MEANS A VOLUNTARY, NON-DISCIPLINARY MONITOR-
43 ING PROGRAM APPROVED BY A NURSE LICENSING BOARD.

44 (C) "COORDINATED LICENSURE INFORMATION SYSTEM" MEANS AN INTEGRATED
45 PROCESS FOR COLLECTING, STORING, AND SHARING INFORMATION ON NURSE LICEN-
46 SURE AND ENFORCEMENT ACTIVITIES RELATED TO NURSE LICENSURE LAWS, WHICH
47 IS ADMINISTERED BY A NON-PROFIT ORGANIZATION COMPOSED OF AND CONTROLLED
48 BY STATE NURSE LICENSING BOARDS.

49 (D) "CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION" MEANS:

50 (1) INVESTIGATIVE INFORMATION THAT A LICENSING BOARD, AFTER A PRELIMI-
51 NARY INQUIRY THAT INCLUDES NOTIFICATION AND AN OPPORTUNITY FOR THE NURSE
52 TO RESPOND IF REQUIRED BY STATE LAW, HAS REASON TO BELIEVE IS NOT

1 GROUNDLESS AND, IF PROVED TRUE, WOULD INDICATE MORE THAN A MINOR INFRAC-
2 TION; OR

3 (2) INVESTIGATIVE INFORMATION THAT INDICATES THAT THE NURSE REPRESENTS
4 AN IMMEDIATE THREAT TO PUBLIC HEALTH AND SAFETY REGARDLESS OF WHETHER
5 THE NURSE HAS BEEN NOTIFIED AND HAD AN OPPORTUNITY TO RESPOND.

6 (E) "HOME STATE" MEANS THE PARTY STATE WHICH IS THE NURSE'S PRIMARY
7 STATE OF RESIDENCE.

8 (F) "HOME STATE ACTION" MEANS ANY ADMINISTRATIVE, CIVIL, EQUITABLE OR
9 CRIMINAL ACTION PERMITTED BY THE HOME STATE'S LAWS WHICH ARE IMPOSED ON
10 A NURSE BY THE HOME STATE'S LICENSING BOARD OR OTHER AUTHORITY INCLUDING
11 ACTIONS AGAINST AN INDIVIDUAL'S LICENSE SUCH AS: REVOCATION, SUSPENSION,
12 PROBATION OR ANY OTHER ACTION WHICH AFFECTS THE NURSE'S AUTHORIZATION TO
13 PRACTICE.

14 (G) "LICENSING BOARD" MEANS A PARTY STATE'S REGULATORY BODY RESPONSI-
15 BLE FOR ISSUING NURSE LICENSES.

16 (H) "MULTISTATE LICENSURE PRIVILEGE" MEANS CURRENT, OFFICIAL AUTHORITY
17 FROM A REMOTE STATE PERMITTING THE PRACTICE OF NURSING AS EITHER A
18 REGISTERED NURSE OR A LICENSED PRACTICAL/VOCATIONAL NURSE IN SUCH PARTY
19 STATE. ALL PARTY STATES HAVE THE AUTHORITY, IN ACCORDANCE WITH EXISTING
20 STATE DUE PROCESS LAW, TO TAKE ACTIONS AGAINST THE NURSE'S PRIVILEGE
21 SUCH AS: REVOCATION, SUSPENSION, PROBATION OR ANY OTHER ACTION WHICH
22 AFFECTS A NURSE'S AUTHORIZATION TO PRACTICE.

23 (I) "NURSE" MEANS A REGISTERED NURSE OR LICENSED PRACTICAL/VOCATIONAL
24 NURSE, AS THOSE TERMS ARE DEFINED BY EACH PARTY'S STATE PRACTICE LAWS.

25 (J) "PARTY STATE" MEANS ANY STATE THAT HAS ADOPTED THIS COMPACT.

26 (K) "REMOTE STATE" MEANS A PARTY STATE, OTHER THAN THE HOME STATE,

27 (1) WHERE THE PATIENT IS LOCATED AT THE TIME NURSING CARE IS PROVIDED,
28 OR

29 (2) IN THE CASE OF THE PRACTICE OF NURSING NOT INVOLVING A PATIENT, IN
30 SUCH PARTY STATE WHERE THE RECIPIENT OF NURSING PRACTICE IS LOCATED.

31 (L) "REMOTE STATE ACTION" MEANS

32 (1) ANY ADMINISTRATIVE, CIVIL, EQUITABLE OR CRIMINAL ACTION PERMITTED
33 BY A REMOTE STATE'S LAWS WHICH ARE IMPOSED ON A NURSE BY THE REMOTE
34 STATE'S LICENSING BOARD OR OTHER AUTHORITY INCLUDING ACTIONS AGAINST AN
35 INDIVIDUAL'S MULTISTATE LICENSURE PRIVILEGE TO PRACTICE IN THE REMOTE
36 STATE, AND

37 (2) CEASE AND DESIST AND OTHER INJUNCTIVE OR EQUITABLE ORDERS ISSUED
38 BY REMOTE STATES OR THE LICENSING BOARDS THEREOF.

39 (M) "STATE" MEANS A STATE, TERRITORY OR POSSESSION OF THE UNITED
40 STATES, THE DISTRICT OF COLUMBIA OR THE COMMONWEALTH OF PUERTO RICO.

41 (N) "STATE PRACTICE LAWS" MEANS THOSE INDIVIDUAL PARTY STATE'S LAWS
42 AND REGULATIONS THAT GOVERN THE PRACTICE OF NURSING, DEFINE THE SCOPE OF
43 NURSING PRACTICE, AND CREATE THE METHODS AND GROUNDS FOR IMPOSING DISCI-
44 PLINE. "STATE PRACTICE LAWS" DOES NOT INCLUDE THE INITIAL QUALIFICATIONS
45 FOR LICENSURE OR REQUIREMENTS NECESSARY TO OBTAIN AND RETAIN A LICENSE,
46 EXCEPT FOR QUALIFICATIONS OR REQUIREMENTS OF THE HOME STATE.

47 ARTICLE III.

48 GENERAL PROVISIONS AND JURISDICTION

49 (A) A LICENSE TO PRACTICE REGISTERED NURSING ISSUED BY A HOME STATE TO
50 A RESIDENT IN THAT STATE WILL BE RECOGNIZED BY EACH PARTY STATE AS
51 AUTHORIZING A MULTISTATE LICENSURE PRIVILEGE TO PRACTICE AS A REGISTERED
52 NURSE IN SUCH PARTY STATE. A LICENSE TO PRACTICE LICENSED
53 PRACTICAL/VOCATIONAL NURSING ISSUED BY A HOME STATE TO A RESIDENT IN
54 THAT STATE WILL BE RECOGNIZED BY EACH PARTY STATE AS AUTHORIZING A

1 MULTISTATE LICENSURE PRIVILEGE TO PRACTICE AS A LICENSED
2 PRACTICAL/VOCATIONAL NURSE IN SUCH PARTY STATE. IN ORDER TO OBTAIN OR
3 RETAIN A LICENSE, AN APPLICANT MUST MEET THE HOME STATE'S QUALIFICATIONS
4 FOR LICENSURE AND LICENSE RENEWAL AS WELL AS ALL OTHER APPLICABLE STATE
5 LAWS.

6 (B) PARTY STATES MAY, IN ACCORDANCE WITH STATE DUE PROCESS LAWS, LIMIT
7 OR REVOKE THE MULTISTATE LICENSURE PRIVILEGE OF ANY NURSE TO PRACTICE IN
8 THEIR STATE AND MAY TAKE ANY OTHER ACTIONS UNDER THEIR APPLICABLE STATE
9 LAWS NECESSARY TO PROTECT THE HEALTH AND SAFETY OF THEIR CITIZENS. IF A
10 PARTY STATE TAKES SUCH ACTION, IT SHALL PROMPTLY NOTIFY THE ADMINISTRA-
11 TOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM. THE ADMINISTRATOR
12 OF THE COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY NOTIFY
13 THE HOME STATE OF ANY SUCH ACTIONS BY REMOTE STATES.

14 (C) EVERY NURSE PRACTICING IN A PARTY STATE MUST COMPLY WITH THE STATE
15 PRACTICE LAWS OF THE STATE IN WHICH THE PATIENT IS LOCATED AT THE TIME
16 CARE IS RENDERED. IN ADDITION, THE PRACTICE OF NURSING IS NOT LIMITED
17 TO PATIENT CARE, BUT SHALL INCLUDE ALL NURSING PRACTICE AS DEFINED BY
18 THE STATE PRACTICE LAWS OF A PARTY STATE. THE PRACTICE OF NURSING WILL
19 SUBJECT A NURSE TO THE JURISDICTION OF THE NURSE LICENSING BOARD AND THE
20 COURTS, AS WELL AS THE LAWS, IN THAT PARTY STATE.

21 (D) THIS COMPACT DOES NOT AFFECT ADDITIONAL REQUIREMENTS IMPOSED BY
22 STATES FOR ADVANCED PRACTICE REGISTERED NURSING. HOWEVER, A MULTISTATE
23 LICENSURE PRIVILEGE TO PRACTICE REGISTERED NURSING GRANTED BY A PARTY
24 STATE SHALL BE RECOGNIZED BY OTHER PARTY STATES AS A LICENSE TO PRACTICE
25 REGISTERED NURSING IF ONE IS REQUIRED BY STATE LAW AS A PRECONDITION FOR
26 QUALIFYING FOR ADVANCED PRACTICE REGISTERED NURSE AUTHORIZATION.

27 (E) INDIVIDUALS NOT RESIDING IN A PARTY STATE SHALL CONTINUE TO BE
28 ABLE TO APPLY FOR NURSE LICENSURE AS PROVIDED FOR UNDER THE LAWS OF EACH
29 PARTY STATE. HOWEVER, THE LICENSE GRANTED TO THESE INDIVIDUALS WILL NOT
30 BE RECOGNIZED AS GRANTING THE PRIVILEGE TO PRACTICE NURSING IN ANY OTHER
31 PARTY STATE UNLESS EXPLICITLY AGREED TO BY THAT PARTY STATE.

32 ARTICLE IV.

33 APPLICATIONS FOR LICENSURE IN A PARTY STATE

34 (A) UPON APPLICATION FOR A LICENSE, THE LICENSING BOARD IN A PARTY
35 STATE SHALL ASCERTAIN, THROUGH THE COORDINATED LICENSURE INFORMATION
36 SYSTEM, WHETHER THE APPLICANT HAS EVER HELD, OR IS THE HOLDER OF, A
37 LICENSE ISSUED BY ANY OTHER STATE, WHETHER THERE ARE ANY RESTRICTIONS ON
38 THE MULTISTATE LICENSURE PRIVILEGE, AND WHETHER ANY OTHER ADVERSE ACTION
39 BY ANY STATE HAS BEEN TAKEN AGAINST THE LICENSE.

40 (B) A NURSE IN A PARTY STATE SHALL HOLD LICENSURE IN ONLY ONE PARTY
41 STATE AT A TIME ISSUED BY THE HOME STATE.

42 (C) A NURSE WHO INTENDS TO CHANGE PRIMARY STATE OF RESIDENCE MAY APPLY
43 FOR LICENSURE IN THE NEW HOME STATE IN ADVANCE OF SUCH CHANGE. HOWEVER,
44 NEW LICENSES WILL NOT BE ISSUED BY A PARTY STATE UNTIL AFTER A NURSE
45 PROVIDES EVIDENCE OF CHANGE IN PRIMARY STATE OF RESIDENCE SATISFACTORY
46 TO THE NEW HOME STATE'S LICENSING BOARD.

47 (D) WHEN A NURSE CHANGES PRIMARY STATE OF RESIDENCE BY:

48 (1) MOVING BETWEEN TWO PARTY STATES, AND OBTAINS A LICENSE FROM THE
49 NEW HOME STATE, THE LICENSE FROM THE FORMER HOME STATE IS NO LONGER
50 VALID;

51 (2) MOVING FROM A NON-PARTY STATE TO A PARTY STATE, AND OBTAINS A
52 LICENSE FROM THE NEW HOME STATE, THE INDIVIDUAL STATE LICENSE ISSUED BY
53 THE NON-PARTY STATE IS NOT AFFECTED AND WILL REMAIN IN FULL FORCE IF SO
54 PROVIDED BY THE LAWS OF THE NON-PARTY STATE;

1 (3) MOVING FROM A PARTY STATE TO A NON-PARTY STATE, THE LICENSE ISSUED
2 BY THE PRIOR HOME STATE CONVERTS TO AN INDIVIDUAL STATE LICENSE, VALID
3 ONLY IN THE FORMER HOME STATE, WITHOUT THE MULTISTATE LICENSURE PRIVI-
4 LEGE TO PRACTICE IN OTHER PARTY STATES.

5 ARTICLE V.
6 ADVERSE ACTIONS

7 IN ADDITION TO THE GENERAL PROVISIONS DESCRIBED IN ARTICLE III, THE
8 FOLLOWING PROVISIONS APPLY:

9 (A) THE LICENSING BOARD OF A REMOTE STATE SHALL PROMPTLY REPORT TO THE
10 ADMINISTRATOR OF THE COORDINATED LICENSURE INFORMATION SYSTEM ANY REMOTE
11 STATE ACTIONS INCLUDING THE FACTUAL AND LEGAL BASIS FOR SUCH ACTION, IF
12 KNOWN. THE LICENSING BOARD OF A REMOTE STATE SHALL ALSO PROMPTLY REPORT
13 ANY SIGNIFICANT CURRENT INVESTIGATIVE INFORMATION YET TO RESULT IN A
14 REMOTE STATE ACTION. THE ADMINISTRATOR OF THE COORDINATED LICENSURE
15 INFORMATION SYSTEM SHALL PROMPTLY NOTIFY THE HOME STATE OF ANY SUCH
16 REPORTS.

17 (B) THE LICENSING BOARD OF A PARTY STATE SHALL HAVE THE AUTHORITY TO
18 COMPLETE ANY PENDING INVESTIGATIONS FOR A NURSE WHO CHANGES PRIMARY
19 STATE OF RESIDENCE DURING THE COURSE OF SUCH INVESTIGATIONS. IT SHALL
20 ALSO HAVE THE AUTHORITY TO TAKE APPROPRIATE ACTION(S), AND SHALL PROMPT-
21 LY REPORT THE CONCLUSIONS OF SUCH INVESTIGATIONS TO THE ADMINISTRATOR OF
22 THE COORDINATED LICENSURE INFORMATION SYSTEM. THE ADMINISTRATOR OF THE
23 COORDINATED LICENSURE INFORMATION SYSTEM SHALL PROMPTLY NOTIFY THE NEW
24 HOME STATE OF ANY SUCH ACTIONS.

25 (C) A REMOTE STATE MAY TAKE ADVERSE ACTION AFFECTING THE MULTISTATE
26 LICENSURE PRIVILEGE TO PRACTICE WITHIN THAT PARTY STATE. HOWEVER, ONLY
27 THE HOME STATE SHALL HAVE THE POWER TO IMPOSE ADVERSE ACTION AGAINST THE
28 LICENSE ISSUED BY THE HOME STATE.

29 (D) FOR PURPOSES OF IMPOSING ADVERSE ACTION, THE LICENSING BOARD OF
30 THE HOME STATE SHALL GIVE THE SAME PRIORITY AND EFFECT TO REPORTED
31 CONDUCT RECEIVED FROM A REMOTE STATE AS IT WOULD IF SUCH CONDUCT HAD
32 OCCURRED WITHIN THE HOME STATE. IN SO DOING, IT SHALL APPLY ITS OWN
33 STATE LAWS TO DETERMINE APPROPRIATE ACTION.

34 (E) THE HOME STATE MAY TAKE ADVERSE ACTION BASED ON THE FACTUAL FIND-
35 INGS OF THE REMOTE STATE, SO LONG AS EACH STATE FOLLOWS ITS OWN PROCE-
36 DURES FOR IMPOSING SUCH ADVERSE ACTION.

37 (F) NOTHING IN THIS COMPACT SHALL OVERRIDE A PARTY STATE'S DECISION
38 THAT PARTICIPATION IN AN ALTERNATIVE PROGRAM MAY BE USED IN LIEU OF
39 LICENSURE ACTION AND THAT SUCH PARTICIPATION SHALL REMAIN NON-PUBLIC IF
40 REQUIRED BY THE PARTY STATE'S LAWS. PARTY STATES MUST REQUIRE NURSES
41 WHO ENTER ANY ALTERNATIVE PROGRAMS TO AGREE NOT TO PRACTICE IN ANY OTHER
42 PARTY STATE DURING THE TERM OF THE ALTERNATIVE PROGRAM WITHOUT PRIOR
43 AUTHORIZATION FROM SUCH OTHER PARTY STATE.

44 ARTICLE VI.
45 ADDITIONAL AUTHORITIES INVESTED IN PARTY STATE NURSE LICENSING BOARDS

46 NOTWITHSTANDING ANY OTHER POWERS, PARTY STATE NURSE LICENSING BOARDS
47 SHALL HAVE THE AUTHORITY TO:

48 (A) IF OTHERWISE PERMITTED BY STATE LAW, RECOVER FROM THE AFFECTED
49 NURSE THE COSTS OF INVESTIGATIONS AND DISPOSITION OF CASES RESULTING
50 FROM ANY ADVERSE ACTION TAKEN AGAINST THAT NURSE;

51 (B) ISSUE SUBPOENAS FOR BOTH HEARINGS AND INVESTIGATIONS WHICH REQUIRE
52 THE ATTENDANCE AND TESTIMONY OF WITNESSES, AND THE PRODUCTION OF

1 EVIDENCE. SUBPOENAS ISSUED BY A NURSE LICENSING BOARD IN A PARTY STATE
2 FOR THE ATTENDANCE AND TESTIMONY OF WITNESSES, AND/OR THE PRODUCTION OF
3 EVIDENCE FROM ANOTHER PARTY STATE, SHALL BE ENFORCED IN THE LATTER STATE
4 BY ANY COURT OF COMPETENT JURISDICTION, ACCORDING TO THE PRACTICE AND
5 PROCEDURE OF THAT COURT APPLICABLE TO SUBPOENAS ISSUED IN PROCEEDINGS
6 PENDING BEFORE IT. THE ISSUING AUTHORITY SHALL PAY ANY WITNESS FEES,
7 TRAVEL EXPENSES, MILEAGE AND OTHER FEES REQUIRED BY THE SERVICE STATUTES
8 OF THE STATE WHERE THE WITNESSES AND/OR EVIDENCE ARE LOCATED.

9 (C) ISSUE CEASE AND DESIST ORDERS TO LIMIT OR REVOKE A NURSE'S AUTHOR-
10 ITY TO PRACTICE IN THEIR STATE;

11 (D) PROMULGATE UNIFORM RULES AND REGULATIONS AS PROVIDED FOR IN ARTI-
12 CLE VIII(C).

13 ARTICLE VII.

14 COORDINATED LICENSURE INFORMATION SYSTEM

15 (A) ALL PARTY STATES SHALL PARTICIPATE IN A COOPERATIVE EFFORT TO
16 CREATE A COORDINATED DATA BASE OF ALL LICENSED REGISTERED NURSES AND
17 LICENSED PRACTICAL/VOCATIONAL NURSES. THIS SYSTEM SHALL INCLUDE INFORMA-
18 TION ON THE LICENSURE AND DISCIPLINARY HISTORY OF EACH NURSE, AS
19 CONTRIBUTED BY PARTY STATES, TO ASSIST IN THE COORDINATION OF NURSE
20 LICENSURE AND ENFORCEMENT EFFORTS.

21 (B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ALL PARTY STATES'
22 LICENSING BOARDS SHALL PROMPTLY REPORT ADVERSE ACTIONS, ACTIONS AGAINST
23 MULTISTATE LICENSURE PRIVILEGES, ANY CURRENT SIGNIFICANT INVESTIGATIVE
24 INFORMATION YET TO RESULT IN ADVERSE ACTION, DENIALS OF APPLICATIONS,
25 AND THE REASONS FOR SUCH DENIALS, TO THE COORDINATED LICENSURE INFORMA-
26 TION SYSTEM.

27 (C) CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION SHALL BE TRANSMITTED
28 THROUGH THE COORDINATED LICENSURE INFORMATION SYSTEM ONLY TO PARTY STATE
29 LICENSING BOARDS.

30 (D) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, ALL PARTY STATES'
31 LICENSING BOARDS CONTRIBUTING INFORMATION TO THE COORDINATED LICENSURE
32 INFORMATION SYSTEM MAY DESIGNATE INFORMATION THAT MAY NOT BE SHARED WITH
33 NON-PARTY STATES OR DISCLOSED TO OTHER ENTITIES OR INDIVIDUALS WITHOUT
34 THE EXPRESS PERMISSION OF THE CONTRIBUTING STATE.

35 (E) ANY PERSONALLY IDENTIFIABLE INFORMATION OBTAINED BY A PARTY
36 STATES' LICENSING BOARD FROM THE COORDINATED LICENSURE INFORMATION
37 SYSTEM MAY NOT BE SHARED WITH NON-PARTY STATES OR DISCLOSED TO OTHER
38 ENTITIES OR INDIVIDUALS EXCEPT TO THE EXTENT PERMITTED BY THE LAWS OF
39 THE PARTY STATE CONTRIBUTING THE INFORMATION.

40 (F) ANY INFORMATION CONTRIBUTED TO THE COORDINATED LICENSURE INFORMA-
41 TION SYSTEM THAT IS SUBSEQUENTLY REQUIRED TO BE EXPUNGED BY THE LAWS OF
42 THE PARTY STATE CONTRIBUTING THAT INFORMATION, SHALL ALSO BE EXPUNGED
43 FROM THE COORDINATED LICENSURE INFORMATION SYSTEM.

44 (G) THE COMPACT ADMINISTRATORS, ACTING JOINTLY WITH EACH OTHER AND IN
45 CONSULTATION WITH THE ADMINISTRATOR OF THE COORDINATED LICENSURE INFOR-
46 MATION SYSTEM, SHALL FORMULATE NECESSARY AND PROPER PROCEDURES FOR THE
47 IDENTIFICATION, COLLECTION AND EXCHANGE OF INFORMATION UNDER THIS
48 COMPACT.

49 ARTICLE VIII.

50 COMPACT ADMINISTRATION AND INTERCHANGE OF INFORMATION

1 (A) THE HEAD OF THE NURSE LICENSING BOARD, OR HIS OR HER DESIGNEE, OF
2 EACH PARTY STATE SHALL BE THE ADMINISTRATOR OF THIS COMPACT FOR HIS OR
3 HER STATE.

4 (B) THE COMPACT ADMINISTRATOR OF EACH PARTY STATE SHALL FURNISH TO THE
5 COMPACT ADMINISTRATOR OF EACH OTHER PARTY STATE ANY INFORMATION AND
6 DOCUMENTS INCLUDING, BUT NOT LIMITED TO, A UNIFORM DATA SET OF INVESTI-
7 GATIONS, IDENTIFYING INFORMATION, LICENSURE DATA AND DISCLOSABLE ALTER-
8 NATIVE PROGRAM PARTICIPATION INFORMATION TO FACILITATE THE ADMINIS-
9 TRATION OF THIS COMPACT.

10 (C) COMPACT ADMINISTRATORS SHALL HAVE THE AUTHORITY TO DEVELOP UNIFORM
11 RULES TO FACILITATE AND COORDINATE IMPLEMENTATION OF THIS COMPACT. THESE
12 UNIFORM RULES SHALL BE ADOPTED BY PARTY STATES, UNDER THE AUTHORITY
13 INVESTED UNDER ARTICLE VI(D).

14 ARTICLE IX.
15 IMMUNITY

16 NO PARTY STATE OR THE OFFICERS OR EMPLOYEES OR AGENTS OF A PARTY
17 STATE'S NURSE LICENSING BOARD WHO ACTS IN ACCORDANCE WITH THE PROVISIONS
18 OF THIS COMPACT SHALL BE LIABLE ON ACCOUNT OF ANY ACT OR OMISSION IN
19 GOOD FAITH WHILE ENGAGED IN THE PERFORMANCE OF THEIR DUTIES UNDER THIS
20 COMPACT. GOOD FAITH IN THIS ARTICLE SHALL NOT INCLUDE WILLFUL MISCON-
21 DUCT, GROSS NEGLIGENCE OR RECKLESSNESS.

22 ARTICLE X.
23 ENTRY INTO FORCE, WITHDRAWAL, AND AMENDMENT

24 (A) THIS COMPACT SHALL ENTER INTO FORCE AND BECOME EFFECTIVE AS TO ANY
25 STATE WHEN IT HAS BEEN ENACTED INTO THE LAWS OF THAT STATE. ANY PARTY
26 STATE MAY WITHDRAW FROM THIS COMPACT BY ENACTING A STATUTE REPEALING THE
27 SAME, BUT NO SUCH WITHDRAWAL SHALL TAKE EFFECT UNTIL SIX MONTHS AFTER
28 THE WITHDRAWING STATE HAS GIVEN NOTICE OF THE WITHDRAWAL TO THE EXECU-
29 TIVE HEADS OF ALL OTHER PARTY STATES.

30 (B) NO WITHDRAWAL SHALL AFFECT THE VALIDITY OR APPLICABILITY BY THE
31 LICENSING BOARDS OF STATES REMAINING PARTY TO THE COMPACT OF ANY REPORT
32 OF ADVERSE ACTION OCCURRING PRIOR TO THE WITHDRAWAL.

33 (C) NOTHING CONTAINED IN THIS COMPACT SHALL BE CONSTRUED TO INVALIDATE
34 OR PREVENT ANY NURSE LICENSURE AGREEMENT OR OTHER COOPERATIVE ARRANGE-
35 MENT BETWEEN A PARTY STATE AND A NON-PARTY STATE THAT IS MADE IN ACCORD-
36 ANCE WITH THE OTHER PROVISIONS OF THIS COMPACT.

37 (D) THIS COMPACT MAY BE AMENDED BY THE PARTY STATES. NO AMENDMENT TO
38 THIS COMPACT SHALL BECOME EFFECTIVE AND BINDING UPON THE PARTY STATES
39 UNLESS AND UNTIL IT IS ENACTED INTO THE LAWS OF ALL PARTY STATES.

40 ARTICLE XI.
41 CONSTRUCTION AND SEVERABILITY

42 (A) THIS COMPACT SHALL BE LIBERALLY CONSTRUED SO AS TO EFFECTUATE THE
43 PURPOSES THEREOF. THE PROVISIONS OF THIS COMPACT SHALL BE SEVERABLE AND
44 IF ANY PHRASE, CLAUSE, SENTENCE OR PROVISION OF THIS COMPACT IS DECLARED
45 TO BE CONTRARY TO THE CONSTITUTION OF ANY PARTY STATE OR OF THE UNITED
46 STATES OR THE APPLICABILITY THEREOF TO ANY GOVERNMENT, AGENCY, PERSON OR
47 CIRCUMSTANCE IS HELD INVALID, THE VALIDITY OF THE REMAINDER OF THIS
48 COMPACT AND THE APPLICABILITY THEREOF TO ANY GOVERNMENT, AGENCY, PERSON
49 OR CIRCUMSTANCE SHALL NOT BE AFFECTED THEREBY. IF THIS COMPACT SHALL BE
50 HELD CONTRARY TO THE CONSTITUTION OF ANY STATE PARTY THERETO, THE

1 COMPACT SHALL REMAIN IN FULL FORCE AND EFFECT AS TO THE REMAINING PARTY
2 STATES AND IN FULL FORCE AND EFFECT AS TO THE PARTY STATE AFFECTED AS TO
3 ALL SEVERABLE MATTERS.

4 (B) IN THE EVENT PARTY STATES FIND A NEED FOR SETTLING DISPUTES ARISING
5 UNDER THIS COMPACT:

6 (1) THE PARTY STATES MAY SUBMIT THE ISSUES IN DISPUTE TO AN ARBITRATION
7 PANEL WHICH WILL BE COMPRISED OF AN INDIVIDUAL APPOINTED BY THE
8 COMPACT ADMINISTRATOR IN THE HOME STATE; AN INDIVIDUAL APPOINTED BY THE
9 COMPACT ADMINISTRATOR IN THE REMOTE STATE(S) INVOLVED; AND AN INDIVIDUAL
10 MUTUALLY AGREED UPON BY THE COMPACT ADMINISTRATORS OF ALL THE PARTY
11 STATES INVOLVED IN THE DISPUTE.

12 (2) THE DECISION OF A MAJORITY OF THE ARBITRATORS SHALL BE FINAL AND
13 BINDING.

14 2. FOR THE PURPOSES OF THE COMPACT SET FORTH IN SUBDIVISION ONE OF
15 THIS SECTION THE "HEAD OF THE NURSE LICENSING BOARD" FOR THIS STATE
16 SHALL BE THE SECRETARY TO THE STATE BOARD FOR NURSING.

17 3. TO FACILITATE CROSS-STATE ENFORCEMENT EFFORTS, THIS STATE SHALL
18 HAVE THE POWER TO RECOVER FROM THE AFFECTED NURSE THE COSTS OF INVESTI-
19 GATIONS AND DISPOSITION OF CASES RESULTING FROM ADVERSE ACTIONS TAKEN BY
20 THIS STATE AGAINST THAT NURSE.

21 4. THIS COMPACT IS DESIGNED TO FACILITATE THE REGULATION OF NURSES AND
22 DOES NOT RELIEVE EMPLOYERS FROM COMPLYING WITH OBLIGATIONS IMPOSED BY
23 LAW OR REGULATION.

24 5. THIS COMPACT DOES NOT SUPERSEDE EXISTING LABOR LAWS.

25 6. TO FACILITATE WORKFORCE PLANNING, THE COMMISSIONER IS AUTHORIZED TO
26 COLLECT EMPLOYMENT DATA ON NURSES PRACTICING ON THE MULTI-PRIVILEGE IN
27 THE NURSE LICENSURE COMPACT PROVIDED THAT THE SUBMISSION OF THIS DATA IS
28 NOT A REQUIREMENT FOR PRACTICE UNDER THE MULTI-STATE PRIVILEGE.

29 S 2. This act shall take effect on the ninetieth day after it shall
30 have become a law; provided, however, that effective immediately, the
31 addition, amendment and/or repeal of any rule or regulation necessary
32 for the implementation of this act on its effective date are authorized
33 and directed to be made and completed on or before such effective date.

34 PART D

35 Section 1. Section 6501 of the education law, as amended by chapter 81
36 of the laws of 1995, is amended to read as follows:

37 S 6501. Admission to a profession (licensing). Admission to practice
38 of a profession in this state is accomplished by a license being issued
39 to a qualified applicant by the education department. To qualify for a
40 license an applicant shall meet the requirements prescribed in the arti-
41 cle for the particular profession and shall meet the requirements
42 prescribed in section 3-503 of the general obligations law; PROVIDED
43 THAT, NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, ANY APPLI-
44 CANT WHO IS THE SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED
45 STATES, NATIONAL GUARD OR RESERVES MAY SUBMIT SATISFACTORY EVIDENCE OF
46 LICENSURE TO PRACTICE AN EQUIVALENT OCCUPATION ISSUED BY ANY OTHER
47 STATE, TERRITORY, PROTECTORATE OR DEPENDENCY OF THE UNITED STATES IN
48 LIEU OF THE SUBMISSIONS REQUIRED BY THE ARTICLE OF THIS CHAPTER FOR THE
49 PARTICULAR PROFESSION, PROVIDED THAT SUCH LICENSE WAS GRANTED IN COMPLI-
50 ANCE WITH STANDARDS WHICH WERE, IN THE JUDGMENT OF THE BOARD OF REGENTS,
51 NOT LOWER THAN THOSE OF THIS STATE.

52 S 2. The general business law is amended by adding a new article 2-A
53 to read as follows:

ARTICLE 2-A

ADMISSION TO A PROFESSION

SECTION 20. ADMISSION TO A PROFESSION; LICENSING, CERTIFICATION OR REGISTRATION.

S 20. ADMISSION TO A PROFESSION; LICENSING, CERTIFICATION OR REGISTRATION. ADMISSION TO PRACTICE OF A PROFESSION GOVERNED BY THIS CHAPTER IN THIS STATE IS ACCOMPLISHED, WHERE REQUIRED, BY A LICENSE, CERTIFICATION OR CERTIFICATE OF REGISTRATION BEING ISSUED TO A QUALIFIED APPLICANT BY THE SECRETARY OF STATE. TO QUALIFY FOR A LICENSE, CERTIFICATION OR CERTIFICATE OF REGISTRATION AN APPLICANT SHALL MEET THE REQUIREMENTS PRESCRIBED IN THE ARTICLE FOR THE PARTICULAR PROFESSION AND SHALL MEET THE REQUIREMENTS PRESCRIBED IN SECTION 3-503 OF THE GENERAL OBLIGATIONS LAW; PROVIDED THAT, NOTWITHSTANDING ANY PROVISION OF THE LAW TO THE CONTRARY, ANY APPLICANT WHO IS THE SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED STATES, NATIONAL GUARD OR RESERVES MAY SUBMIT SATISFACTORY EVIDENCE OF LICENSURE, CERTIFICATION OR REGISTRATION TO PRACTICE AN EQUIVALENT OCCUPATION ISSUED BY ANY OTHER STATE, TERRITORY, PROTECTORATE OR DEPENDENCY OF THE UNITED STATES IN LIEU OF THE SUBMISSIONS REQUIRED BY THE ARTICLE OF THIS CHAPTER FOR THE PARTICULAR PROFESSION, PROVIDED THAT SUCH LICENSE, CERTIFICATION OR CERTIFICATE OF REGISTRATION WAS GRANTED IN COMPLIANCE WITH STANDARDS WHICH WERE, IN THE JUDGMENT OF THE SECRETARY, NOT LOWER THAN THOSE OF THIS STATE.

S 3. Subdivision (d) of section 2136 of the insurance law, as added by chapter 687 of the laws of 2003, is amended to read as follows:

(d) (1) the applicant's home state awards nonresident insurance producer licenses to residents of this state on the same basis as provided in this subsection; OR

(2) THE APPLICANT IS THE SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED STATES, NATIONAL GUARD OR RESERVES.

S 4. Section 442-g of the real property law is amended by adding a new subdivision 1-a to read as follows:

1-A. NO NONRESIDENT APPLICANT WHO IS THE SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED STATES, NATIONAL GUARD, OR RESERVES REGULARLY ENGAGED IN THE REAL ESTATE BUSINESS AS A VOCATION, WHO MAINTAINS A DEFINITE PLACE OF BUSINESS AND IS LICENSED BY ANY OTHER STATE, TERRITORY, PROTECTORATE OR DEPENDENCY OF THE UNITED STATES, SHALL BE REQUIRED TO MAINTAIN A PLACE OF BUSINESS WITHIN THIS STATE. THE COMMISSION SHALL RECOGNIZE THE LICENSE ISSUED BY ANOTHER STATE TO AN APPLICANT WHO IS THE SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED STATES, NATIONAL GUARD, OR RESERVES AS QUALIFICATION FOR A LICENSE IN NEW YORK, PROVIDED THAT SUCH LICENSE WAS GRANTED IN COMPLIANCE WITH STANDARDS WHICH WERE, IN THE JUDGMENT OF THE SECRETARY, NOT LOWER THAN THOSE OF THIS STATE.

S 5. Section 444-e of the real property law is amended by adding a new subdivision 2-a to read as follows:

2-A. ANY APPLICANT FOR A LICENSE WHO IS A SPOUSE OF A MEMBER OF THE ARMED FORCES OF THE UNITED STATES, NATIONAL GUARD OR RESERVES MAY SUBMIT SATISFACTORY EVIDENCE OF LICENSURE TO PRACTICE AN EQUIVALENT OCCUPATION ISSUED BY ANY OTHER STATE, TERRITORY, PROTECTORATE OR DEPENDENCY OF THE UNITED STATES IN LIEU OF THE EVIDENCE OF EDUCATION, EXPERIENCE AND EXAMINATION REQUIRED BY SUBDIVISION ONE OF THIS SECTION, PROVIDED THAT SUCH LICENSE WAS GRANTED IN COMPLIANCE WITH STANDARDS WHICH WERE, IN THE JUDGMENT OF THE SECRETARY, NOT LOWER THAN THOSE OF THIS STATE.

S 6. This act shall take effect on the ninetieth day after it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary

1 for the implementation of this act on its effective date are authorized
2 and directed to be made and completed on or before such effective date.

3 S 2. Severability clause. If any clause, sentence, paragraph, subdivi-
4 sion, section or part of this act shall be adjudged by any court of
5 competent jurisdiction to be invalid, such judgment shall not affect,
6 impair, or invalidate the remainder thereof, but shall be confined in
7 its operation to the clause, sentence, paragraph, subdivision, section
8 or part thereof directly involved in the controversy in which such judg-
9 ment shall have been rendered. It is hereby declared to be the intent of
10 the legislature that this act would have been enacted even if such
11 invalid provisions had not been included herein.

12 S 3. This act shall take effect immediately; provided, however, that
13 the applicable effective date of Parts A through D of this act shall be
14 as specifically set forth in the last section of such Parts.
