AN ACT to amend the insurance law, in relation to losses sustained as a
result of intoxication

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY,
DO ENACT AS FOLLOWS:

1 Section 1. Paragraph 2 of subsection (b) of section 5103 of the insurance law is amended to read as follows:

3 (2) Is injured as a result of operating a motor vehicle while in an
4 intoxicated condition or while his ability to operate such vehicle is
5 impaired by the use of a drug within the meaning of section eleven
6 hundred ninety-two of the vehicle and traffic law; PROVIDED, HOWEVER,
7 THAT AN INSURER SHALL NOT EXCLUDE SUCH PERSON FROM COVERAGE WITH RESPECT
8 TO NECESSARY EMERGENCY HEALTH SERVICES RENDERED IN A GENERAL HOSPITAL,
9 AS DEFINED IN SUBDIVISION TEN OF SECTION TWO THOUSAND EIGHT HUNDRED ONE
10 OF THE PUBLIC HEALTH LAW, INCLUDING AMBULANCE SERVICES ATTENDANT THERETO
11 AND RELATED MEDICAL SCREENING. NOTWITHSTANDING ANY OTHER LAW, WHERE THE
12 COVERED PERSON IS FOUND TO HAVE VIOLATED SECTION ELEVEN HUNDRED NINETY-
13 TWO OF THE VEHICLE AND TRAFFIC LAW, THE INSURER HAS A CAUSE OF ACTION
14 FOR THE AMOUNT OF FIRST PARTY BENEFITS PAID OR PAYABLE ON BEHALF OF SUCH
15 COVERED PERSON AGAINST SUCH COVERED PERSON.
16 S 2. This act shall take effect on the one hundred eightieth day after
17 it shall have become a law and shall apply to all policies issued,
18 renewed, modified, altered or amended on or after such date.
