AN ACT to amend the vehicle and traffic law, in relation to creating a waiver for intrastate operation for deaf persons

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 502 of the vehicle and traffic law is amended by 2 adding a new subdivision 1-a to read as follows:

3 1-A. WAIVER FOR INTRASTATE OPERATION. (A) NOTWITHSTANDING ANY OTHER SUBDIVISION OF THIS SECTION, A DRIVER WHO IS CURRENTLY THE HOLDER OF A 4 VALID COMMERCIAL DRIVER'S LICENSE OR PERMIT AND WHO OPERATES INTRASTATE 5 6 EXCLUSIVELY IN A COMMERCIAL MOTOR VEHICLE REOUIRING A COMMERCIAL DRIV-7 ER'S LICENSE TO OPERATE, WHO HAS OTHERWISE MET THE REQUIREMENTS AS SET FORTH IN PUBLIC LAW 99-570, TITLE XII, AND TITLE 8 49 OF THE CODE OF FEDERAL REGULATIONS, AND ALL REGULATIONS PROMULGATED 9 BY THE UNITED 10 STATES SECRETARY OF TRANSPORTATION UNDER THE HAZARDOUS MATERIALS TRANS-11 PORTATION ACT, MAY, UPON RENEWAL OF SUCH LICENSE, OBTAIN A PERMANENT WAIVER FOR THE HEARING REQUIREMENT OF THE PHYSICAL EXAMINATION AS 12 SET FORTH IN 49 CFR 391.41(B)(11) WHICH SHALL EXEMPT THE DRIVER FROM THE 13 14 HEARING REQUIREMENT OF SUCH PHYSICAL EXAMINATION WHILE THE DRIVER IS A HOLDER OF A VALID COMMERCIAL DRIVER'S LICENSE OR PERMIT. 15 PERSONS WHO HAVE RECEIVED SUCH WAIVER SHALL NOT BE REQUIRED TO WEAR A HEARING AID. 16

17 (B) SUCH WAIVER SHALL BE OF SUCH DESIGN AND TYPE AS THE COMMISSIONER 18 AND THE NEW YORK STATE INTERAGENCY COORDINATING COUNCIL FOR SERVICES TO 19 PERSONS WHO ARE DEAF, DEAF-BLIND, OR HARD OF HEARING SHALL DEEM TO BE 20 SUITABLE AND APPROPRIATE FOR THE PURPOSES THEREOF AND SHALL BE:

21 (I) VALID WHILE THE DRIVER IS THE HOLDER OF A VALID COMMERCIAL DRIV-22 ER'S LICENSE OR PERMIT;

23 (II) KEPT ON FILE WITH THE DEPARTMENT;

24 (III) KEPT BY AND MADE READILY AVAILABLE BY THE HOLDER OF THE COMMER-25 CIAL DRIVER'S LICENSE; AND

26 (IV) KEPT ON FILE BY THE MOTOR CARRIER EMPLOYING THE DRIVER.

27 S 2. This act shall take effect on the one hundred eightieth day after 28 it shall have become a law.
