- AN ACT to amend the election law, in relation to providing that campaign accounts be transferred to the state treasury upon death of a candidate

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The election law is amended by adding a new section 14-131 2 to read as follows:

- 3 14-131. REQUIRED DISPOSAL OF CAMPAIGN FUNDS. 1. UPON THE DEATH OF A S 4 CANDIDATE, FORMER CANDIDATE OR HOLDER OF ELECTIVE OFFICE, WHO RECEIVED CAMPAIGN CONTRIBUTIONS, ANY MONEYS REMAINING IN THE ACCOUNT OF A POLI-5 б TICAL COMMITTEE FORMED FOR THE PURPOSE OF PROMOTING OR ELECTING SUCH NOT OTHERWISE DUE AND OWED TO ANY PARTY SHALL BE PAID OVER TO 7 CANDIDATE THE COMPTROLLER OF THE STATE OF NEW YORK FOR DEPOSIT 8 IN THE GENERAL 9 TREASURY OF THE STATE.
- 10 2. THE TREASURER OF A POLITICAL COMMITTEE SHALL NOTIFY THE STATE BOARD 11 OF ELECTIONS UPON THE DEATH OF A CANDIDATE, FORMER CANDIDATE OR HOLDER 12 OF ELECTIVE OFFICE. SUCH NOTICE SHALL BE FILED IN THE OFFICE IN WHICH 13 THE COMMITTEE IS REQUIRED TO FILE STATEMENTS UNDER SECTION 14-110 OF 14 THIS ARTICLE, WITHIN THIRTY DAYS OF THE DEATH OF SUCH PERSON.
- 15 3. NOTWITHSTANDING SUBDIVISION ONE OF THIS SECTION, A CANDIDATE, CANDIDATE OR HOLDER OF ELECTIVE OFFICE MAY, AT ANY TIME, DESIG-16 FORMER NATE A CHARITABLE ORGANIZATION TO RECEIVE 17 THE BALANCE OF ANY MONEYS 18 REMAINING IN THE ACCOUNT OF A POLITICAL COMMITTEE FORMED FOR THE PURPOSE 19 OF PROMOTING OR ELECTING SUCH CANDIDATE UPON THE DEATH OF SUCH PERSON BY 20 FILING A NOTICE TO THAT EFFECT WITH THE STATE BOARD OF ELECTIONS. THE STATE BOARD OF ELECTIONS SHALL DEVELOP A FORM FOR SUCH PURPOSE. 21 IF A CHARITABLE ORGANIZATION DESIGNATED BY A CANDIDATE UNDER THIS SECTION IS 22 NO LONGER IN EXISTENCE UPON THE DEATH OF SUCH PERSON THEN SUCH REMAINING 23 24 MONEYS SHALL BE PAID INTO THE GENERAL TREASURY OF THE STATE IN ACCORD-25 ANCE WITH THIS SECTION.
- 26 S 2. This act shall take effect on the sixtieth day after it shall 27 have become a law; provided, however, that this act shall apply to
