AN ACT to amend the public buildings law and the public health law, in
relation to automated external defibrillators

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY,
DO ENACT AS FOLLOWS:

1 Section 1. Section 3 of the public buildings law is amended by adding
2 a new subdivision 16 to read as follows:
3 16. IN CITIES WITH A POPULATION OF OVER ONE MILLION, EQUIP, MAINTAIN
4 AND PROVIDE AUTOMATED EXTERNAL DEFIBRILLATOR EQUIPMENT, AS DEFINED IN
5 PARAGRAPH (A) OF SUBDIVISION ONE OF SECTION THREE THOUSAND-B OF THE
6 PUBLIC HEALTH LAW, IN QUANTITIES DEEMED ADEQUATE BY THE DEPARTMENT. SUCH
7 EQUIPMENT SHALL BE READILY ACCESSIBLE FOR USE DURING MEDICAL EMERGEN-
8 CIES. ANY INFORMATION DEEMED NECESSARY BY THE COMMISSIONER SHALL ACCOM-
9 PANY SUCH EQUIPMENT. THE COMMISSIONER SHALL ESTABLISH TRAINING COURSES
10 BY A NATIONALLY-RECOGNIZED ORGANIZATION, AS DEFINED IN PARAGRAPH (D) OF
11 SUBDIVISION ONE OF SECTION THREE THOUSAND-B OF THE PUBLIC HEALTH LAW,
12 FOR THOSE INDIVIDUALS WHOM THE COMMISSIONER DEEMS SHALL BE TRAINED IN
13 THE USE OF SUCH AUTOMATED EXTERNAL DEFIBRILLATOR EQUIPMENT.
14 S 2. The public health law is amended by adding a new section 3000-e
15 to read as follows:
16 S 3000-E. AUTOMATED EXTERNAL DEFIBRILLATORS; STADIUMS, ARENAS AND
17 CONVENTION CENTERS IN CITIES WITH A POPULATION OF OVER ONE MILLION. IN
18 CITIES WITH A POPULATION OF OVER ONE MILLION, ALL STADIUMS, ARENAS AND
19 CONVENTION CENTERS WITH OCCUPANCIES OF OVER FIVE THOUSAND SHALL BE
20 EQUIPPED WITH AND MAINTAIN AUTOMATED EXTERNAL DEFIBRILLATORS AS DEFINED
21 IN PARAGRAPH (A) OF SUBDIVISION ONE OF SECTION THREE THOUSAND-B OF THIS
22 ARTICLE. EMPLOYEES OF SUCH STADIUMS, ARENAS OR CONVENTION CENTERS SHALL
23 BE TRAINED BY A NATIONALLY-RECOGNIZED ORGANIZATION, AS DEFINED IN PARA-
24 GRAPH (D) OF SUBDIVISION ONE OF SECTION THREE THOUSAND-B OF THIS ARTI-

1 CLE. THE OWNERS OR OPERATORS OF SUCH STADIUMS, ARENAS OR CONVENTION
2 CENTERS SHALL PROVIDE SUCH AUTOMATED EXTERNAL DEFIBRILLATORS IN QUANTI-
3 TIES DEEMED NECESSARY BY THE COMMISSIONER. SUCH EQUIPMENT SHALL BE READ-
4 ILY ACCESSIBLE FOR USE DURING MEDICAL EMERGENCIES. ANY INFORMATION
5 DEEMED NECESSARY BY THE COMMISSIONER SHALL ACCOMPANY SUCH EQUIPMENT.
6 S 3. This act shall take effect on the one hundred eightieth day after
7 it shall have become a law; provided, however that effective immediate-
8 ly, the addition, amendment and/or repeal of any rule or regulation
9 necessary for the implementation of this act on its effective date are
10 authorized and directed to be made and completed on or before such
11 effective date.
