AN ACT to amend the penal law, in relation to establishing the crime of
unlawful dissemination of spyware

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The penal law is amended by adding a new section 156.40 to
2 read as follows:
3 S 156.40 UNLAWFUL DISSEMINATION OF SPYWARE.
4 1. A PERSON IS GUILTY OF UNLAWFUL DISSEMINATION OF SPYWARE WHEN HAVING
5 NO RIGHT TO DO SO, HE OR SHE INSTALLS AN EXECUTABLE COMPUTER PROGRAM,
6 INCLUDING BUT NOT LIMITED TO A KEYLOGGING PROGRAM, THAT EMPLOYS A
7 COMPUTER USER'S INTERNET CONNECTION WITHOUT THE COMPUTER USER'S KNOW-
8 LEDGE OR EXPLICIT AUTHORIZATION AND SUCH COMPUTER PROGRAM GATHERS AND
9 TRANSMITS PERSONAL INFORMATION OR DATA OF A COMPUTER USER.
10 2. AUTHORIZATION SHALL ONLY BE GRANTED BY THE OWNER OF A COMPUTER,
11 LESSOR OF A COMPUTER, OR, IF THE OWNER OR LESSOR OF A COMPUTER IS LESS
12 THAN EIGHTEEN YEARS OF AGE, BY THE PARENT OR GUARDIAN OF SUCH PERSON.
13 AUTHORIZATION MAY ALSO BE GRANTED BY AN END USER AGREEMENT THAT A PERSON
14 ESTABLISHED AS AN AUTHORIZED USER PURSUANT TO THIS SUBDIVISION HAS
15 AGREED TO UPON INSTALLATION OF A COMPUTER PROGRAM.
16 3. FOR PURPOSES OF THIS SECTION:
17 (A) "PERSONAL INFORMATION OR DATA" SHALL MEAN DATA THAT IDENTIFIES A
18 SPECIFIC PERSON, INCLUDING BUT NOT LIMITED TO FINANCIAL INFORMATION
19 INCLUDING BANKING AND CREDIT CARD ACCOUNT NUMBERS AND ANY INFORMATION
20 CONCERNING A PERSON WHICH, BECAUSE OF NAME, NUMBER, SYMBOL, MARK OR
21 OTHER IDENTIFIER CAN IDENTIFY SUCH PERSON; AND
22 (B) "KEYLOGGING COMPUTER PROGRAMS" MEANS COMPUTER PROGRAMS, INSTALLED
23 WITHOUT THE KNOWLEDGE OF THE COMPUTER USER, THAT SEND ELECTRONIC COMMU-
24 NICATIONS, THAT THE COMPUTER USER IS UNAWARE OF, FROM THE COMPUTER TO AN

1 UNAUTHORIZED USER. SUCH COMMUNICATIONS ARE COMPUTER FILES THAT DISPLAY
2 ALL OF THE KEY STROKES THAT A COMPUTER USER MAKES.
3 UNLAWFUL DISSEMINATION OF SPYWARE IS A CLASS A MISDEMEANOR, PROVIDED,
4 HOWEVER, THAT UNLAWFUL DISSEMINATION OF SPYWARE BY A PERSON WHO HAS BEEN
5 PREVIOUSLY CONVICTED WITHIN THE LAST FIVE YEARS OF HAVING VIOLATED THIS
6 SECTION IS A CLASS E FELONY.
7 S 2. This act shall take effect on the first of November next succeed-
8 ing the date on which it shall have become a law.
