AN ACT to amend the public health law, in relation to providing personal  
emergency response services as part of home care services, and making  
an appropriation therefor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 3602 of the public health law is amended by adding  
2 a new subdivision 8-a to read as follows:  
3 8-A. "PERSONAL EMERGENCY RESPONSE SERVICES" MEANS (A) THE PROVISION  
4 AND MAINTENANCE OF ELECTRONIC COMMUNICATION EQUIPMENT IN THE HOME OF AN  
5 INDIVIDUAL WHICH SIGNALS A MONITORING AGENCY FOR HELP WHEN ACTIVATED BY  
6 THE INDIVIDUAL, OR AFTER A PERIOD OF TIME IF A TIMER MECHANISM HAS NOT  
7 BEEN RESET, AND (B) THE CONTINUOUS MONITORING OF SUCH SIGNALS BY A  
8 TRAINED OPERATOR AND, IN CASE OF RECEIPT OF SUCH SIGNAL, THE IMMEDIATE  
9 NOTIFICATION OF SUCH EMERGENCY RESPONSE ORGANIZATIONS OR PERSONS, IF  
10 NECESSARY, AS THE INDIVIDUAL HAS PREVIOUSLY SPECIFIED.  
11 S 2. The public health law is amended by adding a new section 3611-b  
12 to read as follows:  
13 S 3611-B. APPLICATION FOR GRANTS TO ESTABLISH OR EXPAND PERSONAL EMER-  
14 GENCY RESPONSE SERVICES. 1. A HOSPITAL, RESIDENTIAL HEALTH CARE FACILI-  
15 TY, CERTIFIED HOME HEALTH AGENCY OR LONG-TERM HOME HEALTH CARE PROGRAM,  
16 OR ANY OTHER NOT-FOR-PROFIT OR PUBLIC ORGANIZATION SEEKING GRANTS TO  
17 ESTABLISH OR EXPAND PERSONAL EMERGENCY RESPONSE SERVICES SHALL TRANSMIT  
18 TO THE COMMISSIONER AN APPLICATION SETTING FORTH THE SCOPE OF THE  
19 PROPOSED SERVICE. THE APPLICATION SHALL INCLUDE A DETAILED DESCRIPTION  
20 OF THE PROPOSED SERVICE INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING:  
21 (A) AN OUTLINE OF THE INSTITUTION'S OR AGENCY'S PLANS FOR THE SERVICE;  
22 (B) THE NEED FOR THE PROPOSED SERVICE;  
23 (C) THE NUMBER AND TYPES OF PERSONNEL TO BE EMPLOYED;

1 (D) THE ABILITY OF THE AGENCY, HOSPITAL OR FACILITY TO PROVIDE THE  
2 SERVICE;

3 (E) THE ESTIMATED NUMBER OF INDIVIDUALS TO BE SERVED;

4 (F) THE GEOGRAPHIC AREA IN WHICH THE PROPOSED SERVICE WILL BE  
5 PROVIDED;

6 (G) A DEMONSTRATION THAT THE PROPOSED SERVICE IS FEASIBLE AND IS PART  
7 OF A COMPREHENSIVE HOME CARE SERVICE SYSTEM; AND

8 (H) SUCH OTHER INFORMATION AS THE COMMISSIONER MAY REQUIRE.

9 2. (A) THE COMMISSIONER MAY, WITHIN THE AMOUNT APPROPRIATED THEREFOR,  
10 MAKE GRANTS TO CERTIFIED HOME HEALTH AGENCIES, HOSPITALS, RESIDENTIAL  
11 HEALTH CARE FACILITIES OR LONG-TERM HOME HEALTH CARE PROGRAMS, OR ANY  
12 OTHER NOT-FOR-PROFIT OR PUBLIC ORGANIZATION FOR THE PURPOSE OF INCREAS-  
13 ING THE AVAILABILITY OF THE PERSONAL EMERGENCY RESPONSE SERVICES. IN  
14 AWARDING GRANTS PURSUANT TO THIS SECTION, THE COMMISSIONER SHALL TAKE  
15 INTO CONSIDERATION, IN RELATION TO THE AREA SERVED, THE FOLLOWING  
16 FACTORS: THE NUMBER OF INDIVIDUALS TO BE SERVED BY THE SERVICE; THE  
17 SCOPE, QUANTITY AND ACCESSIBILITY OF THE SERVICE PROPOSED; THE ABILITY  
18 OF THE AGENCY TO CONTINUE TO PROVIDE THE PERSONAL EMERGENCY RESPONSE  
19 SERVICES UPON THE EXPIRATION OF THE GRANT; THE ABILITY OF THE ELIGIBLE  
20 CLIENT TO SUPPLEMENT ANY ADDITIONAL FUNDING FOR IMPLEMENTING THE  
21 SERVICE; THAT THE AGENCY PROVIDES FOR THE APPROPRIATE UTILIZATION AND  
22 COORDINATION OF THE SERVICE WITH OTHER HOME CARE SERVICES; AND ANY SUCH  
23 OTHER FACTORS AS THE COMMISSIONER MAY DETERMINE AS RELEVANT TO THE  
24 PUBLIC NEED FOR PERSONAL EMERGENCY RESPONSE SERVICES.

25 (B) SUCH GRANTS SHALL NOT EXCEED FIFTEEN THOUSAND DOLLARS PER ANNUM  
26 AND ARE NOT RENEWABLE. GRANTS ARE ALSO AVAILABLE OF UP TO FIFTY PERCENT  
27 OF THE COSTS TO THOSE AGENCIES WHO ARE PRESENTLY PROVIDING PERSONAL  
28 EMERGENCY RESPONSE SERVICES AND WISH TO EXPAND THE SERVICE.

29 (C) THE COMMISSIONER, AFTER CONSULTATION WITH THE STATE COUNCIL ON  
30 HOME CARE SERVICES, SHALL PROMULGATE RULES AND REGULATIONS NECESSARY TO  
31 ADMINISTER THIS SECTION. THE STATE COUNCIL ON HOME CARE SERVICES SHALL  
32 ADVISE THE DEPARTMENT OF THE AVAILABILITY AND QUALITY OF THE PERSONAL  
33 EMERGENCY RESPONSE SERVICES AND ON THE METHODS THAT MAY BE USED TO  
34 ENHANCE THE AVAILABILITY, APPROPRIATE UTILIZATION AND COORDINATION OF  
35 THE SERVICE THROUGH THE IMPLEMENTATION OF THE GRANT SYSTEM.

36 S 3. The sum of one hundred thousand dollars (\$100,000), or so much  
37 thereof as may be necessary, is hereby appropriated out of any moneys in  
38 the state treasury in the general fund to the credit of the state  
39 purposes account, not otherwise appropriated, and made immediately  
40 available to the commissioner of health to pay the expenses including  
41 personal service, in carrying out the provisions of this act. Such  
42 moneys shall be payable out of the state treasury after audit by and on  
43 the warrant of the comptroller upon vouchers certified or approved by  
44 the commissioner of health as prescribed by law.

45 S 4. This act shall take effect one year after the date on which it  
46 shall have become a law.
