AN ACT to amend the agriculture and markets law, in relation to the administration of rabies vaccine to livestock and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The agriculture and markets law is amended by adding a new 2 section 89-a to read as follows:

3 S 89-A. ADMINISTRATION OF RABIES VACCINE. (1) NOTWITHSTANDING ANY 4 OTHER SECTION OF LAW, ANY LIVESTOCK OWNER MAY DIRECTLY PURCHASE KILLED RABIES VACCINE FOR THE SOLE PURPOSE OF VACCINATING LIVESTOCK OWNED 5 ΒY 6 LIVESTOCK OWNER. LIVESTOCK VACCINATED IN SUCH A MANNER WITHOUT THE SUCH 7 DIRECT OR SUPERVISORY PARTICIPATION OF A VETERINARIAN ΒE WILL NOT CONSIDERED AS VACCINATED BY THE DEPARTMENT OF HEALTH, THE DEPARTMENT OF 8 AGRICULTURE AND MARKETS, OR ANY OTHER DEPARTMENT, AGENCY, 9 OR AGENT OF 10 FOR THE PURPOSES OF MATTERS INVOLVING STATE ACTION OR POLICY THE STATE TOWARDS LIVESTOCK, INCLUDING, BUT NOT LIMITED TO, QUARANTINE IN THE CASE 11 12 OF A RABIES OUTBREAK OR LOCAL RABIES EMERGENCY, AND ELIGIBILITY FOR PARTICIPATION IN THE NEW YORK STATE FAIR OR ANY COUNTY OR LOCAL FAIR RUN 13 BY ANY POLITICAL SUBDIVISION OF THE STATE OF NEW YORK. 14 LIVESTOCK VACCI-15 NATED PURSUANT TO THIS SECTION SHALL NOT BE ELIGIBLE FOR INDEMNIFICATION AS PROVIDED FOR IN ARTICLE SIX-A OF THIS CHAPTER IF IT IS 16 FOR RABIES 17 DETERMINED THAT SUCH VACCINATIONS, CONDUCTED WITHOUT THEDIRECT OR SUPERVISORY PARTICIPATION OF A VETERINARIAN, CONTRIBUTED TO THE DAMAGES 18 19 TO THE ANIMAL.

(2) FOR PURPOSES OF THIS SECTION, 20 THE TERM "LIVESTOCK" SHALL MEAN 21 CATTLE AND HORSES AND ANY SPECIES OF LIVESTOCK THAT ARE INDICATED ON THE INSERT. THE TERM "LIVESTOCK" SHALL NOT MEAN 22 VACCINE LABEL OR PACKAGE 23 DOGS AND CATS. ALL KILLED RABIES VACCINES MUST BE ADMINISTERED IN
