AN ACT to amend the insurance law, in relation to excepting from community rating requirements group health insurance policies issued to multiple employer trusts consisting of municipal corporations and public benefit corporations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subsection (g) of section 3231 of the insurance 1 law, as 2 added by chapter 501 of the laws of 1992, is amended to read as follows: 3 This section shall also apply to policies issued to a group (q) 4 defined in subsection (c) of section four thousand two hundred thirtyfive OF THIS CHAPTER, including but not limited to an association or 5 б trust of employers, if the group includes one or more member employers 7 other member groups which have fifty or fewer employees or members or exclusive of spouses and dependents, PROVIDED HOWEVER THAT THIS 8 SECTION SHALL NOT APPLY TO POLICIES ISSUED TO A GROUP DEFINED IN SUBPARAGRAPH 9 10 (D) OF PARAGRAPH ONE OF SUBSECTION (C) OF SECTION FOUR THOUSAND TWO HUNDRED THIRTY-FIVE OF THIS CHAPTER, IF THE GROUP INCLUDES ONE OR MORE 11 12 MEMBER EMPLOYERS THAT ARE MUNICIPAL CORPORATIONS OR PUBLIC BENEFIT CORPORATIONS THAT HAVE FIFTY OR FEWER EMPLOYEES EXCLUSIVE OF SPOUSES AND 13 14 DEPENDENTS.

15 S 2. Subsection (d) of section 4317 of the insurance law, as added by 16 chapter 501 of the laws of 1992, is amended to read as follows:

17 (d) This section shall also apply to contracts issued to a group defined in subsection (c) of section four thousand two hundred thirty-18 five OF THIS CHAPTER, including but not limited to an association or 19 employers, if the group includes one or more member employers 20 trust of or other member groups which have fifty or fewer employees or members 21 22 exclusive of spouses and dependents, PROVIDED HOWEVER THAT THIS SECTION 23 SHALL NOT APPLY TO POLICIES ISSUED TO A GROUP DEFINED IN SUBPARAGRAPH
