AN ACT to amend the education law, in relation to the use of epinephrine by students

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 920 to 2 read as follows:

3 PUPILS AFFLICTED WITH SEVERE FOOD OR OTHER ALLERGIES. 1. S 920. Α. 4 THE BOARD OF EDUCATION OR TRUSTEES OF EACH SCHOOL DISTRICT AND BOARD OF 5 COOPERATIVE EDUCATIONAL SERVICES SHALL ALLOW PUPILS WHO HAVE BEEN DIAG-6 NOSED BY A PHYSICIAN OR OTHER DULY AUTHORIZED HEALTH CARE PROVIDER WITH 7 SEVERE FOOD OR OTHER ALLERGY TO CARRY AND USE THE PRESCRIBED MEDICA-Α TION EPINEPHRINE AND A DEVICE TO SELF-ADMINISTER EPINEPHRINE, SUCH AS AN 8 EPINEPHRINE AUTO-INJECTOR, DURING THE SCHOOL DAY AND DURING SCHOOL SPON-9 10 SORED ACTIVITIES THAT OCCUR AFTER THE REGULAR SCHOOL DAY OR OUTSIDE OF WRITTEN PERMISSION OF A PHYSICIAN OR OTHER DULY 11 THE SCHOOL, WITH THE 12 AUTHORIZED HEALTH CARE PROVIDER, AND PARENTAL CONSENT, BASED ON SUCH 13 PHYSICIAN'S OR PROVIDER'S DETERMINATION THAT SUCH PUPIL IS SUBJECT TO ALLERGIC ATTACKS SEVERE ENOUGH TO DEBILITATE SUCH PUPIL. A RECORD OF 14 15 SUCH PERMISSION SHALL BE MAINTAINED IN THE SCHOOL OFFICE.

B. THE BOARD OF EDUCATION OR TRUSTEES OF EACH SCHOOL DISTRICT OR BOARD 16 17 OF COOPERATIVE EDUCATIONAL SERVICES THAT HAS ALLOWED THE USE OF EPINEPH-A DEVICE TO SELF-ADMINISTER EPINEPHRINE BY A STUDENT PURSUANT 18 RINE AND TO THE PROVISIONS OF PARAGRAPH A OF THIS SUBDIVISION SHALL PREPARE 19 FOR EACH SUCH STUDENT AN EMERGENCY ACTION PLAN AND A SEVERE ALLERGY TREAT-20 21 MENT PLAN WITH THE ASSISTANCE OF THE PHYSICIAN OF THE PUPIL, WHICH IDEN-22 TIFIES, AT A MINIMUM, SEVERE ALLERGY TRIGGERS, THE TREATMENT PLAN, AND 23 SUCH OTHER ELEMENTS AS SHALL BE DETERMINED BY THE PHYSICIAN. 1 SIONER, IN CONSULTATION WITH THE COMMISSIONER OF HEALTH, SHALL ESTABLISH 2 STANDARDS FOR THE DEVELOPMENT OF SUCH PLANS.

3 2. THE BOARD OF EDUCATION OR TRUSTEES OF EACH SCHOOL DISTRICT OR BOARD 4 OF COOPERATIVE EDUCATIONAL SERVICES THAT HAS APPROVED THE USE OF 5 EPINEPHRINE AND A DEVICE TO SELF-ADMINISTER EPINEPHRINE BY A STUDENT 6 THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION SHALL PURSUANT ТО 7 INFORM THE PARENTS, GUARDIANS OR PERSONS IN PARENTAL RELATION TO THE PUPIL IN WRITING THAT THE SCHOOL DISTRICT OR BOARD OF COOPERATIVE EDUCA-8 TIONAL SERVICES AND ITS EMPLOYEES OR AGENTS SHALL INCUR NO LIABILITY AS 9 10 A RESULT OF ANY INJURY ARISING FROM THE SELF-ADMINISTRATION OF SUCH MEDICATION BY THE PUPIL. THE PARENTS, GUARDIANS OR PERSONS IN PARENTAL 11 12 RELATION TO THE PUPIL SHALL SIGN A STATEMENT ACKNOWLEDGING THAT THE DISTRICT OR BOARD OF COOPERATIVE EDUCATIONAL SERVICES SHALL INCUR NO 13 14 LIABILITY AS A RESULT OF ANY INJURY ARISING FROM THE SELF-ADMINISTRATION 15 OF SUCH MEDICATION BY THE PUPIL AND THE PARENTS, GUARDIANS OR PERSONS IN PARENTAL RELATION SHALL INDEMNIFY AND HOLD HARMLESS THE SCHOOL DISTRICT 16 17 BOARD OF COOPERATIVE EDUCATIONAL SERVICES AND ITS EMPLOYEES AND OR AGENTS FROM ANY CLAIMS ARISING OUT OF THE SELF-ADMINISTRATION OF SUCH 18 MEDICATION BY THE PUPIL. 19

3. A. EVERY SCHOOL DISTRICT, BOARD OF COOPERATIVE EDUCATIONAL SERVICES
 AND NONPUBLIC ELEMENTARY AND SECONDARY SCHOOL IN THIS STATE SHALL
 REQUIRE AT LEAST ONE DEVICE CONTAINING EPINEPHRINE USED TO ADMINISTER
 EPINEPHRINE, SUCH AS AN EPINEPHRINE AUTO-INJECTOR, BE MAINTAINED IN THE
 OFFICE OF THE SCHOOL NURSE OR IN A SIMILAR ACCESSIBLE LOCATION.

25 B. THE COMMISSIONER SHALL PROMULGATE REGULATIONS FOR THE ADMINIS-26 TRATION OF EPINEPHRINE THROUGH THE USE OF A DEVICE TO ADMINISTER 27 EPINEPHRINE BY THE SCHOOL NURSE OR OTHER PERSON AUTHORIZED BY REGU-28 LATION. THE REGULATIONS SHALL INCLUDE:

(I) A REQUIREMENT THAT EACH CERTIFIED NURSE OR OTHER PERSON AUTHORIZED
TO ADMINISTER EPINEPHRINE IN SCHOOLS RECEIVE TRAINING IN ALLERGY MANAGEMENT AND IN THE USE OF DEVICES TO SELF-ADMINISTER EPINEPHRINE CONSISTENT
WITH NATIONALLY RECOGNIZED STANDARDS, INCLUDING, BUT NOT LIMITED TO,
THOSE OF THE NATIONAL INSTITUTES OF HEALTH AND THE AMERICAN ASSOCIATION
OF ALLERGY AND IMMUNOLOGY.

35 (II) A REQUIREMENT THAT INFORMATION BE PROVIDED TO TEACHING AND OTHER 36 SCHOOL STAFF ABOUT:

37 (1) THE PRESENCE OF STUDENTS IN THE SCHOOL WHO MAY SUFFER FROM SEVERE 38 FOOD OR OTHER ALLERGIES AND THE POTENTIAL CONSEQUENCES OF SUCH ALLER-39 GIES;

40 (2) THE NEED FOR EPINEPHRINE THROUGH THE USE OF A DEVICE TO ADMINISTER 41 EPINEPHRINE;

42 (3) THE AVAILABILITY OF SUCH MEDICATION FROM THE SCHOOL NURSE OR OTHER 43 PERSON AUTHORIZED BY REGULATION, AND THE USE OF SUCH MEDICATION BY 44 PUPILS AUTHORIZED PURSUANT TO SUBDIVISION ONE OF THIS SECTION; AND

45 (4) THE PROTOCOL TO BE FOLLOWED WHEN A PUPIL EXPERIENCES A SEVERE 46 ALLERGIC REACTION.

S 2. This act shall take effect on the one hundred twentieth day after it shall have become a law; provided, however, that effective immediately the commissioner of education is authorized to promulgate rules and regulations for the implementation of this act on such effective date.
