AN ACT to amend the tax law and the real property tax law, in relation to providing a tax credit for the purchase of energy efficient home improvements

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1.     Section 606 of the tax law is amended by adding a new  
2     subsection (qq) to read as follows:  
3     (QQ) CREDIT FOR THE PURCHASE OF ENERGY EFFICIENT HOME IMPROVEMENTS.  
4     (1) ALLOWANCE AND AMOUNT OF CREDIT. A TAXPAYER SHALL BE ALLOWED A CREDIT, TO BE COMPUTED AS PROVIDED IN THIS SUBSECTION, AGAINST THE TAX  
5     IMPOSED BY THIS ARTICLE. THE AMOUNT OF THE CREDIT SHALL BE EQUAL TO  
6     TWENTY-FIVE PERCENT OF THE COST OF ENERGY EFFICIENT HOME IMPROVEMENTS,  
7     AS PROVIDED IN PARAGRAPH TWO OF THIS SUBSECTION, UP TO A TWO THOUSAND  
8     FIVE HUNDRED DOLLAR LIMIT FOR ALL HOME IMPROVEMENTS MADE BY SUCH TAXPAYER.  
9     ER.  
10     (2) THE NEW YORK STATE ENERGY RESEARCH AND DEVELOPMENT AUTHORITY SHALL  
11     ADOPT RULES AND REGULATIONS SETTING FORTH HOME IMPROVEMENTS WHICH QUALIFY FOR THE CREDIT UNDER THIS SUBSECTION. SUCH AUTHORITY SHALL DEVELOP A  
12     LIST OF SUCH IMPROVEMENTS AND PRODUCTS AND MAKE SUCH LIST AVAILABLE ON  
13     ITS WEBSITE.  
14     (3) APPLICATION OF CREDIT. IF THE AMOUNT OF CREDIT ALLOWED UNDER THIS  
15     SUBSECTION FOR ANY TAXABLE YEAR SHALL EXCEED THE TAXPAYER'S TAX FOR SUCH  
16     YEAR, THE EXCESS SHALL BE TREATED AS AN OVERPAYMENT OF TAX TO BE CREDITED OR REFUNDED IN ACCORDANCE WITH THE PROVISIONS OF SECTION SIX HUNDRED

3 S 2. The real property tax law is amended by adding a new section  
4 582-b to read as follows:

5 S 582-B. ENERGY EFFICIENT HOME IMPROVEMENTS. ENERGY EFFICIENT PRODUCTS  
6 AND HOME IMPROVEMENTS WHICH HAVE BEEN DETERMINED BY THE NEW YORK STATE  
7 ENERGY RESEARCH AND DEVELOPMENT AUTHORITY AS QUALIFIED FOR A TAX CREDIT  
8 UNDER SUBSECTION (QQ) OF SECTION SIX HUNDRED SIX OF THE TAX LAW SHALL  
9 NOT INCREASE THE ASSESSED VALUATION FOR PURPOSES OF REAL PROPERTY TAXA-  
10 TION OF ANY REAL PROPERTY TO WHICH SUCH IMPROVEMENTS ARE MADE OR  
11 PRODUCTS ARE AFFIXED.

12 S 3. This act shall take effect on the first of January next succeed-  
13 ing the date on which it shall have become a law and shall apply to  
14 taxable years commencing on and after such date.
