AN ACT to amend the general business law and the executive law, in relation to requiring mattresses and upholstered furniture to be fire retardant

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The general business law is amended by adding a new section 2 385-b to read as follows:
- 3 S 385-B. MATTRESSES AND UPHOLSTERED FURNITURE TO BE FIRE RETARDANT. 1. AS USED IN THIS SECTION:

- (A) "FIRE RETARDANT" MEANS A PRODUCT THAT MEETS THE REGULATIONS THE OFFICE OF FIRE PREVENTION AND CONTROL. THIS DOES NOT ADOPTED BY INCLUDE FURNITURE USED EXCLUSIVELY FOR THE PURPOSE OF PHYSICAL FITNESS AND EXERCISE.
- (B) "BEDDING" MEANS ANY OUILTED PAD, PACKING PAD, MATTRESS PAD, HAMMOCK PAD, MATTRESS, COMFORTER, QUILT, SLEEPING BAG, BOX SPRING, STUDIO COUCH, PILLOW OR CUSHION MADE OF LEATHER, CLOTH OR ANY OTHER 12 MATERIAL, WHICH IS OR CAN BE STUFFED OR FILLED IN WHOLE OR IN PART ANY CONCEALED SUBSTANCE OR MATERIAL, WHICH CAN BE USED BY ANY HUMAN BEING FOR SLEEPING OR RECLINING PURPOSES.
- 15 2. (A) ALL MATTRESSES AND BOX SPRINGS MANUFACTURED FOR SALE INSHALL BE FIRE RETARDANT PURSUANT TO SECTION ONE HUNDRED 16 17 FIFTY-SIX-H OF THE EXECUTIVE LAW. THE OFFICE OF FIRE PREVENTION AND 18 CONTROL SHALL ADOPT REGULATIONS NO LATER THAN JANUARY FIRST, TWO THOU-SAND TEN, REQUIRING THAT FIRE RETARDANT MATTRESSES AND BOX SPRINGS 19 TEST THAT USES A PASS OR FAIL PERFORMANCE 20 RESISTANCE TO OPEN-FLAME 21 CRITERIA BASED ON A TEST METHOD DEVELOPED BY THE OFFICE OF 22 PREVENTION AND CONTROL OR THAT IS BASED ON ASTME 1590. IF THE OFFICE OF 23 FIRE PREVENTION AND CONTROL CONCLUDES THAT OTHER BEDDING CONTRIBUTES

MATTRESS FIRES, THE REGULATIONS SHALL REQUIRE THE OTHER BEDDING TO BE FLAME RETARDANT UNDER THE RESISTANCE TO OPEN-FLAME TEST. IF FEASIBLE, 3 OFFICE OF FIRE PREVENTION AND CONTROL REGULATIONS SHALL PERMIT A MANUFACTURER TO COMPLY WITH THE RESISTANCE TO OPEN-FLAME TEST BY TESTING A SMALL SCALE VERSION OF ITS PRODUCT. IN DEVELOPING THESE REGULATIONS, THE OFFICE OF FIRE PREVENTION AND CONTROL MAY CONTRACT, COOPERATE, 7 OTHERWISE SHARE RESOURCES WITH OTHER GOVERNMENT AGENCIES, PRIVATE ORGAN-IZATIONS, OR INDEPENDENT CONTRACTORS THAT IT CONSIDERS APPROPRIATE FOR 9 PURPOSES OF REVIEWING TEST CRITERIA AND METHODS, EQUIPMENT SPECIFICA-10 TIONS, AND OTHER RELEVANT SUBJECTS. THESE REGULATIONS SHALL BECOME INOP-11 ERATIVE UPON THE EFFECTIVE DATE OF ANY FEDERAL LAW OR REGULATION ESTAB-LISHING AN OPEN-FLAME RESISTANCE STANDARD FOR THESE PRODUCTS. THE OFFICE 12 13 OF FIRE PREVENTION AND CONTROL SHALL SUBMIT A REPORT TO THE GOVERNOR AND 14 THE LEGISLATURE ON OR BEFORE JANUARY FIRST, TWO THOUSAND TEN, SUMMARIZ-ING ITS REGULATORY FINDINGS.

- (B) REQUIREMENTS FOR FLAME RESISTANT MATTRESSES, BOX SPRINGS, OR OTHER BEDDING PRODUCTS SHALL NOT APPLY TO ANY HOTEL, MOTEL, BED AND BREAKFAST, INN, OR SIMILAR TRANSIENT LODGING ESTABLISHMENT THAT HAS AN AUTOMATIC FIRE EXTINGUISHING SYSTEM THAT CONFORMS TO APPLICABLE STATE CODES.
- (C) ALL SEATING FURNITURE SOLD OR OFFERED FOR SALE BY AN IMPORTER, MANUFACTURER, OR WHOLESALER FOR USE IN THIS STATE, INCLUDING ANY SEATING FURNITURE SOLD TO OR OFFERED FOR SALE FOR USE IN A HOTEL, MOTEL, OR OTHER PLACE OF PUBLIC ACCOMMODATION IN THIS STATE, AND REUPHOLSTERED FURNITURE TO WHICH FILLING MATERIALS ARE ADDED, SHALL BE FIRE RETARDANT AND SHALL BE LABELED IN A MANNER SPECIFIED BY THE OFFICE OF FIRE PREVENTION AND CONTROL.
- S 2. The executive law is amended by adding a new section 156-h to read as follows:
- S 156-H. FIRE SAFETY STANDARDS FOR MATTRESSES AND UPHOLSTERED FURNITURE. 1. AS USED IN THIS SECTION:
- (A) "FIRE RETARDANT" MEANS A PRODUCT THAT MEETS THE REGULATIONS ADOPTED BY THE OFFICE OF FIRE PREVENTION AND CONTROL. THIS DOES NOT INCLUDE FURNITURE USED EXCLUSIVELY FOR THE PURPOSE OF PHYSICAL FITNESS AND EXERCISE.
- (B) "BEDDING" MEANS ANY QUILTED PAD, PACKING PAD, MATTRESS PAD, HAMMOCK PAD, MATTRESS, COMFORTER, QUILT, SLEEPING BAG, BOX SPRING, STUDIO COUCH, PILLOW OR CUSHION MADE OF LEATHER, CLOTH OR ANY OTHER MATERIAL, WHICH IS OR CAN BE STUFFED OR FILLED IN WHOLE OR IN PART WITH ANY CONCEALED SUBSTANCE OR MATERIAL, WHICH CAN BE USED BY ANY HUMAN BEING FOR SLEEPING OR RECLINING PURPOSES.
- (A) ALL MATTRESSES AND BOX SPRINGS MANUFACTURED FOR SALE IN THIS STATE SHALL BE FIRE RETARDANT. THE OFFICE OF FIRE PREVENTION AND CONTROL SHALL ADOPT REGULATIONS NO LATER THAN JANUARY FIRST, TWO THOUSAND REQUIRING THAT FIRE RETARDANT MATTRESSES AND BOX SPRINGS MEET A RESIST-ANCE TO OPEN-FLAME TEST THAT USES A PASS OR FAIL PERFORMANCE BASED ON A TEST METHOD DEVELOPED BY THE OFFICE OF FIRE PREVENTION AND CONTROL OR THAT IS BASED ON ASTME 1590. IF THE OFFICE OF FIRE PREVENTION AND CONTROL CONCLUDES THAT OTHER BEDDING CONTRIBUTES TO MATTRESS REGULATIONS SHALL REQUIRE THE OTHER BEDDING TO BE FLAME RETARDANT UNDER THE RESISTANCE TO OPEN-FLAME TEST. IF FEASIBLE, THE OFFICE OF FIRE PREVENTION AND CONTROL REGULATIONS SHALL PERMIT A MANUFACTURER TO COMPLY WITH THE RESISTANCE TO OPEN-FLAME TEST BY TESTING A SMALL SCALE VERSION ITS PRODUCT. IN DEVELOPING THESE REGULATIONS, THE OFFICE OF FIRE PREVENTION AND CONTROL MAY CONTRACT, COOPERATE, OR OTHERWISE RESOURCES WITH OTHER GOVERNMENT AGENCIES, PRIVATE ORGANIZATIONS, OR INDEPENDENT CONTRACTORS THAT IT CONSIDERS APPROPRIATE FOR PURPOSES OF

REVIEWING TEST CRITERIA AND METHODS, EQUIPMENT SPECIFICATIONS, AND OTHER RELEVANT SUBJECTS. THESE REGULATIONS SHALL BECOME INOPERATIVE UPON THE EFFECTIVE DATE OF ANY FEDERAL LAW OR REGULATION ESTABLISHING AN OPEN-FLAME RESISTANCE STANDARD FOR THESE PRODUCTS. THE OFFICE OF FIRE PREVENTION AND CONTROL SHALL SUBMIT A REPORT TO THE GOVERNOR AND THE LEGISLATURE ON OR BEFORE JANUARY FIRST, TWO THOUSAND TEN, SUMMARIZING ITS REGULATORY FINDINGS.

- (B) REQUIREMENTS FOR FLAME RESISTANT MATTRESSES, BOX SPRINGS, OR OTHER BEDDING PRODUCTS SHALL NOT APPLY TO ANY HOTEL, MOTEL, BED AND BREAKFAST, INN, OR SIMILAR TRANSIENT LODGING ESTABLISHMENT THAT HAS AN AUTOMATIC FIRE EXTINGUISHING SYSTEM THAT CONFORMS TO APPLICABLE STATE CODES.
- (C) ALL SEATING FURNITURE SOLD OR OFFERED FOR SALE BY AN IMPORTER, MANUFACTURER, OR WHOLESALER FOR USE IN THIS STATE, INCLUDING ANY SEATING FURNITURE SOLD TO OR OFFERED FOR SALE FOR USE IN A HOTEL, MOTEL, OR OTHER PLACE OF PUBLIC ACCOMMODATION IN THIS STATE, AND REUPHOLSTERED FURNITURE TO WHICH FILLING MATERIALS ARE ADDED, SHALL BE FIRE RETARDANT AND SHALL BE LABELED IN A MANNER SPECIFIED BY THE OFFICE OF FIRE PREVENTION AND CONTROL.
- 3. THE ATTORNEY GENERAL SHALL HAVE THE POWER TO ASSESS A FINE OF UP TO ONE THOUSAND DOLLARS FOR EACH VIOLATION OF THIS SECTION. TO ENFORCE THE PROVISIONS OF THIS SECTION, THE ATTORNEY GENERAL MAY BRING AN ACTION ON BEHALF OF THE PEOPLE OF THE STATE OF NEW YORK TO ENJOIN ACTS IN VIOLATION OF THIS SECTION AND TO RECOVER CIVIL PENALTIES AUTHORIZED UNDER THIS SUBDIVISION.
- 25 S 3. This act shall take effect on the sixtieth day after it shall 26 have become a law.
