AN ACT to amend the alcoholic beverage control law, in relation to the  
issuance of temporary carnival licenses; and providing for the repeal  
of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. The alcoholic beverage control law is amended by adding a  
2     new section 97-b to read as follows:  
3     S 97-B. TEMPORARY CARNIVAL LICENSE. 1. THE LIQUOR AUTHORITY IS HEREBY  
4     AUTHORIZED TO ISSUE TEMPORARY PERMITS FOR A PERIOD NOT TO EXCEED EIGH-  
5     TEEN DAYS TO AUTHORIZE THE SALE OF BEER AND WINE AT ASSOCIATED EVENTS  
6     LEADING UP TO FESTIVALS, CARNIVALS AND PARADES WITHIN THE HOURS FIXED BY  
7     OR PURSUANT TO SUBDIVISION FIVE OF SECTION ONE HUNDRED SIX OF THIS CHAP-  
8     TER, PROVIDED, HOWEVER, THE DURATION OF THE TEMPORARY CARNIVAL LICENSE  
9     SHALL BE MEASURED OVER A PERIOD OF SIX CONSECUTIVE WEEKS, DURING WHICH  
10    SUCH TEMPORARY CARNIVAL LICENSE SHALL ONLY BE VALID ON FRIDAY, SATURDAY,  
11    AND SUNDAY OF EACH WEEK. THE FEE FOR SUCH PERMIT SHALL BE ONE HUNDRED  
12    DOLLARS. SUCH PERMIT AND THE EXERCISE OF THE PRIVILEGE GRANTED THEREBY  
13    SHALL BE SUBJECT TO SUCH RULES OF THE LIQUOR AUTHORITY AS IT DEEMS  
14    NECESSARY.  
15    2. SUCH RULES SHALL INCLUDE PROCEDURES FOR REVOCATION OF A PERMIT  
16    BASED ON COMPLAINTS FROM A GOVERNMENTAL AGENCY, LOCAL POLICE, OR CIVIC  
17    ASSOCIATION, AND SHALL BE DEVELOPED IN CONSULTATION WITH LOCAL COMMUNI-  
18    TIES, CARNIVAL ASSOCIATIONS AND MAY INCLUDE CONDITIONS SPECIFIC TO A  
19    BOROUGH, COUNTY, OR COMMUNITY BOARD IN THE CITY OF NEW YORK.  
20    3. THE LIQUOR AUTHORITY IS HEREBY AUTHORIZED TO ISSUE SUCH TEMPORARY  
21    PERMITS TO GROUPS OR ORGANIZATIONS WHO ARE REGISTERED AS FESTIVAL,  
22    CARNIVAL OR PARADE PARTICIPANTS OR DESIGNATED OR ACKNOWLEDGED BY THE  
23    PRIME SPONSOR OF SUCH FESTIVAL, CARNIVAL OR PARADE. THE OFFICIAL PRIME

1 SPONSOR SHALL BE THE ENTITY HOLDING THE PERMIT OR OFFICIAL DOCUMENTATION  
2 AUTHORIZING SUCH FESTIVAL, CARNIVAL OR PARADE.

3 S 2. This act shall take effect on the forty-fifth day after it shall  
4 have become a law and shall expire five years after such effective date  
5 when upon such date the provisions of this act shall be deemed repealed;  
6 provided, however, that effective immediately the liquor authority is  
7 hereby authorized to promulgate rules and regulations for the purpose of  
8 implementing the provisions of this act on or before such effective  
9 date.
