AN ACT to amend the elder law, in relation to establishing a senior housing task force

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The elder law is amended by adding a new section 203-a to 2 read as follows:
 - S 203-A. SENIOR HOUSING TASK FORCE. 1. THERE IS HEREBY ESTABLISHED WITHIN THE OFFICE A SENIOR HOUSING TASK FORCE WHICH SHALL MEET AT LEAST FOUR TIMES IN DIFFERENT GEOGRAPHICAL AREAS OF THE STATE. THE TASK FORCE
- 6 SHALL CONSIST OF SEVENTEEN MEMBERS AND SHALL INCLUDE REPRESENTATIVES

- 7 FROM THE FOLLOWING STATE AGENCIES: THE OFFICE FOR THE AGING, THE DIVI-8 SION OF HOUSING AND COMMUNITY RENEWAL, THE DEPARTMENT OF HEALTH, THE
- 9 OFFICE OF MENTAL HEALTH, THE DEPARTMENT OF ECONOMIC DEVELOPMENT, THE 10 EMPIRE STATE DEVELOPMENT CORPORATION, THE OFFICE OF MENTAL RETARDATION

SHALL BE APPOINTED BY THE GOVERNOR AT THE RECOMMENDATION OF THE SPEAKER OF THE ASSEMBLY, THREE SHALL BE APPOINTED BY THE GOVERNOR AT THE RECOM-MENDATION OF THE TEMPORARY PRESIDENT OF THE SENATE, ONE SHALL BE APPOINTED BY THE GOVERNOR AT THE RECOMMENDATION OF THE MINORITY LEADER OF THE ASSEMBLY AND ONE SHALL BE APPOINTED BY THE GOVERNOR AT THE RECOM-MENDATION OF THE MINORITY LEADER OF THE SENATE, AND SHALL BROADLY REPRE-7 SENT HOUSING AND SENIOR CITIZEN GROUPS FROM ALL GEOGRAPHIC AREAS OF THE STATE INCLUDING SERVICE PROVIDERS, ASSOCIATIONS, ADVOCATES, PROPRIETORS, AND CONSUMERS OF FOR-PROFIT AND NOT-FOR-PROFIT SENIOR HOUSING OPTIONS 9 10 INCLUDING BUT NOT LIMITED TO: ASSISTED LIVING FACILITIES, ADULT HOMES, SKILLED NURSING FACILITIES, INDEPENDENT LIVING FACILITIES, NATURALLY 11 OCCURRING RETIREMENT COMMUNITIES, NEIGHBORHOOD NATURALLY OCCURRING 12 RETIREMENT COMMUNITIES, AND CONTINUING CARE RETIREMENT COMMUNITIES. 13 MEMBERS SHALL RECEIVE NO COMPENSATION FOR THEIR SERVICES BUT SHALL BE 14 REIMBURSED FOR TRAVEL AND OTHER EXPENSES ACTUALLY AND NECESSARILY INCURRED IN THE PERFORMANCE OF THEIR DUTIES. THE TASK FORCE SHALL BE CO-CHAIRED BY THE DIRECTOR OF THE OFFICE AND THE COMMISSIONER OF THE 16 17 DIVISION OF HOUSING AND COMMUNITY RENEWAL. THE TASK FORCE IS RESPONSIBLE 18 19 FOR CONDUCTING A STATE-WIDE ASSESSMENT OF SENIOR HOUSING NEEDS TAKING INTO CONSIDERATION THE VARIOUS GEOGRAPHICAL AREAS AND DIFFERENT NEEDS OF 20 21 THE SENIORS IN THOSE AREAS AND RESOURCES AVAILABLE IN THOSE DIFFERENT AREAS AND PROJECT THOSE NEEDS OVER THE NEXT TEN YEARS; OTHER FACTORS WHICH SHALL BE TAKEN INTO CONSIDERATION ARE: HEALTH CARE NEEDS OF 23 SENIORS, THE LONG TERM CARE NEEDS OF SENIORS, FINANCIAL RESOURCES AVAIL-ABLE TO SENIORS, OR NEEDED BY SENIORS, AND TRANSPORTATION NEEDS OF SENIORS. THE ASSESSMENT SHALL INCLUDE A REVIEW OF INNOVATIVE APPROACHES 26 SUCCESSFULLY BEING IMPLEMENTED IN OTHER STATES AND THEIR POTENTIAL FOR 27 IMPLEMENTATION IN THIS STATE. SUCH ASSESSMENT SHALL ALSO DEVELOP A 28 VIABLE PLAN FOR PROVIDING OUALITY SENIOR HOUSING TO MEET THE PROJECTED 29 NEEDS OF SENIORS WITH ACTIONS, STEPS AND TIME FRAMES. 30

- 2. THE TASK FORCE SHALL ISSUE A REPORT BY JANUARY FIRST, TWO THOUSAND TWELVE OUTLINING ITS FINDINGS AND RECOMMENDATIONS INCLUDING THE STATE PLAN WITH TIME FRAMES. THE REPORT SHALL BE DELIVERED TO THE GOVERNOR, THE SPEAKER OF THE ASSEMBLY, THE TEMPORARY PRESIDENT OF THE SENATE, THE CHAIRPERSONS OF THE AGING, HEALTH AND HOUSING COMMITTEES IN THE ASSEMBLY, AND THE CHAIRPERSONS OF THE AGING, HEALTH AND HOUSING, CONSTRUCTION, AND COMMUNITY DEVELOPMENT COMMITTEES IN THE SENATE.
