AN ACT to amend the local finance law, in relation to the sale of municipal obligations by the county of Erie

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 54.50 of the local finance law, as amended by chapter 80 of the laws of 2008, is amended to read as follows:
2 S 54.50 Costs of sales; county of Erie. To facilitate the marketing of
3 any issue of serial bonds or notes of the county of Erie issued on or
4 before June thirtieth, two thousand [nine] TEN such county may, notwithstanding any limitations on private sales of bonds provided by law, and
5 subject to approval by the state comptroller of the terms and conditions
6 of such sale:
7 a. arrange for the underwriting of its bonds or notes at private sale
8 through negotiated agreement, compensation for such underwriting to be
9 provided by negotiated fee or by sale of such bonds or notes to an
10 underwriter at a price less than the sum of par value of, and the
11 accrued interest on, such obligations; or
12 b. arrange for the private sale of its bonds or notes through negotiated agreement, compensation for such sales to be provided by negotiated
13 fee, if required. The cost of such underwriting or private placement
14 shall be deemed a preliminary cost for purposes of section 11.00 of this
15 chapter.
16 S 2. This act shall take effect immediately.
