AN ACT to amend the real property actions and proceedings law and the county law, in relation to representation of certain persons in private residential foreclosure actions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The real property actions and proceedings law is amended by 2 adding a new section 1305 to read as follows:

S 1305. ASSIGNMENT OF COUNSEL. A HOMEOWNER IN A FORECLOSURE ACTION WHO
IS FINANCIALLY UNABLE TO OBTAIN COUNSEL FOR REPRESENTATION IN SUCH
ACTION SHALL HAVE A RIGHT TO ASSIGNED COUNSEL BY THE COURT. ASSIGNMENT
OF COUNSEL ISSUED UNDER THIS SECTION SHALL BE IMPLEMENTED AS PROVIDED IN
ARTICLE EIGHTEEN-B OF THE COUNTY LAW.

8 S 2. Subdivision 3 of section 1303 of the real property actions and 9 proceedings law, as amended by chapter 472 of the laws of 2008, is 10 amended to read as follows:

3. The notice required by this section shall appear as follows:

Foreclosure rescue scams Be careful of people who approach you with offers to "save" your home. 11 There are individuals who watch for notices of foreclosure actions in order to unfairly profit from a homeowner's distress. You should be 12 13 14 extremely careful about any such promises and any suggestions that you 15 pay them a fee or sign over your deed. State law requires anyone offering such services for profit to enter into a contract which fully describes the services they will perform and fees they will charge, and 16 17 which prohibits them from taking any money from you until they have 18 19 completed all such promised services. The opening paragraph of section 722 of the county law, as amended by chapter 7 of the laws of 2007, is amended to read as follows: 26 The governing body of each county and the governing body of the city in which a county is wholly contained shall place in operation through-27 28 29 the county a plan for providing counsel to persons charged with a out crime or who are entitled to counsel pursuant to section two hundred 30 sixty-two or section eleven hundred twenty of the family court act, 31 32 article six-C of the correction law, section four hundred seven of the 33 surrogate's court procedure act [or], article ten of the mental hygiene law OR SECTION THIRTEEN HUNDRED FIVE OF THE REAL PROPERTY ACTIONS AND 34 PROCEEDINGS LAW, who are financially unable to obtain counsel. Each plan 35 shall also provide for investigative, expert and other services neces-36 37 sary for an adequate defense. The plan shall conform to one of the following: S 5. This act shall take effect on the first of January next succeed-
