AN ACT to amend the education law, in relation to requiring students enrolled in the undergraduate psychology program within the SUNY and CUNY systems to complete 12 hours of documented volunteer service with certain places or programs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as
2 "Vicki's law".
3 S 2. The education law is amended by adding a new section 355-d to
4 read as follows:
5 S 355-D. REQUIRED VOLUNTEER SERVICE FOR STUDENTS ENROLLED IN THE
6 UNDERGRADUATE PSYCHOLOGY PROGRAM. 1. EVERY STUDENT ENROLLED IN THE
7 UNDERGRADUATE PSYCHOLOGY PROGRAM WITHIN THE STATE UNIVERSITY OF NEW YORK
8 SYSTEM SHALL COMPLETE, IN ADDITION TO ESTABLISHED PROGRAM REQUIREMENTS
9 FOR GRADUATION, A MINIMUM OF TWELVE HOURS OF VOLUNTEER SERVICE WITH ANY
10 OF THE FOLLOWING PLACES OR PROGRAMS:
11 A. A SUICIDE PREVENTION HOTLINE AND/OR CENTER;
12 B. A DOMESTIC ABUSE PREVENTION HOTLINE AND/OR CENTER;
13 C. AN EATING DISORDER HOTLINE AND/OR COUNSELING CENTER;
14 D. AN EXPRESSIVE THERAPY COUNSELING CENTER;
15 E. OR ANY CALL CENTERS OR COUNSELING CENTERS WITH PROGRAMS THAT
16 SPECIFICALLY PERTAIN TO ISSUES SUCH AS ABUSE, DEPRESSION, ANXIETY AND
17 STRESS, OR SELF-ESTEEM AND WEIGHT DISORDERS.
18 2. EACH COLLEGE SHALL APPOINT A FACULTY MEMBER WITHIN THE UNDERGRADU-
19 ATE PSYCHOLOGY PROGRAM OR AN APPROPRIATE COLLEGE ADMINISTRATION OFFICIAL
20 TO TRACK AND DOCUMENT A STUDENT'S COMPLETED HOURS OF VOLUNTEER SERVICE.

7 S 3. The education law is amended by adding a new section 6235 to read

9 S 6235. REQUIRED VOLUNTEER SERVICE FOR STUDENTS ENROLLED IN THE UNDER-
10 GRADUATE PSYCHOLOGY PROGRAM. 1. EVERY STUDENT ENROLLED IN THE UNDERGRAD-
11 UATE PSYCHOLOGY PROGRAM WITHIN THE CITY UNIVERSITY OF NEW YORK SYSTEM
12 SHALL COMPLETE, IN ADDITION TO ESTABLISHED PROGRAM REQUIREMENTS FOR
13 GRADUATION, A MINIMUM OF TWELVE HOURS OF VOLUNTEER SERVICE WITH ANY OF
14 THE FOLLOWING PLACES OR PROGRAMS:

15 A. A SUICIDE PREVENTION HOTLINE AND/OR CENTER;

16 B. A DOMESTIC ABUSE PREVENTION HOTLINE AND/OR CENTER;

17 C. AN EATING DISORDER HOTLINE AND/OR COUNSELING CENTER;

18 D. AN EXPRESSIVE THERAPY COUNSELING CENTER;

19 E. OR ANY CALL CENTERS OR COUNSELING CENTERS WITH PROGRAMS THAT
20 SPECIFICALLY PERTAIN TO ISSUES SUCH AS ABUSE, DEPRESSION, ANXIETY AND
21 STRESS, OR SELF-ESTEEM AND WEIGHT DISORDERS.

22 2. EACH COLLEGE SHALL APPOINT A FACULTY MEMBER WITHIN THE UNDERGRADU-
23 ATE PSYCHOLOGY PROGRAM OR AN APPROPRIATE COLLEGE ADMINISTRATION OFFICIAL
24 TO TRACK AND DOCUMENT A STUDENT'S COMPLETED HOURS OF VOLUNTEER SERVICE.
25 SUCH FACULTY MEMBER OR COLLEGE ADMINISTRATION OFFICIAL SHALL BE RESPON-
26 SIBLE FOR ENSURING THAT SUCH STUDENT MEETS PROGRAM STANDARDS AND
27 FULFILLS THE REQUIREMENTS PROVIDED IN SUBDIVISION ONE OF THIS SECTION.

28 3. THE CITY UNIVERSITY OF NEW YORK IS HEREBY AUTHORIZED TO PROMULGATE
29 ANY RULES AND REGULATIONS NECESSARY FOR THE IMPLEMENTATION OF THE
30 PROVISIONS OF THIS SECTION.

31 S 4. This act shall take effect immediately.
