AN ACT to amend the family court act, in relation to placement of juvenile delinguents

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 1 of section 353.3 of the family court act, as 1 2 added by chapter 920 of the laws of 1982, is amended to read as follows: 3 1. In accordance with section 352.2, the court may place the respond-4 ent in his own home or in the custody of a suitable relative or other 5 suitable private person or the commissioner of [social services or the division for youth] THE OFFICE OF CHILDREN AND FAMILY SERVICES pursuant 6 7 to article nineteen-G of the executive law, subject to the orders of the court AND, FOR PURPOSES OF SECTION 352.2 ONLY, MAY ALSO PLACE THE 8 CHILD FOR ONE INTERVENING PERIOD IN A JUVENILE DETENTION FACILITY, OTHER THAN 9 10 A SECURE DETENTION FACILITY AS DEFINED IN SECTION SEVEN HUNDRED TWENTY OF THIS ACT, FOR A WEEK OR DURING VACATION OR RECESS FROM SCHOOL BUT NOT 11 12 TO EXCEED SEVEN DAYS IN THE AGGREGATE.

13 S 2. Subdivision 5 of section 353.3 of the family court act, as 14 amended by chapter 419 of the laws of 1987, is amended to read as 15 follows:

16 [If] EXCEPT AS OTHERWISE PROVIDED IN SUBDIVISION ONE OF THIS 5. 17 SECTION, IF the respondent has committed a felony the initial period of placement shall not exceed eighteen months. If the respondent has 18 committed a misdemeanor such initial period of placement shall not 19 exceed twelve months. If the respondent has been in detention pending 20 21 disposition, the initial period of placement ordered under this section 22 shall be credited with and diminished by the amount of time spent by the 23 respondent in detention prior to the commencement of the placement
