AN ACT to amend the public authorities law, in relation to providing for the financing and construction of capital facilities for Mesivta Torah Vodaath Rabbinical Seminary and Yeshivas Novominsk

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Paragraph (b) of subdivision 2 of section 1676 of the  
2     public authorities law is amended by adding two new undesignated para-  
3     graphs to read as follows:  
4     MESIVTA TORAH VODAATH RABBINICAL SEMINARY, AN INDEPENDENT,  
5     NOT-FOR-PROFIT PRIVATE, ACCREDITED COLLEGE/SCHOOL OF HIGHER LEARNING,  
6     THAT IS EXEMPT FROM FEDERAL INCOME TAX AS AN ORGANIZATION DESCRIBED IN S  
7     501(C)(3) OF THE INTERNAL REVENUE CODE FOR THE FINANCING, ACQUISITION  
8     AND EQUIPPING OF A BUILDING TO BE LOCATED AT 425 EAST 9TH STREET, KINGS  
9     COUNTY, NEW YORK TO BE USED AS A SCHOOL.  
10    YESHIVAS NOVOMINSK, AN INDEPENDENT, NOT-FOR-PROFIT PRIVATE, ACCREDITED  
11    COLLEGE/SCHOOL OF HIGHER LEARNING, THAT IS EXEMPT FROM FEDERAL INCOME  
12    TAX AS AN ORGANIZATION DESCRIBED IN S 501(C)(3) OF THE INTERNAL REVENUE  
13    CODE FOR THE FINANCING, ACQUISITION AND EQUIPPING OF A BUILDING TO BE  
14    LOCATED AT 1690 60TH STREET, KINGS COUNTY, NEW YORK TO BE USED AS A  
15    SCHOOL.  
16    S 2. Subdivision 1 of section 1680 of the public authorities law is  
17    amended by adding two new undesignated paragraphs to read as follows:  
18    MESIVTA TORAH VODAATH RABBINICAL SEMINARY, AN INDEPENDENT,  
19    NOT-FOR-PROFIT PRIVATE, ACCREDITED COLLEGE/SCHOOL OF HIGHER LEARNING,  
20    THAT IS EXEMPT FROM FEDERAL INCOME TAX AS AN ORGANIZATION DESCRIBED IN S  
21    501(C)(3) OF THE INTERNAL REVENUE CODE FOR THE FINANCING, ACQUISITION  
22    AND EQUIPPING OF A BUILDING TO BE LOCATED AT 425 EAST 9TH STREET, KINGS  
23    COUNTY, NEW YORK TO BE USED AS A SCHOOL.
