- AN ACT to amend the tax law and the state finance law, in relation to authorizing a tax check-off for gifts to food banks

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The tax law is amended by adding a new section 625-a to 2 read as follows:

S 625-A. GIFTS TO FOOD BANKS. EFFECTIVE FOR ANY TAXABLE YEAR COMMENC-3 ING ON OR AFTER JANUARY FIRST, TWO THOUSAND ELEVEN, AN INDIVIDUAL IN ANY 4 5 TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE STATE GIFTS TO FOOD BANKS 6 FUND FOR FINANCIAL SUPPORT FOR REGIONAL FOOD BANKS. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF 7 STATE TAX OWED BY SUCH INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE 8 SPACE 9 PERSONAL TAX RETURN TO ENABLE A TAXPAYER TO MAKE SUCH ON THE INCOME 10 CONTRIBUTION. NOTWITHSTANDING ANY OTHER PROVISION OF LAW ALL REVENUES SECTION SHALL BE CREDITED TO THE GIFTS TO 11 COLLECTED PURSUANT TO THIS FOOD BANKS FUND AND USED ONLY FOR THOSE PURPOSES ENUMERATED 12 IN SECTION 13 EIGHTY-TWO OF THE STATE FINANCE LAW.

14 S 2. The state finance law is amended by adding a new section 82 to 15 read as follows:

S 82. GIFTS TO FOOD BANKS FUND. THE GIFTS TO FOOD BANKS FUND 16 SHALL CONSIST OF ALL MONEYS RECEIVED BY THE DEPARTMENT OF TAXATION AND FINANCE 17 FROM GIFTS TO FOOD BANKS PURSUANT TO SECTION SIX HUNDRED TWENTY-FIVE-A 18 19 OF THE TAX LAW. SUCH MONEYS, AFTER APPROPRIATION BY THE LEGISLATURE, SHALL BE AVAILABLE TO THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE 20 FOR THE DISTRIBUTION OF GRANTS TO REGIONAL FOOD BANKS ORGANIZED TO SERVE 21 SPECIFIC REGIONS THAT GENERALLY COLLECT AND REDISTRIBUTE FOOD DONATIONS 22
