AN ACT to amend the town law, in relation to volunteer members of the Roslyn Rescue Hook and Ladder Company, No. 1

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 7 of section 176-b of the town law, as sepa-  
2     rately amended by chapters 302, 314, 468 and 474 of the laws of 2009, is  
3     amended to read as follows:  
4     7. The membership of any volunteer firefighter shall not be continued  
5     pursuant to subdivision five of this section, and persons shall not be  
6     elected to membership pursuant to subdivision six of this section, if,  
7     by so doing, the percentage of such non-resident members in the fire  
8     company would exceed forty-five per centum of the actual membership of  
9     the fire company, provided however, that the provisions of this subdivi-  
10    sion shall not apply to the memberships of the Shelter Island Heights  
11    fire district, the Cherry Grove fire district, the Fire Island Pines  
12    fire district, the Davis Park fire department, and the Cold Spring  
13    Harbor fire district in Suffolk county, the New Hampton fire district,  
14    the Mechanicstown fire district, the Pocatello fire district, the Wash-  
15    ington Heights fire district and the Good Will fire district in Orange  
16    county, the Jericho fire district [and], the Westbury fire district AND  
17    THE ROSLYN RESCUE HOOK AND LADDER COMPANY, NO. 1 in Nassau county, the  
18    Orangeburg fire district in Rockland county, the South Lockport Fire  
19    Company and the Terry's Corners volunteer fire company in Niagara Coun-  
20    ty, the Taunton fire district and the Onondaga Hill fire department in  
21    Onondaga county, the Town of Batavia fire department in Genesee County,
