AN ACT to amend the town law and the village law, in relation to requiring local building and planning regulations to accommodate the use of renewable and alternative energy sources

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 263 of the town law, as amended by chapter 602 of the laws of 2003, is amended to read as follows:

3 S 263. Purposes in view. Such regulations shall be made in accordance with a comprehensive plan and designed to lessen congestion in the streets; to secure safety from fire, flood, panic and other dangers; to 5 6 promote health and general welfare; to provide adequate light and air; 7 to prevent the overcrowding of land; to avoid undue concentration of population; to make provision for, so far as conditions may permit, the accommodation of [solar energy systems and equipment and access to 9 10 sunlight necessary therefor] RENEWABLE ENERGY RESOURCES, WHICH FOR THE 11 PURPOSES OF THIS SECTION SHALL INCLUDE SOLAR THERMAL, PHOTOVOLTAICS, WIND, HYDROELECTRIC, GEOTHERMAL ELECTRIC, GEOTHERMAL GROUND SOURCE HEAT, 12 TIDAL ENERGY, WAVE ENERGY, OCEAN THERMAL, AND FUEL CELLS USING RENEWABLE 13 to facilitate the practice of forestry; 14 to facilitate the adequate provision of transportation, water, sewerage, 15 schools, parks 16 and other public requirements. Such regulations shall be made with 17 reasonable consideration, among other things, as to the character of the 18 district and its peculiar suitability for particular uses, and with a 19 view to conserving the value of buildings and encouraging the most appropriate use of land throughout such municipality.

1 S 2. Section 7-704 of the village law, as amended by chapter 742 of 2 the laws of 1979, is amended to read as follows:

S 7-704 Purposes in view. Such regulations shall be made in accordance with a comprehensive plan and designed to lessen congestion in the 5 streets; to secure safety from fire, panic, floods and other dangers; to 6 promote health and the general welfare; to provide adequate light and to prevent the overcrowding of land; to avoid undue concentration 7 8 of population; to make provision for, so far as conditions may permit, the accommodation of [solar energy systems and equipment and access to 9 10 sunlight necessary therefor] RENEWABLE ENERGY RESOURCES, WHICH THIS SECTION SHALL INCLUDE SOLAR THERMAL, PHOTOVOLTAICS, 11 PURPOSES WIND, HYDROELECTRIC, GEOTHERMAL ELECTRIC, GEOTHERMAL GROUND SOURCE HEAT, 12 TIDAL ENERGY, WAVE ENERGY, OCEAN THERMAL, AND FUEL CELLS USING RENEWABLE 13 14 FUELS; to facilitate the adequate provision of transportation, 15 sewerage, schools, parks and other public requirements. Such regulations 16 shall be made with reasonable consideration, among other things, as to the character of the district and its peculiar suitability for partic-17 ular uses, and with a view to conserving the value of buildings and 18 19 encouraging the most appropriate use of land throughout such munici-20 pality.

S 3. This act shall take effect immediately.
