AN ACT to amend the penal law, the general business law and the state technology law, in relation to adding medical and health insurance information within the definitions of identity theft

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 190.78 of the penal law, as added by chapter 619 of 1 the laws of 2002, is amended to read as follows: 2 3

S 190.78 Identity theft in the third degree.

4 A person is guilty of identity theft in the third degree when he or 5 she knowingly and with intent to defraud assumes the identity of another person by presenting himself or herself as that other person, 6 or by acting as that other person or by using personal identifying information 7 8 of that other person, and thereby:

9 1. obtains goods, money, MEDICAL INFORMATION, HEALTH INSURANCE INFOR-MATION, property or services or uses credit in the name of such other 10 person or causes financial loss to such person or to another person or 11 12 persons; or

2. commits a class A misdemeanor or higher level crime.

3. (A) FOR THE PURPOSES OF THIS SECTION, THE TERM 14 "MEDICAL INFORMA-15 MEANS ANY INFORMATION REGARDING AN INDIVIDUAL'S MEDICAL HISTORY, TION" 16 MENTAL OR PHYSICAL CONDITION, OR MEDICAL TREATMENT OR DIAGNOSIS BY A 17 HEALTH CARE PROFESSIONAL.

S 2. Section 190.79 of the penal law, as added by chapter 619 of the laws of 2002 and subdivision 4 as amended by chapter 279 of the laws 2008, is amended to read as follows:

4 S 190.79 Identity theft in the second degree.

5 A person is guilty of identify theft in the second degree when he or 6 she knowingly and with intent to defraud assumes the identity of another 7 person by presenting himself or herself as that other person, or by 8 acting as that other person or by using personal identifying information 9 of that other person, and thereby:

10 1. obtains goods, money, MEDICAL INFORMATION, HEALTH INSURANCE INFOR-11 MATION, property or services or uses credit in the name of such other 12 person in an aggregate amount that exceeds five hundred dollars; or

13 2. causes financial loss to such person or to another person or 14 persons in an aggregate amount that exceeds five hundred dollars; or

15 3. commits or attempts to commit a felony or acts as an accessory to 16 the commission of a felony; or

17 commits the crime of identity theft in the third degree as defined 4. in section 190.78 of this article and has been previously convicted 18 within the last five years of identity theft in the third degree as 19 defined in section 190.78, identity theft in the second degree as defined in this section, identity theft in the first degree as defined 20 21 22 in section 190.80, unlawful possession of personal identification information in the third degree as defined in section 190.81, unlawful 23 possession of personal identification information in the second degree 24 25 as defined in section 190.82, unlawful possession of personal identifi-26 cation information in the first degree as defined in section 190.83, unlawful possession of a skimmer device in the second degree as defined 27 section 190.85, unlawful possession of a skimmer device in the first 28 in 29 degree as defined in section 190.86, grand larceny in the fourth degree as defined in section 155.30, grand larceny in the third degree as defined in section 155.35, grand larceny in the second degree as defined 30 31 32 in section 155.40 or grand larceny in the first degree as defined in 33 section 155.42 of this chapter.

Identity theft in the second degree is a class E felony.
