AN ACT to amend the vehicle and traffic law and the administrative code of the city of New York, in relation to requiring background checks for for-hire vehicle licenses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding a new 1 2 article 17-C to read as follows: 3

BACKGROUND CHECK FOR FOR-HIRE VEHICLE LICENSES. PRIOR TO THE 6 S 499. 7 ISSUANCE OF A TAXICAB, LIMOUSINE, COMMUTER VAN, PARATRANSIT OR FOR-HIRE VEHICLE LICENSE, THE APPLICANT FOR SUCH LICENSE SHALL BE FINGERPRINTED 8 BY THE LICENSING AUTHORITY AUTHORIZED TO ISSUE SUCH LICENSE 9 FOR THE 10 PURPOSE OF SECURING CRIMINAL HISTORY RECORDS FROM BOTH THE STATE DIVI-SION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF 11 INVESTI-APPLICANT SHALL PAY ANY PROCESSING FEE REOUIRED BY THE 12 GATION. THE STATE DIVISION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU 13 OF INVESTIGATION. FINGERPRINTS SHALL BE TAKEN OF THE INDIVIDUAL OWNER IF 14 15 THE APPLICANT IS A SOLE PROPRIETORSHIP; THE GENERAL PARTNERS IF THE APPLICANT IS A PARTNERSHIP; THE OFFICERS, PRINCIPALS, AND STOCKHOLDERS 16 17 OWNING MORE THAN TEN PERCENT OF THE OUTSTANDING STOCK OF THE CORPORATION IF THE APPLICANT IS A CORPORATION. 18

S 2. Subdivision 1 of section 19-504 of the administrative code of the 19 city of New York, as added by local law number 115 of the city of New 20 21 York for the year 1993, is amended and a new subdivision q is added to 22 read as follows:

EXPLANATION--Matter in ITALICS (underscored) is new; matter in brackets [] is old law to be omitted.

1. Prior to the issuance of a commuter van license, the applicant 1 shall be fingerprinted for the purpose of securing criminal history 2 3 records from BOTH the state division of criminal justice services AND 4 THE FEDERAL BUREAU OF INVESTIGATION. The applicant shall pay any proc-5 essing fee required by the state division of criminal justice services AND THE FEDERAL BUREAU OF INVESTIGATION. Fingerprints shall be taken of 6 7 the individual owner if the applicant is a sole proprietorship; the 8 general partners if the applicant is a partnership; the officers, principals, and stockholders owning more than ten percent of the outstanding 9 10 stock of the corporation if the applicant is a corporation.

Q. PRIOR TO THE ISSUANCE OF A TAXICAB, LIMOUSINE, PARATRANSIT OR 11 FOR-12 HIRE VEHICLE LICENSE, THE APPLICANT SHALL BE FINGERPRINTED FOR THE PURPOSE OF SECURING CRIMINAL HISTORY RECORDS FROM BOTH THE 13 STATE DIVI-14 SION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF INVESTI-15 GATION. THE APPLICANT SHALL PAY ANY PROCESSING FEE REQUIRED BY THE STATE DIVISION OF CRIMINAL JUSTICE SERVICES AND THE FEDERAL BUREAU OF INVESTI-16 GATION. FINGERPRINTS SHALL BE TAKEN OF THE 17 INDIVIDUAL OWNER IF THE APPLICANT IS A SOLE PROPRIETORSHIP; THE GENERAL PARTNERS IF THE APPLI-18 19 CANT IS A PARTNERSHIP; THE OFFICERS, PRINCIPALS, AND STOCKHOLDERS OWNING MORE THAN TEN PERCENT OF THE OUTSTANDING STOCK OF THE CORPORATION IF THE 20 21 APPLICANT IS A CORPORATION.

22 S 3. This act shall take effect on the sixtieth day after it shall 23 have become a law.
