AN ACT to amend the public health law, in relation to the minority health council

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 243 of the public health law, as added by chapter
2 757 of the laws of 1992 and as renumbered by chapter 443 of the laws of
3 1993, is amended to read as follows:

4 S 243. Minority health council. 1. Appointment of members. There
5 shall be established in the office of minority health a minority health
6 council to consist of [the commissioner and fourteen members to be
7 appointed by the governor with the advice and consent of the senate]
8 SEVENTEEN MEMBERS TO BE APPOINTED BY JULY FIRST, TWO THOUSAND TEN. NINE
9 MEMBERS SHALL BE APPOINTED BY THE GOVERNOR, THREE BY THE TEMPORARY PRES-
10 IDENT OF THE SENATE, THREE BY THE SPEAKER OF THE ASSEMBLY, ONE BY THE
11 MINORITY LEADER OF THE SENATE AND ONE BY THE MINORITY LEADER OF THE
12 ASSEMBLY. Membership on the council shall be reflective of the divers-
13 ity of the state's population including, but not limited to, the various
14 minority populations throughout the state.

15 2. Terms of office; vacancies. a. The terms of office of members of
16 the minority health council shall be six years. The members of the coun-
17 cil shall continue in office until the expiration of their terms and
18 until their successors are appointed and have qualified. Such appoint-
19 ments shall be made [by the governor, with the advice and consent of the
20 senate,] within one year following the expiration of such terms.

21 b. [Vacancies shall be filled by appointment by the governor for the
22 unexpired terms within one year of the date upon which such vacancies
23 occur. Any vacancy existing on the effective date of paragraph c of
24 this subdivision shall be filled by appointment within one year of such
25 effective date.

1 c. In making appointments to the council, the governor shall seek to
2 ensure that membership on the council reflects the diversity of the
3 state's population including, but not limited to the various minority
4 populations throughout the state.] VACANCIES SHALL BE FILLED BY THE
5 APPOINTING OFFICIAL WHO ORIGINALLY APPOINTED SUCH MEMBER WITHIN ONE YEAR
6 OF THE DATE UPON WHICH SUCH VACANCIES OCCUR.

7 3. Meetings. a. The minority health council shall meet as frequently
8 as its business may require, and at least twice in each year.

9 b. The governor shall designate one of [the members of the public
10 health council as its chair] HIS OR HER APPOINTEES TO BE CHAIRPERSON OF
11 THE COUNCIL.

12 4. Compensation and expenses. The members of the council shall serve
13 without compensation other than reimbursement of actual and necessary
14 expenses.

15 5. Powers and duties. The minority health council shall[, at the
16 request of the commissioner,] consider any matter relating to the pres-
17 ervation and improvement of minority health, and [may] SHALL advise the
18 commissioner thereon; and it [may] SHALL, from time to time, submit to
19 the commissioner, any recommendations relating to the preservation and
20 improvement of minority health.

21 S 2. This act shall take effect immediately.
