- AN ACT to amend the public authorities law, the environmental conservation law and the highway law, in relation to memorializing Robert F. Kennedy, Dr. Martin Luther King, Jr. and Dr. Pedro Albizu Campos by renaming certain spans of the Triborough bridge after such men

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative findings and intent. The legislature hereby 2 recognizes Robert F. Kennedy by naming after him a span of the Tribor-3 ough bridge, as a tribute befitting his historic contribution to the 4 state of New York and the nation. Robert F. Kennedy represented the 5 state of New York in the United States Senate with great distinction, 1965 until his untimely death in 1968, working tirelessly to б from 7 improve the lives of New Yorkers, fighting poverty and advancing the 8 civil rights movement. The state of New York and our entire nation were 9 further enriched by Robert F. Kennedy's prior service as the sixtyfourth Attorney General of the United States, and trusted advisor to the 10 President. Common throughout his many works was an effort to bridge the 11 12 gaps among persons of diverse racial, ethnic and economic backgrounds. 13 Accordingly, the legislature hereby names the span of the Triborough 14 bridge which stretches over the East river from the borough of Queens to 15 Ward's Island the Robert F. Kennedy bridge.

16 The legislature further recognizes Dr. Martin Luther King, Jr., in 17 this fortieth year following his tragic assassination, by naming after 18 him a span of the Triborough bridge, as a tribute befitting his historic 19 contributions to the nation. Dr. King worked tirelessly to improve the 20 lives of the citizens of this country, fighting segregation and discrim-

ination through non-violent protest and advancing the civil rights move-1 2 ment, until his untimely death in 1968. The state of New York and our 3 entire nation were enriched by Dr. King's dedication, example and sacri-4 fices. Common throughout his many works was an effort to bridge the gaps 5 among persons of diverse racial, ethnic and economic backgrounds. 6 Accordingly, the legislature hereby names the span of the Triborough 7 bridge which stretches from Randall's Island to Manhattan the Dr. Martin 8 Luther King, Jr. bridge.

9 The legislature also hereby recognizes Dr. Pedro Albizu Campos, by 10 naming after him a span of the Triborough bridge, as a tribute befitting his historic contributions to the nation of 11 Puerto Rico. Dr. Albizu 12 Campos, the most prominent Puerto Rican political figure of the 20th century, was instrumental in Puerto Rico's fight for independence until 13 14 his death in 1965. Accordingly, the legislature hereby names the span of 15 the Triborough bridge which stretches from Randall's Island to the Bronx 16 the Dr. Pedro Albizu Campos bridge.

17 S 2. Paragraph (a) of subdivision 9 of section 553 of the public 18 authorities law, as amended by chapter 453 of the laws of 2008, is 19 amended to read as follows:

20 [a bridge] THREE BRIDGES heretofore constructed[, known as Robert (a) 21 F. Kennedy bridge,] over the East river from the borough of Queens to 22 [the boroughs of Manhattan and the Bronx, over and across] Ward's island 23 [and Randall's island in said river] SHALL BE KNOWN AS THE ROBERT F. 24 KENNEDY BRIDGE; OVER THE EAST RIVER FROM RANDALL'S ISLAND IN SAID RIVER 25 BOROUGH OF MANHATTAN, SHALL BE KNOWN AS THE DR. MARTIN LUTHER ТΟ THE 26 KING, JR. BRIDGE; AND OVER THE BRONX KILL FROM RANDALL'S ISLAND IN SAID RIVER TO THE BOROUGH OF THE BRONX, SHALL BE KNOWN AS THE DR. PEDRO ALBI-27 BRIDGE, together with such incidental bridges and structures 28 ΖU CAMPOS 29 as shall be necessary or convenient in order to give access from the [bridge] BRIDGES to both of said islands, together with approaches to 30 said bridges (herein collectively referred to as the "[Robert F. 31 Kenne-32 dy] TRIBUTE bridge project"); and

33 S 3. Paragraphs (a) and (b) of subdivision 10 of section 553 of the 34 public authorities law, as amended by chapter 453 of the laws of 2008, 35 are amended to read as follows:

(a) in the case of the [Robert F. Kennedy] TRIBUTE bridge project 36 and 37 the Whitestone bridge project to pay to the city not exceeding thirtyfive per centum of the cost (including awards for damages and expenses) of the acquisition of land for the widening of existing roads, streets, 38 39 of 40 parkways or avenues and for new roads, streets, parkways or avenues, 41 connecting with the approaches.

(b) to purchase from the persons, partnerships, associations or corpo-42 43 rations who were the owners of any land acquired for the widening of 44 existing roads, streets, parkways or avenues or for new roads, streets, 45 parkways or avenues connecting with the approaches or of any interest in land at the date title to such land was vested in the city in any 46 such 47 proceeding heretofore or hereafter instituted for the acquisition there-48 of by condemnation, or from their successors in interest or legal representatives, their right, title, interest and/or claim in and to the award or awards or any part thereof to be made in such proceeding after 49 50 51 the date of such purchase, and to take an assignment thereof to the authority, provided, however, that in the case of the [Robert F. Kenne-52 dy] TRIBUTE bridge project and the Whitestone bridge project the aggre-53 54 gate amount expended by the authority on account of all such purchases 55 together with the aggregate amount paid to the city in accordance with 56 paragraph (a) of this subdivision, shall not exceed thirty-five per

1 centum of the cost (including awards for damages and expenses) of the 2 acquisition of land for the widening of existing roads, streets, park-3 ways or avenues, and for new roads, streets, parkways or avenues, 4 connecting with the approaches,

5 S 4. Subdivision 2 of section 563 of the public authorities law, as 6 amended by chapter 453 of the laws of 2008, is amended to read as 7 follows:

8 The state of New York does covenant and agree with the holders of 2. 9 any bonds issued after January first, nineteen hundred forty that no 10 tunnel, bridge, parkway, causeway, street, road, highway or other connection for vehicular traffic (other than one of the projects), which 11 will be competitive with the [Robert F. Kennedy] TRIBUTE bridge project 12 the Whitestone bridge project or the Throgs Neck bridge project or 13 or 14 the Marine parkway bridge project or the Cross Bay parkway bridge 15 project will be constructed or maintained until the bonds together with interest thereon, interest on any unpaid installments of interest, 16 and 17 costs and expenses in connection with any action or proceedings by all or on behalf of the bondholders, are fully met and discharged; provided 18 that a tunnel, bridge, parkway, causeway, street, road, highway or other 19 20 connection for vehicular traffic shall be considered as competitive with 21 [Robert F. Kennedy] TRIBUTE bridge project or Whitestone bridge the project or the Throgs Neck bridge project only if it shall 22 form a connection for vehicular traffic over, under, or across the East river 23 24 north of an extension to the east of the center line of Seventy-third 25 street in the borough of Manhattan, and shall be considered as compet-26 itive with the Marine parkway bridge project or Cross Bay parkway bridge 27 project only if such tunnel, bridge, parkway, causeway, street, road, other connection for vehicular traffic shall form a 28 highway or connection for vehicular traffic with Rockaway peninsula across any part 29 of the waters of Jamaica bay or Rockaway inlet west of seventy-three degrees, forty-six minutes of west longitude. The covenant herein 30 31 32 contained restricting competitive traffic connections with any project 33 projects shall be only for the benefit of the holders of bonds or secured in whole or in part by the pledge of the revenues of 34 such 35 All covenants of the state made with the holders project or projects. of bonds issued before January first, nineteen hundred and forty, 36 are 37 hereby confirmed and shall not be affected hereby.

38 S 5. Subdivision 4 of section 13-0341 of the environmental conserva-39 tion law, as amended by chapter 453 of the laws of 2008, is amended to 40 read as follows:

41 4. In the Harlem River and the East River east of the Robert F. Kenne-42 dy [Bridge], DR. MARTIN LUTHER KING, JR. AND DR. PEDRO ALBIZU CAMPOS 43 BRIDGES and in Long Island Sound west of a line drawn from Hewlett's 44 (King's) Point to the north end of Hart Island, thence to the south end 45 of Glen Island, and in their adjacent bays, coves, creeks and confluent 46 waters.

47 S 6. Subdivision 3 of section 13-0343 of the environmental conserva-48 tion law, as amended by chapter 453 of the laws of 2008, is amended to 49 read as follows:

50 3. In the Harlem River and the East River east of the Robert F. Kenne-51 [Bridge], DR. MARTIN LUTHER KING, JR. AND DR. PEDRO ALBIZU CAMPOS dy BRIDGES and in Long Island Sound west of a line drawn from Hewlett's 52 (King's) Point to the north end of Hart Island, thence to the south end 53 54 of Glen Island, and in their adjacent bays, coves, creeks and confluent 55 only such nets as are used to take lobsters or crabs may be waters, 56 used.

4 6. In all waters from the Robert F. Kennedy [bridge], DR. MARTIN LUTH-5 ER KING, JR. AND DR. PEDRO ALBIZU CAMPOS BRIDGES west through the East 6 River, Harlem River and those portions of the Hudson River south of the 7 George Washington bridge to a line drawn from Rockaway Point to Romer 8 Shoals lighthouse, no person shall use a net to take fish, except that landing nets and nets of not more than 10 feet in length, operated by 9 10 hand, may be used to take bait and shrimp, and cast nets may be used to 11 take Atlantic menhaden and mullets as provided in subdivision one of section 13-0343 of this title. 12

13 S 8. The paragraph relating to interstate route connection 512 of 14 section 340-a of the highway law, as amended by chapter 453 of the laws 15 of 2008, is amended to read as follows:

16 Interstate Route Connection 512. Staten Island expressway from 17 Goethals bridge approach to Verrazano-Narrows bridge approach, Brook-18 lyn-Queens expressway from Verrazano-Narrows bridge approach to Grand 19 Central parkway, Grand Central parkway from Brooklyn-Queens expressway 20 to [Robert F. Kennedy] THE DR. PEDRO ALBIZU CAMPOS bridge approach, 21 Major Deegan expressway from Robert F. Kennedy bridge approach to the 22 Westchester county line connecting with interstate route 502.

23 S 9. The paragraph relating to interstate route connection 516 of 24 section 340-a of the highway law, as amended by chapter 453 of the laws 25 of 2008, is amended to read as follows:

Interstate Route Connection 516. Bruckner expressway from [Robert F. Kennedy] DR. PEDRO ALBIZU CAMPOS bridge approach to Cross-Bronx expressway.

29 S 10. Section 349-f of the highway law, as amended by chapter 453 of 30 the laws of 2008, is amended to read as follows:

31 S 349-f. New York city routes. The following existing or proposed main 32 routes or thoroughfares, are designated herein, as aforesaid, viz.:

33 New England thruway from the Westchester county line to Bruckner expressway; Bruckner expressway from New England thruway to [Robert F. 34 35 Kennedy] DR. PEDRO ALBIZU CAMPOS bridge approach; Hutchinson river parkway from the Westchester county line to the Bronx-Whitestone bridge 36 approach; Bronx river parkway from the Westchester county line to Bruck-37 38 ner expressway; Henry Hudson parkway from the Westchester county line to 39 Miller highway excepting the Henry Hudson bridge, provided that no 40 portion of this route from West Seventy-second street to the Cross Bronx expressway shall be constructed or reconstructed so as to encroach in 41 any way on or over any land mapped or used for park purposes except for 42 43 such temporary encroachment of no more than ten feet in width from 44 seventy-third street to seventy-sixth street as may be essential during and for the purpose of reconstruction or repair of the existing roadway following which there shall be full restoration of park land; Major 45 46 47 Deegan expressway from the [Robert F. Kennedy] DR. PEDRO ALBIZU CAMPOS 48 bridge to Central Park avenue at the Westchester county line together 49 with a connection to Broadway and along Broadway to Manhattan college 50 parkway; Cross Bronx expressway from George Washington bridge approach 51 to Throgs Neck bridge; Throgs Neck expressway from Bruckner expressway Throgs Neck bridge; Arthur V. Sheridan expressway from Cross-Bronx 52 to expressway to Bruckner expressway; Mosholu parkway from Henry Hudson 53 54 parkway to Bronx river parkway; Bronx and Pelham parkway from Bronx 55 river parkway to New England thruway; Boston road from Bronx and Pelham parkway to New England thruway; Miller highway from Henry Hudson parkway 56

to the Brooklyn Battery tunnel; and from Brooklyn Battery tunnel to Brooklyn-Queens expressway; Franklin D. Roosevelt drive from the Brook-1 2 3 lyn Battery tunnel to [Robert F. Kennedy] THE DR. MARTIN LUTHER KING, 4 JR. bridge approach; Harlem river drive from [Robert F. Kennedy] THE DR. LUTHER KING, JR. bridge approach to George Washington bridge 5 MARTIN б approach; Belt parkway including Gowanus parkway to Third avenue and 7 Sixtieth street, Leif Erikson drive to Knapp street, Shore parkway, Belt 8 parkway, Southern parkway and Cross Island parkway from Brooklyn Battery tunnel to Bronx-Whitestone bridge approach; Nassau expressway from 9 10 Southern parkway to the Nassau county line; Brooklyn-Queens expressway 11 Gowanus expressway to Grand Central parkway; Prospect expressway from 12 from Gowanus expressway to Ocean parkway; Ocean parkway from Prospect 13 expressway to Shore parkway; Interborough parkway from Grand Central 14 Parkway to Belt parkway; Gowanus expressway from the Verrazano-Narrows 15 bridge to Third avenue at Gowanus parkway; Third Avenue from Gowanus 16 expressway to Hamilton avenue; Hamilton Avenue from Third Avenue to 17 Brooklyn Battery tunnel; Queens boulevard from Queensborough bridge 18 approach to Van Wyck expressway; Van Wyck expressway from Whitestone 19 expressway, including a connection to Grand Central parkway, to John F. 20 Kennedy international airport; Woodhaven boulevard from Queens boulevard 21 to Cross Bay parkway bridge northerly approach; Cross Bay parkway from 22 Cross Bay bridge southerly approach to Short Front parkway; Shore Front 23 parkway from Cross Bay parkway generally along the shore line of the Atlantic ocean to the Nassau expressway at the Nassau county line; 24 25 Queens-Midtown expressway from Queens-Midtown tunnel approach to Queens 26 Boulevard; Horace Harding expressway from Queens Boulevard to the Nassau 27 county line; a connection between Brooklyn-Queens expressway and North-28 ern boulevard in the vicinity of Grand Central parkway; Grand Central 29 parkway from Robert F. Kennedy bridge approach to Nassau county line; 30 Whitestone expressway from Bronx-Whitestone bridge approach to Van Wyck expressway and continuing to Grand Central parkway; Clearview expressway 31 32 from Throgs Neck bridge to Nassau expressway; Richmond parkway from 33 Staten Island expressway to Outerbridge crossing approach; Staten Island expressway from Goethals bridge to the Verrazano-Narrows bridge with a 34 connection to Bayonne bridge; Willowbrook parkway from Staten Island 35 expressway to Great Kills park; West Shore expressway from Staten Island 36 37 expressway to Outerbridge crossing; Shore Front drive northerly from the 38 terminus of West Shore expressway at Staten Island expressway, thence generally along the shore lines of Kill Van Kull, the Narrows, Lower New 39 40 York bay and Raritan bay to the approach to Outerbridge crossing.

11. Terms occurring in laws, regulations, contracts and other docu-41 S ments. Whenever Triborough bridge is referred to or designated in 42 any law, regulation, contract or document, such reference or designation 43 shall be deemed to refer to the Robert F. Kennedy, Dr. Martin Luther 44 45 King, Jr. and Dr. Pedro Albizu Campos bridges, collectively, and no such laws, regulations, contracts or other documents shall be thereby 46 47 impaired in any way.

48 S 12. The New York state department of transportation, the New York 49 city department of transportation and the Triborough bridge and tunnel 50 authority shall provide for the installation and maintenance of adequate 51 signage in conformance with paragraph (a) of subdivision 9 of section 52 553 of the public authorities law, as amended by section two of this act within such time and in such manner as they shall deem appropriate. 53 54 S 13. This act shall take effect immediately.
