AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for hunting big game in a certain portion of the county of Chautauqua; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

27 S 4. This act shall take effect immediately, provided that the amend-
28 ments to item (i) of paragraph a of subdivision 2 of section 11-0907 of
29 the environmental conservation law made by section one of this act shall
30 be subject to the expiration and reversion of such paragraph pursuant to
31 section 3 of chapter 412 of the laws of 2008, as amended, when upon such
32 date the provisions of section two of this act shall take effect and
33 provided, further, that the amendments to item (i) of paragraph a of
34 subdivision 2 of section 11-0907 of the environmental conservation law
35 made by section two of this act shall be subject to the expiration and
36 reversion of such paragraph pursuant to section 13 of chapter 600 of the
37 laws of 1993, as amended, when upon such date the provisions of section
38 three of this act shall take effect and provided further that the
39 provisions of this act shall expire and be deemed repealed one year
40 after such effective date.
