Introduced by M. of A. KOLB -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for hunting in Ontario county; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907  
2 of the environmental conservation law, as amended by chapter 412 of the  
3 laws of 2008, is amended to read as follows:

4 (i) The counties of Deer, the first Monday Pistol, shotgun,  
5 Allegany, after November 15 muzzle loading  
6 Cattaraugus, Chemung, through first Tuesday firearm,  
7 Chenango, Herkimer, after December 7 rifle or  
8 Madison, long bow only  
9 Montgomery, Oneida,  
10 ONTARIO,  
11 Oswego, Otsego,  
12 Schoharie, Steuben,  
13 Tioga and Yates  
14 and that portion of  
15 the county of  
16 Broome east of the  
17 Susquehanna river

18 S 2. Item (i) of paragraph a of subdivision 2 of section 11-0907 of  
19 the environmental conservation law, as amended by chapter 296 of the  
20 laws of 2007, is amended to read as follows:

21 (i) The counties of Deer, the first Monday Pistol, shotgun,  
22 Allegany, after November 15 muzzle loading

 14 of the laws of 2005, is amended to read as follows:

15 (i) The counties of Deer and bear, the Pistol, shotgun,  
 16 Allegany, first Monday after muzzle loading  
 17 Cattaraugus, November 15 through firearm, rifle or  
 18 Chenango, Herkimer, first Tuesday after long bow only  
 19 Montgomery, Oneida, December 7  
 20 ONTARIO,  
 21 Oswego, Otsego,  
 22 Schoharie and Tioga  
 23 and that portion of  
 24 the county of  
 25 Broome east of the  
 26 Susquehanna river

27 S 4. This act shall take effect immediately, provided that the amend-  
 28 ment to item (i) of paragraph a of subdivision 2 of section 11-0907 of  
 29 the environmental conservation law made by section one of this act shall  
 30 be subject to the expiration and reversion of such item pursuant to  
 31 section 3 of chapter 412 of the laws of 2008, as amended, when upon such  
 32 date the provisions of section two of this act shall take effect; and  
 33 provided further that the amendments to paragraph a of subdivision 2 of  
 34 section 11-0907 of the environmental conservation law made by section  
 35 two of this act shall expire and be deemed repealed on the same date  
 36 such paragraph expires and reverts pursuant to section 13 of chapter 600  
 37 of the laws of 1993, as amended, when upon such date section three of  
 38 this act shall take effect.
